#### 1. GENERAL

- (i) As per Government of Uttarakhand GO No: 773/XXXX/2013-50/2011 dated 25-04-2013, Uttarakhand Ayurved University, Dehradun, will conduct the Competitive Entrance Examination for selecting candidates for admission to MD/MS(Ay) Ras Shastra Evam Bhaishajya Kalpna, Shalya Tantra, Panch karma, Maulik Siddhant, Swasthavritta, Dravyaguna, Agadatantra, Prasuti Evam Striroga Shalakya and Kayachikitsa in Government Rishikul Ayurvedic College Haridwar & Uttaranchal Ayurvedic College, Dehradun for the Academic year 2014.
- (ii) The competitive entrance examination for MD/MS (Ay) Ras Shastra Evam Bhaishajya Kalpna, Shalya Tantra, Panch karma, Maulik Siddhant, Swasthavritta, Dravyaguna, Agadatantra, Prasuti evam Striroga, Shalakya and Kayachikitsa shall be conducted for 53 seats out of which 24 seats shall be filled by those candidates who has domicile of Uttrakhand and 19 seats shall be filled by the candidates from other States. These seats of MD/MS (AY) are subject to permission for admission by CCIM/Govt. of India.
- (iii) The eligible candidates who get selected through U.A.P.G.M.E.E. 2014 will be given admission on available seats in post graduate courses by counseling on merit cum choice basis.
- (iv) A candidate who is already admitted to any post graduate course will not be eligible to appear in the U.A.P.G.M.E.E. 2014 till he/she completes the course and passes the examination.
- (v) The Entrance Examination for admission to all courses for 2014 shall be held on 22-06-2014. at Dehradun.

#### 2. POST GRADUATE COURSES

(i) The MD/MS (AY) course shall be of 3 year duration.

#### 3. ELIGIBILITY CRITERIA

For MD/MS (Ay) courses Ras Shastra Evam Bhaishajya Kalpna, Shalya Tantra, Panch karma, Maulik Siddhant, Swasthavritta, Dravyaguna Agadatantra, Prasuti evam Striroga Shalakya and Kayachikitsa

The competitive Entrance Examination shall be open to such candidates who:-

- (a) Have, passed B.A.M.S. course from Ayurvedic College recognized by Central Council of Indian Medicine (CCIM) New Delhi.
- (b) Are Registered under any State/Central Council of Indian Medicine (CCIM) New Delhi.
- (c) Have completed/will be completing Rotatory Compulsory Internship by July,2014
- 4. SCOPE OF EXAMINATION, EVALUATION & ELIGIBILITY FOR ADMISSION to MD/MS (Ay) courses Ras Shastra Evam Bhaishajya Kalpna (7), Shalya Tantra (5), Panch karma (5), Maulik Siddhant (5), Swasthavritta (5), Dravyaguna (9), Agadatantra (5), Prasuti Evam Striroga (4), Shalakya (4) and Kayachikitsa (4).
- (i) The Competitive Entrance Examination of MD/MS (AY) Ras Shastra evam Bhaishajya Kalpna, Shalya Tantra & Panch karma shall consist of one written paper of 180 questions. It shall be of three hours duration and shall carry maximum of 720 marks.

- (ii) All the questions will be **objective type** with multiple (A,B,C,D) choice of which only one will be the most appropriate response and, therefore, the correct choice. Each answer with correct choice shall be awarded **FOUR marks. ZERO** marks shall be given to no response. **ONE** mark shall be deducted for each **wrong** response. If more than one choice is indicated against a question it shall be considered as **incorrect** response and **ONE** mark will be deducted for each such **incorrect** response.
- (iii) Answering Method: Read the instruction of OMR Answer sheet carefully.
- (iv) Minimum marks criteria: General Category candidates shall have to secure a minimum of 50% marks and the reserved category candidates a minimum of 40% marks in order to qualify for admission to a Post Graduate Avurvedic course.
- (v) Candidate eligible in the reserved category will be given admission as per rules of State Government, applicable till the last date fixed for receipt of application.

#### 5. APPLICATION FORM

- (i) Application forms/brochures will be made available at Uttarakhand Ayurved University, (website www.uau.ac.in) from 10-02-2014.
- (ii) Those candidates, who are using downloaded application forms will submit their fee alongwith the completed application forms with a draft of Rs 3500/- (General and OBC) or `2000/- (SC/ST) in favour of Finance Officer, Uttarakhand Ayurved University, Dehradun.

- (iii) A candidate seeking admission to the competitive entrance examination is required to send his / her application on the prescribed application format, also downloadable from the website: www.uau.ac.in completed in all respect to the office of Coordinator, Uttarakhand Ayuerved University, Dehradun.
- (iv) A candidate should not fill in more than one form for the U.A.P.G.M.E.E.-2014.
- (v) Before filling up the application form, the candidate must familiarize himself/herself with the information given in this brochure.
- (vi) Every detail must be filled in by the candidate in his / her own handwriting. All answer must be given in words and not by dashes or dots. No column should be left blank. Where a column is not applicable, mention "NA".
- (vii) Incomplete application form and forms without examination fee {As explained in para-(ii), (iii) above} in the form of Demand Draft, shall be rejected.
- (viii) Candidate must affix latest passport size photographs in the space provided on the application form. The candidates who have completed their internship can get their photographs attested by a Gazetted Officer. Those who are still pursuing their internship program shall get their photograph attested by the Dean/Principal of their respective institution along with the certificate mentioning expected date of completion of internship, latest by 31<sup>st</sup> July 2014.
- (ix) Furnishing of false information or suppression of any information would disqualify the candidate from the competitive entrance examination/admission and cancellation of admission if already admitted. If considered necessary, legal action may also be taken against such candidate.
- (x) Application form of the candidates, who are likely to complete internship on or before 31<sup>st</sup> July 2014 for MD/MS (Ay) course has to be countersigned by the Dean/Principal of Ayurvedic College from where the candidate has passed the B.A.M.S.. Examination in the forwarding note column.
- (xi) Candidate employed elsewhere must give a 'no objection certificate' signed by the employer for appearing in the entrance examination failing which the application shall be rejected.

# 6. COMPETITIVE AYURVEDIC POSTGRADUATE MEDICAL ENTRANCE EXAMINATION, 2014

- (i) The Postgraduate Ayurvedic medical entrance examination of 2014 will be held on 22-06-2014 at Dehradun.
- (ii) Admit Card list of eligible/non eligible candidates will be sent to eligible candidates by speed post on 15.05.2014 The (Coordinator, UAPGMEE-2014) Uttarakhand Ayurved University, Dehradun shall not be responsible for non-receipt of admit cards due to any reason. Admit Card will not be sent to ineligible candidates and no correspondence in this regard shall be entertained nor shall their fees be refunded.
- (iii) However, if due to any reason the candidate fails to receive the Admit Card. The candidates will be given original admit cards at their respective examination centers one day before(22.06.2014) and one hour before, on the date of the examination(22.06.2014) scheduled. Such candidates must bring one attested copy of the same photograph, which he has affixed with the application form. For information regarding examination centre or any other Quarry the candidate can contact Coordinator (U.A.P.G.M.E.E.-2014) on Telephone no 0135-2685138
- (iv)Entry to the Examination hall will be restricted to candidates producing the admit card, issued by the Coordinator (U.A.P.G.M.E.E.-2014), Uttarakhand Ayurved University, Dehradun or Competent Authority of examination Centre.

#### (v) Examination will commence at Dehradun on 22-06-2014

(vi)Candidates must reach their center at least 30 minutes before the commencement of the examination. No candidate will be allowed in the examination center 15 minutes after the commencement of the examination.

#### 7. RESULT AND SELECTION CRITERIA:

- (i) Candidates who secure a minimum of 50% marks in case of General Category and 40% marks in case of Reserved Category in the U.A.P.G.M.E.E.-2014 shall be eligible for admission to Post Graduate Ayurvedic Courses availability of the seats.
- (ii) In case of candidates obtaining equal marks shall be determined in order of preference as under:
  - (a) Candidates scoring less negative marks. If obtained equal marks then.
  - (b) Candidate obtaining higher average aggregate percentage of marks in all professional exams. If obtained equal marks then.
  - (c) According to age i.e. older getting preference over younger
- (iii) Merit list (combined & category wise) of eligible candidates for admission to the Post Ayurvedic courses shall be declared/published by Coordinator Graduate the (U.A.P.G.M.E.E.-2014), Uttarakhand Ayurved University, Harawala, Dehradun on website www.uau.ac.in and in the newspapers (all Uttarakhand & Delhi edition) and shall be displayed at the Office of the Coordinator (U.A.P.G.M.E.E.- 2014), Uttarakhand Ayurved University, Harawala, Dehradun. The copy of result will also be sent to the Director Ayurvedic and Unani Services, Uttarakhand and Principal, Government Rishikul Ayurvedic College, Haridwar & Uttaranchal Ayurvedic College, Dehradun.
- (iv) The allotment of course to the eligible candidates shall be made by the admission committee under chairmanship of an officer appointed by Uttarakhand Government on personal appearance, along with all original documents, of the candidate as per his/her merit and choice of the course. The date and place of counseling shall be notified through press. No intimation will be sent to the candidate. It will be the responsibility of the candidates to check these dates and appear for counseling and allotment of course. The candidate will have to deposit a fee of `2000/- at the time of counseling. All available seats in different courses shall be displayed along with it recognition status at the time of counseling. The candidate may choose any one of the available seats according to their merit. A seat once allotted to candidate for any course shall be final.
- (v) In case, a candidate is unable to appear for counseling in person, he/she can send his/her representative with an authority letter on the prescribed Performa as given below for allotment. The allotment made to the authorized representative shall be binding on the candidate. Authority on any other form will not be accepted. It will be necessary for the authorized person to bring original documents of the candidate for obtaining allotment. One person can represent only one candidate.
- (vi) If seats remain vacant after last round of counseling than these vacant seats will be filled as follows.
  - (a) OBC category vacant seats will be filled by general category students.
  - (b) If seats of schedule caste/schedule tribe categories remains vacant than these seats will be filled by interchanging. If further remains vacant than these seats will be filled by OBC category students and if ample No. of OBC category students is not available than these seats will be filled by general category students.

#### 8. ADMISSION

Admission of the candidates shall be made by the Principal, Government Rishikul Ayurvedic College Haridwar & Uttaranchal Ayurvedic College, Dehradun..

- (i) A candidate who had qualified for admission to a postgraduate course shall have to deposit the prescribed fee on the date notified for the purpose in the College. Those who fail to do so will loose their claim for admission in the course and in subsequent counseling if any.
- (ii) Admission in MD/MS(Ay) course shall be given only after the candidate produces the original of the following documents at the office of the Principal of Government Rishikul Ayurvedic College, Haridwar & Uttaranchal Ayurvedic College, Dehradun.
  - (a) High School certificate as proof of date of birth

- (b) Original Mark sheets of all professional Examination.
- (c) B.A.M.S. passing out certificate or degree.
- (f) Employer's relieving certificate, if employed.
- (d) Compulsory Rotatory internship completion certificate.
- (e) Permanent Registration Certificate of Indian Medicine Board
- (g) S.C./S.T./O.B.C Certificate, if applicable.
- (h) Allotment letter, issued by Chairman, Admission Board of U.A.P.G.M.E.E.-2014.
- (i) Admit Card of U.A.P.G.M.E.E.-2014.
- (j) Domicile certificate on prescribed Performa.
- (iii) Candidate shall be required to complete the admission formalities and join the course assigned to them within specified period.
- (iv) At the time of counseling reservation policy will be applicable as per order of the Govt. of Uttarakhand.
- (v) After allotment of the seats candidates who failed to join the course within the specified period shall forfeit the right of admission and the security.
- (vi) Candidates who are absent or do not wish to opt for a seat in any course amongst the seats available at their merit, shall not be eligible for allotment in subsequent counseling, if any.
- (vii) Candidate willing to opt for a course will have to deposit a bank draft from nationalized bank of `10000/- (Rupees ten thousand only) in favor of "Finance Officer, Uttarakhand Ayurved University, Dehradun" (for MD/MS(Ay) course) payable at Dehradun as security money and the same will be returned to the candidate after he/she takes admission. Those who do not join or leave the course after allotment / admission will forfeit their claim of refund of security deposit.
