Undertaking I

As Our son/ward _____ has been granted admission in Vagad Gurukul International School, we hereby undertake and agree that:

1. after reading the prospectus, we have decided to bring-up our ward in accordance with the arrangements outlined therein and we also undertake to abide by the school's rules and regulations laid down in the prospectus, hand books, hostel and gurukul and any changes made by the Management from time to time including the students/parents | code of conduct.
2. we will deposit the Transfer Certificate of the previous school on or before our ward joins the school duly countersigned by D.E.O. or by the concerned educational authority, failing which the Principal has the right to cancel the admission.
3. we will deposit the fees in full, on or before the due date and shall also pay all debit on our ward's account within seven days from the date of presentation of such bill to us and we will not dispute the said bill for any reason or on any ground whatsoever. Failing to make the payments within the stipulated time may lead to striking off name of our ward from the registration and admission without any further notice to us.
4. we conform to the fee structure of the School which is subject to change from time to time, at the discretion of the Management.
5. if our ward leaves the school and gurukul before the end of the Term, fees will be payable for the next quarter along with the Term fees (I and II) and we will not be entitled to refund of the fees under any circumstance whatsoever, except the security deposit/caution money and Personnel deposit after deducting the expenses and loss incurred to the School, if any, on account of our ward.
6. prior to withdrawal of our ward by us, from the school we shall pay all unpaid installment or any other amount due for the Term.
7. in addition to fees mentioned in the Fee-Structure, we shall be meeting all the expenses of books, uniforms, school transport, educational tours, class activities, material expenses, fees for public/board examinations and any other expenses in connection with our ward's education.
8. any damage to, or loss of library books, laboratory equipments and other assets of the school or gurukul will be adjusted from Security Deposit/Caution Money.
9. all the refundable deposit will be refunded to us without interest after deducting all the expenses and damages, if any, on account of our ward.
10. we shall comply with the leave rules of the school i.e. no leave is permissible for religious functions. Only two days leave in addition to travelling time for attending the marriage of real sister or brother will be granted on showing an invitation card for the same. Leave to offer condolence to immediate relations is permissible. During exams no leave will be granted.

11. in case of sickness or accident of our ward, fatal or otherwise Which may occur in sports field, laboratories, gymnasium, educational tours or any other form of activities of the school or gurukul within or outside the campus, we shall not hold the school responsible on any ground, whatsoever including the ground of negligence and all the expenses that may be incurred in the treatment of such injuries/sickness shall be borne and paid by us.
12. For the students using Hostel Facility. (Boarders only)
 - a) no food parcel and electrical/electronic gadgets such as FM radio; mobile etc. will be sent by us or our family members to the ward.
 - b) no cash or costly/valuable items will be given to our ward.
 - c) if our ward leaves the school campus without permission of the school authorities, is name will be struck off from the school rolls and the school authorities may lodge a police complaint also.
13. whatever information we have provided to the Management in all the forms for admitting the ward in the school and gurukul is true and correct and hereafter also, we will provide correct information to the Management as and when the same is asked for and in case of the information found by the Management being incorrect the Management shall be entitled to remove our ward from the school and gurukul and forfeit all the fees paid by us.
