The documentation should be completed on 17th and 18th January, 2014 latest by 5 pm by visiting bar council of India New Delhi office. The admit card of such Applicants would be given at 9 am at council office (New Delhi) on 19th January, 2014 itself. The candidature would be cancelled for the applicants of AIBE -VI who failed to appear on the above mentioned date."

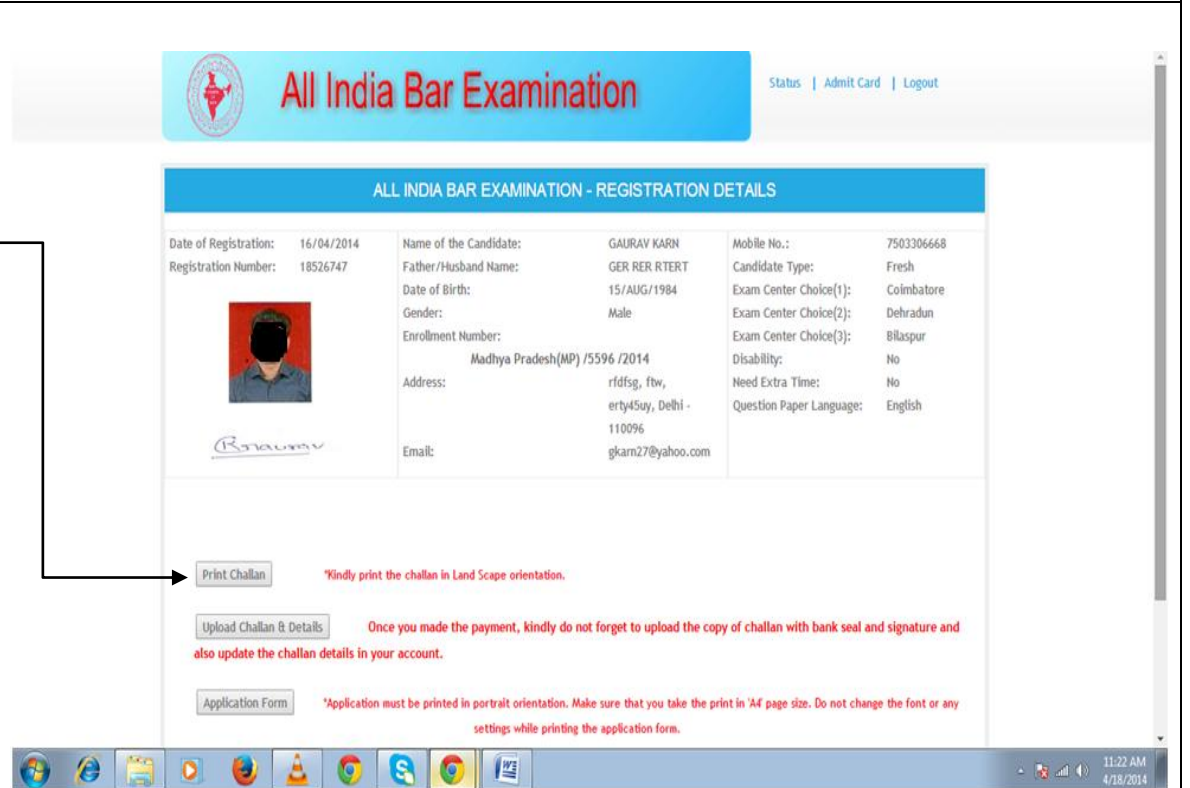

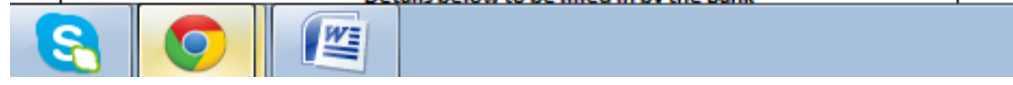

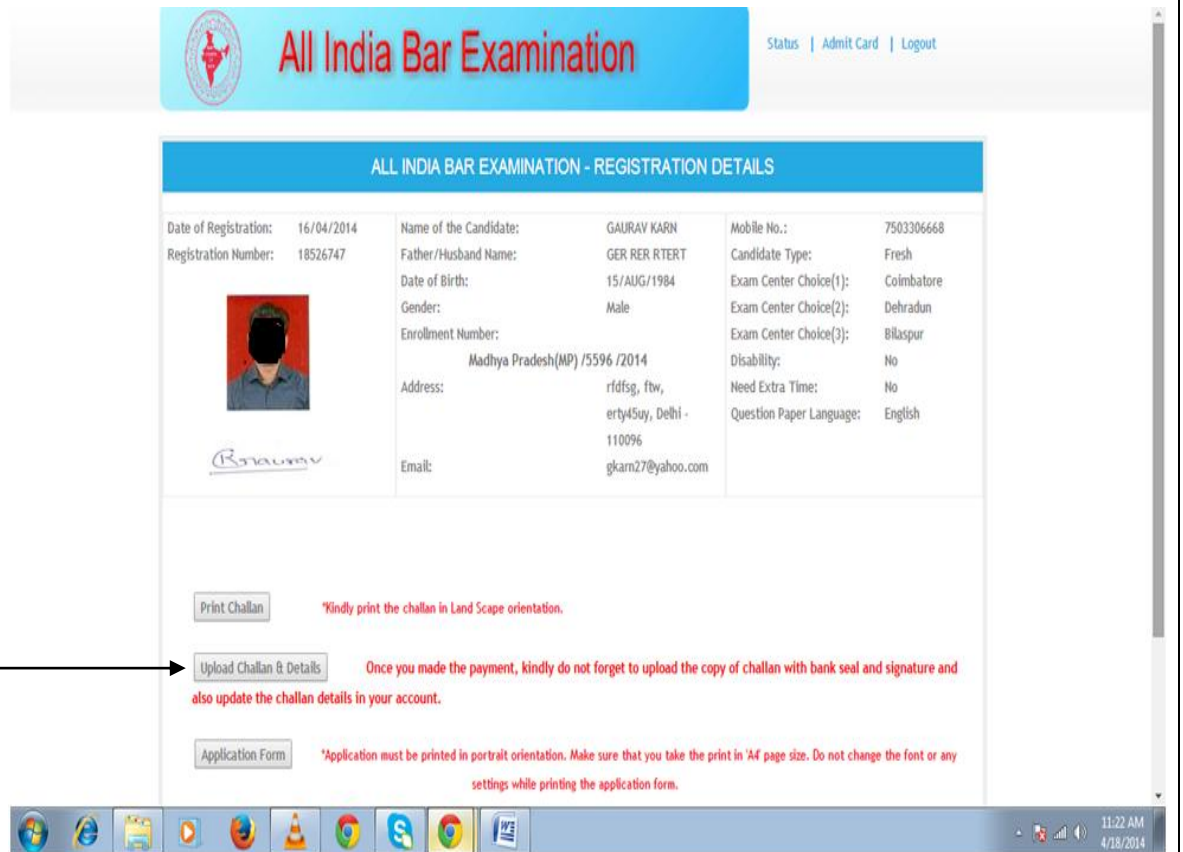

You will see your registration details and now click on the Upload Challan & Details button.



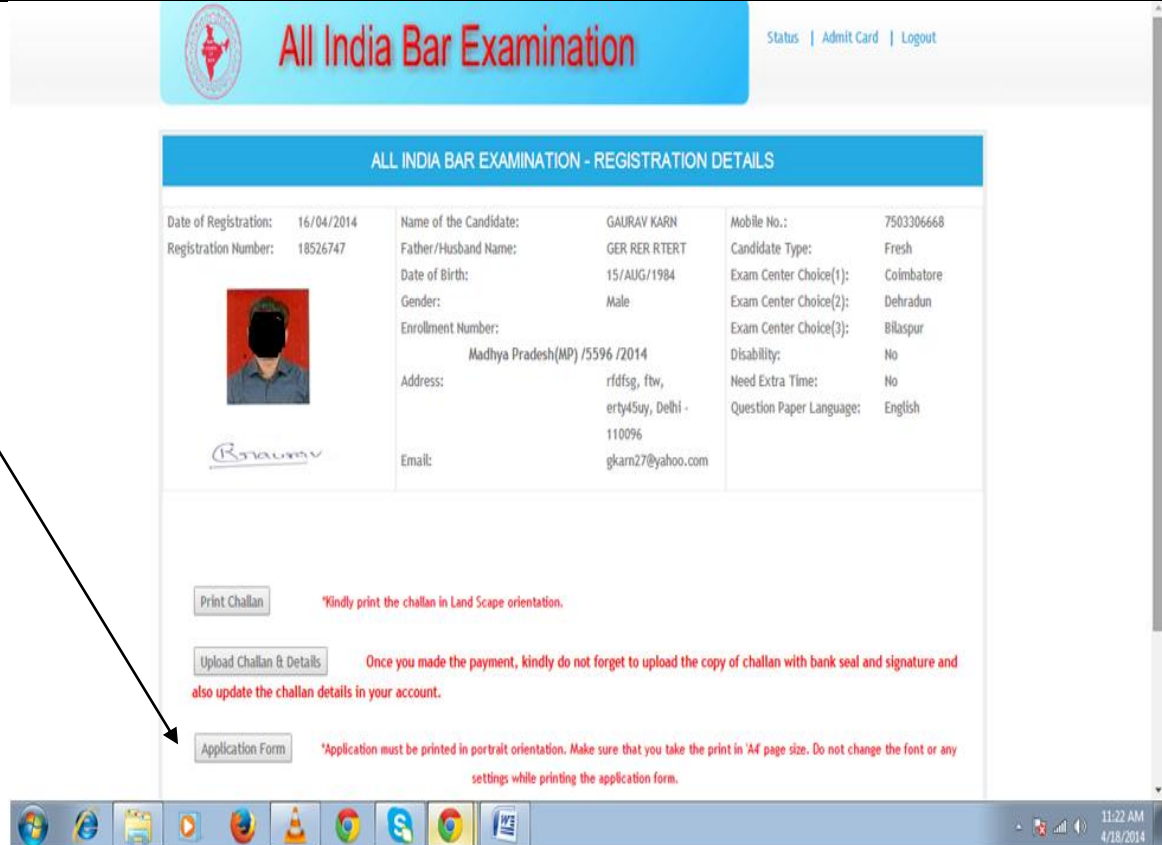
Step13:



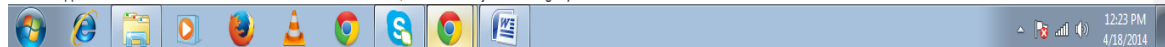
