Essential Qualification: Ph.D. submitted in the area of Agronomy / Soil Science for Scientist OR Ph.D. in the area of Agronomy / Soil Science with two years postdoctoral research experience in related area for Senior Scientist.

Essential Qualification : Ph.D. submitted in the area of Plant Biochemistry/Plant Biotechnology for Scientist OR Ph.D. in the area of Plant Biochemistry/Plant Biotechnology with two years postdoctoral research experience in related area for Senior Scientist.

<u>Essential Qualification</u>: Ph.D. submitted in the area of Agronomy for Scientist OR Ph.D. in the area of Agronomy with two years postdoctoral research experience in related area for Senior Scientist.

<u>Desirable Qualification:</u> Two years experience of working in agronomy and /or agriculture extension, preferably of medicinal, aromatic or other industrial crop(s) as evident with research publications and past/current job profile.

Job Requirement :To work in the area of Agronomy and agriculture extension.

<u>Likely place of work:</u> CSIR-CIMAP Research Centre, Hyderabad/other Research Centres of CSIR-CIMAP.

<u>Age limit</u>: Upto 32 years for Scientist / 37 years for Scientist (Upper age limit relaxable upto 10 years).

<u>Position No. 6: Scientist / Senior Scientist (Publications)</u> in Pay Band-3 Rs.15600-39100* (01 post Unreserved -UR)

Essential Qualification: Ph.D. submitted in the area of Botany/Chemistry/Biochemistry for Scientist OR Ph.D. in the area of Botany/Chemistry/Biochemistry with two years postdoctoral research experience in related area for Scientist.

<u>Desirable Qualification:</u> One year experience in editing and printing of scientific documents / research journals and popular journals, etc as evident with research publications and/or past/current job profile.

Job Requirement: To help in scientific publications/documentation of CSIR-CIMAP.

Likely place of work: CSIR-CIMAP, Lucknow

Age limit : Upto 32 years for Scientist / 37 years for Senior Scientist.

(*Positioning of the candidate as Scientist or Senior Scientist for positions No. 01 to 06 in terms of a particular grade i.e. Grade Pay Rs.6600/- OR Rs.7600/- in PB-3 (15600-39100) shall be done by the Selection Committee depending upon performance of the candidate subject to meeting the minimum criterion specified.)

NOTE: Two backlog vacant posts of Scientist-B which were advertised vide Advt. No./2010 (Position Nos.3&4 reserved for PWD) and notified as cancelled (Employment News/Daily newspapers during November, 2010) are being re-advertised at Position Nos. 4 &5 above with revised status as per new guidelines.

DEFINITIONS OF PERSONS WITH DISABILITY (PWD)

- 1) **Hearing handicapped (HH)** persons are those in whom the sense of hearing is non-functional for ordinary purposes of life. They do not hear, understand sounds at all even with amplified speech. The cases included in this category will be those having hearing loss more than 90 decibels in the better ear (profound impairment) or total loss of hearing in both ears.
- 2) Orthopaedically handicapped (OH) are those who have a minimum of 40% of physical defect or deformity which causes an interference with the normal functioning of the bones, muscles and joints.

GENERAL CONDITIONS:

(1)All the posts carry usual allowances at the same rates as are admissible to the Central Government employees at the place of posting. Higher initial pay could be considered for exceptionally meritorious and deserving candidates on the basis of recommendations of the Selection Committee. (2) The selected candidates will be governed by the provisions of the New Pension Scheme as introduced by the Government of India and as adopted by CSIR effective from 01.01.2004. (3) Relaxation in age limit, qualification and/or experience may be considered by the competent authority as in exceptional cases **(4)** Persons employed in Government/Government rules undertakings/Autonomous bodies are required to submit their applications through proper channel and with a clear certificate from respective employee that the applicant will be relieved in case of selection, within one month of receipt of offer of appointment. (5) Persons desirous to apply for more than one post may submit separate application for each post with separate application fee. (6) The selected persons should be ready to serve at any of the offices/Research Centres of CSIR-CIMAP located at Lucknow, Bangalore, Hyderabad, Pantnagar, Purara (Distt. Bageshwar) or at any place of posting in India as per need of CSIR-CIMAP R&D activities. (7) Upper age limit is relaxable as indicated against the post. (8) Relaxation in age limit up to five years may be allowed to the Council/Government/ Autonomous Bodies/Public Sector employees in accordance with the instructions and orders issued by the Government of India from time to time in this regard. (9)Relaxaton of upper age limit for Ex-servicemen is admissible as per rules. (10) Relaxation in the upper age limit of 5 years is applicable for persons who had ordinarily been domiciled in the Kashmir Division of the State of J&K during the period of 01.01.1980 to 31.12.1989 subject to production of relevant certificate from concerned authority. (11) Relaxation in the upper age limit for Physically Handicapped will be 5 years, over and above SC/ST/OBC as the case may be. (12) Special Age Relaxation: upto the age of 40 years in the case of Widows, Divorced Women and Women Judicially separated from their husbands, who are not re-married. (13) Relaxation in age, qualification and/or experience may be permitted if sufficient number of candidates possessing the requisite qualification and/or experience are not likely to be available to fill up the posts. (14) SC/ST/OBC/PH candidates are required to produce the certificate in the prescribed format signed by the specified authority at time of interview. The OBC candidate should produce the certificate valid for appointment of posts under the Central Government. (15) The upper age limit will be reckoned as on 25 April 2012 which is relaxable as per Government orders in force from time to time. (16) The period of experience in the requisite discipline/area of work wherever prescribed, shall be counted with effect from the date of acquiring the prescribed minimum educational qualifications required for the post. (17) The cut off date for determining the qualification and experience of a candidate will be the last date of receipt of applications. (18) The physically handicapped persons fulfilling the prescribed qualifications and experience are also encouraged to apply. (19) Mere fulfillment of essential educational qualifications & experience does not entitle a candidate to be called for Interview. The decision of CSIR-CIMAP/CSIR in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, conduct of interview will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection from any candidate or his/her agency. (20) Incomplete applications and applications not supported by attested copies of certificates of educational qualifications, experience certificate, community certificate, testimonials, list of publications, reprints and application fee are liable to be summarily rejected. (21) Candidates of Indian origin settled abroad of proven merit, as evidenced by their research work/publications, if found suitable for the post applied, may be considered by the Selection Committee, In Absentia, on specific request of the candidate. (22) Outstation candidates called for interview will be paid to and fro single second-class rail fare/ordinary bus fare from the normal place of their residence or that declared in the application or from the actual place of undertaking the journey, in India, whichever is nearer to the place of interview, as per rules. (23) Canvassing in any form and bringing in influence political or otherwise will be treated as disqualification.
