#### **I. B. Tech (Chemical Engineering) Course (OTHER STATES QUOTA) :**

- **One seat for Haryana and Himachal Pradesh**
- **One seat for Goa, Delhi and Union Territories except Chandigarh**
- **One seat for Manipur, Arunachal Pradesh, Nagaland, Meghalaya and Sikkim**
- **Seven seats for the students hailing from the state of Old Madhya Pradesh, residing in the districts Balaghat, Betul, Bilaspur, Chhindawara, Damoh, Durg, Hoshangabad, Jabalpur, Mandla, Narsingpur, Nimar, Raipur, Rajnandgaon, Saugar & Seoni**
- **Three seats for NRI candidates (subject to State Government rules; refer DTE brochure for more details, to be filled by DTE, Mumbai)**

**II. B. Tech (Chemical Technology) Course (OTHER STATES QUOTA): In the disciplines of “Oil”, “Food”, “Pulp and Paper”, “Plastic and Polymer”, “Surface Coating Technology” and “Petroleum Refining and Petrochemical Technology”.**

- One seat for Northern States of Delhi, Uttar Pradesh, Punjab, Haryana, Chandigarh, Himachal Pradesh, Jammu and Kashmir.
- One seat for Eastern and Central States of Rajasthan, Gujarat, Madhya Pradesh, West Bengal, Bihar, Meghalaya, Tripura, Orissa, Assam, Mizoram, Arunachal Pradesh, Manipur and Nagaland.
- One seat for Southern states Goa, Andhra Pradesh, Dadra, Nagar Haveli, Daman, Diu, Tamil Nadu, Karnataka, Kerala, Pondichery, Andaman and Nicobar, Lakshadweep islands
- Three seats for NRI candidates(subject to State Government rules; refer DTE brochure for more details, to be filled by DTE, Mumbai)

**Eligibility Criteria**

1. Candidates seeking admission must be Indian nationals who have passed S. S. C. (X) or any other equivalent examination from any of the recognized board from the region for which the seats are reserved.

2. Candidates seeking admission must also have passed the H. S. S. C. (XII) examination of the Higher Secondary Board Examination (10+2) pattern from any of the recognized board from the region for which the seats are reserved.

**OR**

An equivalent examination from the recognized board from the region for which the seats are reserved.

3. Candidates should have also secured **not less than 50% marks in Physics, Mathematics and Chemistry/Biotechnology/Biology/ Vocational Technical subject in first attempt** and have also passed in English Language.

4. Selection of candidates is on the basis of their ranks in the composite merit list prepared & displayed by CBSE based on the score of JEE (Main) and normalized score in Class 12th or other qualifying exam (weightage as decided by the competent authorities).

**Important Notes:**

1. Send by speed post or submit by hand , the duly filled in application form for B.Tech. courses (Other than Maharashtra State Quota ONLY) along with a Demand Draft worth Rs. 500/- only, drawn in favor of “Director, Laxminarayan Institute of Technology, Nagpur” payable at NAGPUR.

2. The candidate shall fill the appropriate application form/s, separately for each course of choice (Chemical Engineering /Chemical Technology).

3. True copies of the certificates, duly certified & attested must be attached with the application form. All the original certificates will have to be produced at the time of admission and whenever called for at a later stage.
