Sir,

I am directed to refer to your letter No. 3/7/2007-P&P (Vol.II) dated 14.8.2008 on the above mentioned subject and to say that as per the prescribed Recruitment Rules for the post of Junior Engineer (Civil & Electrical), the educational qualification is Diploma in Civil or Electrical or Mechanical Engineering from an Institute recognized by the Central Government or equivalent qualification. As per the Notification dated 6.11.2007 of the Ministry of Human Resources Development (copy enclosed with your letter), Section A&B of Associate Membership Course and Part I& II of Technician Engineers (T) have been recognized equivalent to Degree and Diploma respectively in Civil Engineering.

Therefore Technician Membership Examination (Diploma) in Civil Engineering awarded by "The Institute of Civil Engineers (India)" during the year 2007-08 can be treated as equivalent to essential qualification for the recruitment of Junior Engineer (Civil) in CPWD. A review in respect of recognition of educational qualifications shall be made by Ministry of Human Resources Development after one year through AICTE. Further, the Architectural course is not the prescribed stream as per Recruitment Rules of Junior Engineer (Civil & Electrical) in CPWD and is therefore, not equivalent to essential qualification for the recruitment of Junior Engineer in CPWD.

INCORPORATION OF ELIGIBILITY CLAUSE AS QUALIFYING EXAMINATION FOR RECRUITMENT/PROMOTION OF GROUP A OFFICERS IN BRO

- 1. Reference your letter No ICE (I)/29/2008/3297 dated 08 Oct 2008.
- 2. Direct recruitment to the post of Assistant Executive Engineer (Civil) (Group A) through UPSC in terms of the existing Recruitment Rules in BRO is through the Combined Engineering Services Examination conducted by the UPSC for which the essential qualification is 'Degree in Civil Engineering of a recognized University or equivalent'. Hence all qualifications recognized as equivalent to a Degree in Civil Engineering by the UPSC will be automatically covered under the existing Recruitment Rules. Similarly, direct recruitment to Group B and C posts where a Degree or Diploma in Civil Engineering has been prescribed as the qualification for recruitment in terms of the existing Recruitment Rules, all qualifications which have been recognized by the Govt of India as equivalent to a Degree/Diploma in Civil Engineering will be automatically covered by the Recruitment Rules under the equivalency Clause.



1. General Information

Graduate Aptitude Test in Engineering (GATE) is an all India examination administered and conducted jointly by the Indian Institute of Science and seven Indian Institutes of Technology on behalf of the National Coordinating Board - GATE, Department of Education, Ministry of Human Resource Development (MHRD), Government of India.

The GATE committee, which comprises representatives from the administering institutes, is the sole authority for regulating the examination and declaring the results.

1.1. Zonal Administrative Institutes

GATE is conducted through the constitution of eight zones. The zones and the corresponding administrative institutes are:

Zone 1 - Indian Institute of Science Bangalore

Zone 2 - Indian Institute of Technology Bombay

Zone 3 - Indian Institute of Technology Delhi

Zone 4 - Indian Institute of Technology Guwahati

Zone 5 - Indian Institute of Technology Kanpur

Zone 6 - Indian Institute of Technology Kharagpur

Zone 7 - Indian Institute of Technology Madras

Zone 8 - Indian Institute of Technology Roorkee

The overall coordination and responsibility of conducting GATE 2009 lies with Indian Institute of Technology Roorkee, designated as the **Organising Institute for GATE 2009**.

1.2. GATE Qualification

Admission to postgraduate programmes with MHRD and some other government scholarship/assistantship at engineering colleges/institutes in the country are open to those who qualify through GATE. GATE qualified candidates with Bachelor's degree in Engineering/Technology/Architecture/Pharmacy or Master's degree in any branch of Science/Mathematics/Statistics/Computer Applications are eligible for Master/Doctoral programmes in Engineering/Technology/Architecture/Pharmacy as well as for Doctoral programmes in relevant branches of Science. To avail the scholarship, the candidate must secure admission to such a postgraduate programme, as per the prevailing procedure of the admitting institution. GATE qualification, however, is not required for candidates with Master's degree in Engineering /Technology/Architecture/Pharmacy, who may be seeking scholarship/assistantship for relevant doctoral programmes.

Some institutions specify GATE as the mandatory qualification even for admission of self-financing students to postgraduate programmes. GATE qualified candidates are also eligible for the award of Junior Research Fellowship in CSIR Laboratories and CSIR sponsored projects. Some government organizations prescribe GATE qualification as a requirement for applying to the post of a Scientist / Engineer.

1.3. Eligibility

The following categories of candidates are eligible to appear in GATE:

- a) Bachelor's degree holders in Engineering/Technology/Architecture/Pharmacy (4 years after 10+2) and those who are in the final or pre-final year of such programmes.
- b) Master's degree holders in any branch of Science/Mathematics/Statistics/Computer Applications or equivalent and those who are in the final or pre-final year of such programmes.
- c) Candidates in the second or higher year of the Four-year Integrated Master's degree programme (Post-B.Sc.) in Engineering/Technology or in the third or higher year of Five-year Integrated Master's degree programme and Dual Degree programme in Engineering/Technology.
- d) Candidates with qualifications obtained through examinations conducted by professional societies recognized by UPSC/AICTE (e.g. AMIE by IE(I), AME by ICE(I)) as equivalent to B.E./B.Tech. Those who have completed section A or equivalent of such professional courses are also eligible.
