M.ED. ADMISSION FOR THE SESSION 2010-2011 IN NON GOVT. COLLEGES OF EDUCATION

Applications on prescribed format are invited from eligible candidates for admission to the M.Ed. regular course in the Non-Govt. Colleges of Education affiliated with University of Jammu.

FEE:-

Rs.40,000/- per student besides other University fee as prescribed for B.Ed. Programme till such time, the state government prescribed the fee in the Non Govt. Colleges of Education for M.Ed. Course.

ELIGIBILITY

- i) Any person having a Bachelor's Degree in Education or any other degree recognized as equivalent thereto shall be eligible for admission to M.Ed. Course subject to fulfillment of eligibility criteria and other conditions prescribed for M.Ed. Course, the admission shall first be given to a candidate who :
- ii) Has passed the qualifying examination from the University of Jammu and is a permanent resident of territorial jurisdiction of the University of Jammu; or
- iii) Has passed the qualifying examination from any other University other than the University of Jammu but is a permanent resident of the territorial jurisdiction of the University of Jammu or
Is an employee of the Central or a State Govt. or a Public Undertaking or any other organization recognized for the purpose by the Syndicate, posted within the territorial jurisdiction of the University of Jammu, or son/daughter/spouse of such an employee;
OR
- iv) Is not a permanent resident of the territorial jurisdiction of University of Jammu but has passed the qualifying examination with not less than 60% marks from any recognized University, subject to the condition that number of seats in this category shall not exceed 10% of the total number of seats available in the course of study.
- v) After making admission of students following under the afore-said criteria, if seats remain vacant these shall be open to such candidates as have passed qualifying examination from any recognized University provided they have applied in time and are otherwise eligible

CRITERIA FOR DETERMINATION OF MERIT

A candidate to be eligible for admission to M.Ed. Course, must have passed the qualifying examination of B.Ed. The criteria to determine merit will be out of a total of 100 points which will be calculated as under :-

(i) The percentage of marks obtained by a candidate in the B.Ed. Examination shall be worked out with the weightage of :

(a) Theory	=	80%
(b) Practice of Teaching	=	20%

(ii) In the event of a tie between candidates seeking admission to the M.Ed. Course it shall be resolved on the basis of the aggregate marks obtained by the candidate in the first degree i.e., B.A./B.Sc./B.Com./B.B.A./B.C.A examination.

(iii) If the tie still persists, their marks in Part-III of the said examination (B.A./B.Sc./B.Com./BBA/BCA) will be the deciding factor. The candidate with higher marks shall get priority in admission.

PROCEDURE OF SUBMISSION OF APPLICATION FORM

The application form can be downloaded from the website annexures. The form (2 pages) to be downloaded on A4 size bond paper/JK/Modi xerox photostat paper and complete in all respects accompanied with a Crossed Bank Draft of any Nationalised/Scheduled Bank for Rs.300/- (which is non-refundable) drawn in favour of **Director, Colleges Development Council, University of Jammu payable at Jammu** alongwith attested photocopies of all qualifying certificates/degrees must be sent to the Asstt. Registrar, CDC, Administration Block, University of Jammu, Jammu by Registered post/speed post/ by hand/ Courier so as to reach before the last date(s) specified as under :-

- 3) Submission of application form with late fee of Rs.100/- upto : **16.8.2010**

PROCEDURE OF ADMISSION :-

Admissions shall be made by the Admission Committee constituted for the purpose on the basis of merit to be determined as per criteria mentioned above. Allotment of College will be made on the basis of merit-cum-choice. The merit list of the candidates will be displayed on the notice board of the College Development Council, Administration Block on **19th August, 2010**. The candidates will report for admission on **21st August, 2010 at 10.00 a.m.** alongwith original documents of examination passed alongwith a Demand Draft of **Rs.40,000/- drawn in favour of Director, Colleges Development Council**. The admission will be made strictly in order of merit subject to availability of seats in each college. If a candidate does not report for admission on the scheduled date and time, it shall be presumed that he/she is not interested in seeking admission and the next candidate in order of merit shall be considered for admissions.

No separate intimation shall be sent to the candidates. The candidates have to be personally present at the time of admission.

IMPORTANT NOTES :-

1. Photocopies of the application form on standard brand A4 photo-stat paper can also be used.
2. The Demand Draft must be in the name of the Director Colleges Development, University of Jammu payable at Jammu.
3. No additional document/certificate will be accepted at the time of admission.

5. The Colleges cannot make direct admissions.
6. Class work shall start from **23rd August, 2010**.
