CANDIDATES WHO HAVE BEEN PROVISIONALLY SELECTED FOR INTERVIEW FOR ADMISSION WILL BE REQUIRED TO BRING THE FOLLOWING AT THE TIME OF INTERVIEW AND ADMISSION:

- 1) 5 (FIVE) COPIES RECENT PASSPORT SIZE PHOTOGRAPHS.
- 2) ALL ORIGINAL AND ATTESTED PHOTO COPIES OF MARKSHEETS AND CERTIFICATES OF SECONDARY LEVEL, HIGHER SECONDARY LEVEL & **B.SC.** (CERTIFICATE, IF AVAILABLE).
- 3) ORIGINAL ADMIT CARD/CERTIFICATE OF SECONDARY LEVEL EXAMINATION FOR VERIFICATION OF DATE OF BIRTH.
- 4) ORIGINAL AND ATTESTED PHOTO COPIES OF SC/ST/PD CERTIFICATES FROM COMPETENT AUTHORITIES IN THE NAMES OF THE CANDIDATES, WHERE APPLICABLE.
- 5) ORIGINAL INCOME CERTIFICATE FROM COMPETENT AUTHORITY.
- 6) ORIGINAL 'CANDIDATE'S COPY' OF PAY-IN-SLIP, PROVIDED BY THE BANK, PRINT-OUT OF ON-LINE APPLICATION AND ADMIT CARD OF ADMISSION TEST.
- 7) DISCONTINUITY CERTIFICATE, IN CASE OF ANY YEAR LAG.
- 8) CANDIDATES WHO HAVE ALREADY TAKEN ADMISSION IN ANY UNIVERSITY/INSTITUTE/COLLEGE SHALL SUBMIT ADMISSION CANCELLATION CERTIFICATE WITHIN SEVEN DAYS FROM THE DATE OF ADMISSION, FAILING WHICH ADMISSION IN JADAVPUR UNIVERSITY WILL BE CANCELLED FORTHWITH.

THE SEATS WILL BE FILLED UP IN ORDER OF MERIT FROM PUBLISHED PROVISIONAL WAITING LISTS.
