Based on the Written examination (Part-I) held on 01.04.2012 and Computer Skill Test (Part-II) held on 17.06.2012 for the post of Upper Division Clerk (U.D.C) in Employees' State Insurance Corporation, Andhra Pradesh Region, candidates having following Roll Numbers have been selected provisionally subject to submission of original certificates in support of their Qualification, Age, SC/ST/OBC, Disability, Ex-Servicemen discharge certificate issued by the competent authority in the proforma prescribed for appointment to the posts under the Government of India.

Offer letters to all successful candidates are being dispatched separately.

Candidates belonging to SC, ST, OBC category are required to submit their latest Caste Certificates issued by competent authority **duly revalidated.**

Further, candidates belonging to OBC category are required to submit **latest caste certificate** in prescribed format as mentioned in GOI Dept. of Per. & Trg. O.M. No. 36033/28/94-Estt, (Res.), dated 02.07.1997.

Persons with disability shall be required to submit latest disability certificate issued by the Medical Board constituted by the Central / State Government in the prescribed proforma.

Furthermore, all the candidates will have to submit certificate of medical fitness issued by Civil Surgeon / District Medical Officer in the prescribed format.

All the candidates will have to submit Character & Antecedent Verification form in prescribed format duly signed by prescribed Officials.
