Masters in Business Administration (MBA)	MBA Program is the primary course offered at Punjab Institute of Management (PIM), PTU Main Campus. Students for an MBA program can specialize in the areas of Marketing, Finance and Human Resources. Total intake for MBA program is 60 only. This has been done with a view to impart quality education to a select number of students. Students qualifying CAT / MAT / XAT / CMAT or any other
	equivalent national level examination with minimum 50% marks in graduation (45% in case of SC/ST) are eligible to apply.
	Candidates who have not given any national level entrance exam as mentioned above but have secured 50% marks (45% in case of SC / ST) in graduation are also eligible to apply for admission to MBA by appearing in an objective type written test to be conducted by PIM on June 22, 2014. Students whose result is awaited are also eligible to appear in entrance exam.
Certificate Programs	The institute is set to begin with short term certificate courses in the area of Advertising and Retail Management, Credit Risk and Treasury Management and Retail Banking by December, 2014.
Doctor of Philosophy (PhD)	PhD program at Punjab Institute of Management is a unique offering for researchers who wish to pursue their research in the area of Marketing and Finance. Punjab Institute of Management is on the lookout for University Grants Commission's Junior Research Fellows (UGC-JRF) who want to do their PhD full-time. Handsome Stipend will be paid by UGC as per its rules. Since this is a full-time PhD program, students will have to attend university on a regular basis. This is not a part-time PhD offering.

C/E/I=. C means Compulsory subjects, E means Elective subjects and I mean Interdisciplinary subjects.

**End Semester Examination:** Final examinations cover full syllabus of the semester. Question paper are divided into three parts i.e. Section A , Section B and Section C. Section A consists of 6 short notes of 2 marks each covering two questions from each unit, Section B consists of 4 questions of 10 marks each. Section C consists of a case study. All questions are compulsory.

**Continuous Evaluation:** Credit Based Evaluation System (CBES) is followed at PIM. The continuous monitoring of students ensures that the performance of a student is checked at regular intervals to ensure that all students fair well at every step of the way.



First and second Minor Tests are of 12 marks each from unit I and Unit II respectively, 6 marks are assigned on the basis of class participation / assignments / case evaluation of the student. Written test based on Multiple Choice questions covering the entire syllabus is conducted out of 10 marks.

Faculty members at PIM have both academic as well as industry experience. ### **Admission Guidelines**

### **Eligibility Criteria:**

1. <u>Candidates who have qualified CAT / MAT / XAT / CMAT</u> or any other National level entrance exam for admission to MBA with 50% marks (45% in case of SC / ST) in graduation are eligible to apply for admission in MBA at Punjab Institute of Management (PIM), Punjab Technical University Main Campus, Kapurthala.

2. <u>Candidates who have not given any entrance exam</u> as mentioned above but have secured 50% marks (45% in case of SC / ST) in graduation are eligible to apply for admission to MBA at Punjab Institute of Management (PIM) Punjab Technical University Main Campus. These candidates will have to appear for an objective type written test to be conducted by PIM on June 22, 2014.

3. Candidates appearing in their final degree examination / qualifying examination whose result is not declared at the time of admission shall be admitted provisionally subject to submission of the result of the qualifying examination latest by August 30, 2014. At the time of admission, he / she will have to submit a certificate obtained from the Principal / Head of the Institution certifying that the candidate has obtained not less than 50% marks (45% marks in case of SC / ST) based on the preceding Grades / Marks.

4. Reservation of seats in the course shall be determined as per the Reservation Policy of the Government of Punjab.

(a) Application under a reserved category must be accompanied by a certificate from the competent authority (as given in Reservation Policy) stating that the candidate belongs to that particular reserved category for which he/she is claiming a seat.

(b) Under no circumstances, the proof of belonging to a particular reserved category shall be entertained or altered after the Application Form has been submitted.

(c) If no reservation is claimed, the candidate shall be treated and considered as a 'General Category Candidate'.

(d) All admissions will be provisional and liable to cancellation, if at any stage, any information furnished by the candidate is found to be fabricated or false.

The candidate claiming seat under any one reserved category will be admitted on merit inter-se in that category / categories subject to fulfilling the eligibility requirements.



All candidates must declare their claims for reserved categories at the time of filling their forms for the counseling otherwise; their subsequent claims may not be accepted. Admission will first be made against reserved categories and if any reserved seat remains unfilled, it will be treated as open for admission from general category candidates. The claim for a seat in any reserve category will not prejudice the right of a candidate for being considered in open merit.

### Prohibition, Prevention and Punishment of Ragging at the PTU Main University Campus

The University Grants Commission vide its letter no F.1-16/2007 (CPP-II) dated June 17, 2009 has reiterated the ban on ragging of students in Institutions of Higher Learning. The students are therefore directed to strictly desist from any kind of ragging.

### **Ragging constitutes the following:**

- 1. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- 2. Indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- 3. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
- 4. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
- 5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- 6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- 7. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- 8. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student ;
- 9. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.



### **Punishment for Participation in/or Abetment of Ragging:**

- 1. Cancellation of admission.
- 2. Suspension from attending classes.
- 3. Withholding/withdrawing scholarship/fellowship and other benefits.
- 4. Debarring from appearing in any test/examination or other evaluation process.
- 5. Withholding results.
- 6. Debarring from representing the institution in any national or international meet, tournament, youth festival, etc.
- 7. Suspension/expulsion from the hostel.
- 8. Rustication from the institution for periods varying from 1 to 4 semesters or equivalent period.
- 9. Expulsion from the institution and consequent debarring from admission to any other institution.
