#### 13. MERIT LIST

After completion of Phase – II, Merit lists in each category namely, Gen, SC, ST, OBC (NCL) and Ex-servicemen will be drawn on the basis of total marks obtained by the candidates in the written examination. Extended list shall also be prepared to cover the shortfall due to failure of candidates in DME and Review Medical Examination (RME). However, there shall be no reserve list.

### 14. <u>RESOLUTION OF TIE CASES</u>

The application for Re-Medical Examination shall be sent to THE INSPECTOR GENERAL (North East) Frontier Hqr, ITB Police, Old AP Secretariat Building, Cantt. Area, GS Road, Shillong (Meghalaya)- 793001.
- (iv) The decision of the RME Board of ITBP shall be final and no second appeal shall be entertained as per Govt. instructions. No reply of the correspondence for second appeal will be considered/entertained.


