SELECTION & ADMISSION PROCEDURE

1.0 B. Pharm

Total numbers of seats are 120, out of which 60 seats are reserved for Sikh Minority students. However, students of General and other categories may also apply in the same procedure wherein they will be placed in the waiting list for seats falling vacant from Management & General Category to be filled after counseling conducted by Uttarakhand Technical University on 15th June, 2012. Please **refer Para 1.2** for details and **Para 1.3** for important dates and procedure of admission..

Remaining 60 seats will be filled through Uttarakhand State Entrance Examination, conducted by Uttarakhand Technical University, Dehradun scheduled on 15th June 2012 web address: (www.uktech.in).

Over and above the normal strength, 2 seats are reserved for Migrants of Kashmir for which students should apply to Uttarakhand Technical University directly with a copy to the Institute.

Additionally, six seats are available under TFW (Tuition Fee Waiver) Scheme of Govt. of India. Candidate should apply to 'Uttarakhand Technical University, Dehradun' for admission under this category. Eligibility for these seats is as below:

- a. Sons and daughters of parents whose annual income is less than Rs. 2.50 lakhs from all sources shall only be eligible for seats under this scheme
- b. The Waiver is limited to the tuition fee as approved by the State Level Fee Committee for self-financing Institutions and by the Government for the Government and Government Aided Institutions. All other Fee except tuition fees will have to be paid by the beneficiary.

1.1 B. Pharm 2nd Year

Total 24 seats are available for lateral entry out of which 12 seats are to be filled through Uttarakhand State Entrance Examination, conducted by Uttarakhand Technical University, Dehradun schedules on 15th June, 2012. The details are available on www.uktech.in. The remaining 12 seats will be filled on the basis of merit to be prepared on the following criteria:-

- (1) Marks obtained in Diploma Pharmacy.
- (2) A maximum of four marks as per weightage will be added to the overall Merit.

Eligibility: Diploma holders with minimum 50% marks.

3.0 RESERVATION OF SEATS

50% of the seats are reserved for candidates of Sikh Minority Community, inclusive of 5% seats reserved for ex-students in Post Graduate Courses. 15% of the seats are reserved under management quota for NRI candidates.

4.0 **WEIGHTAGE**

Special Weightage of 2 marks in the Merit List will be given to:

- (a) Recipient of National Talent Award of N.C.E.R.T.
- (b) N.C.C. Cadets who have passed the "B" for Under Graduate Courses and "C" or Equivalent Certificate for Post Graduate Courses.

OR

Students who have been commended (i.e. have obtained 1st or 2nd position) at the Inter Zonal or Inter-University or Inter-State or State-Level Youth Festivals organized by the State Govt./University or competitions either individually or as members of a team.

OR

Sportsperson who have won 1st, 2nd or 3rd position at the University/State Level Tournaments organized by State Govt./University in Individual Events or Team Games or have actually participated in the Inter University or National Level Competition.

OR

Holder of Certificate of Merit for N.S.S./M.F.I.P. awarded by the University or State Govt.

- (c) Candidates who have passed Metric and Higher Secondary or 10 + 2 Examination from Schools situated in rural areas excluding Public/Boarding Schools and are bonafide resident of rural areas. In such cases, a certificate from a competent authority (1st Class Magistrate), to the satisfaction of the chairperson of the department concerned will be required.
- (d) All Female Candidates.
- (e) Wards of Olympians.

5.6 **GENERAL**

➤ Connectivity and Transportation: Dehradun is well connected by Air, Rail and Road. Kingfisher, Jet and Air India connect Dehradun to Delhi, besides Rail Services and Road.

Local transportation, local buses from Premnagar, Railway Station via Haridwar Road ply regularly to the Institute. Autorikshaws can be hired from ISBT and Railway Station.

Distances:

ISBT: 14 Km (Board local bus to Rispina Bridge, change bus for Institute/Balawala from here).

Railway Station: 12 Km (Board local bus to Institute via Haridwar Road).

Airport: 15 Km (Hire Taxi).

6.0 *FEE*

- The fee deposited at the time of counseling is towards admission and advance tuition fee.
- ➤ Balance fee is to be deposited as per admission letters and important dates notified for courses.
- Candidates who fail to deposit the advance fee as per as per admission letters and important dates notified for courses shall not be considered for admission.

6.1 CANCELLATION OF ADMISSION

Student not desirous admission in the Institute after completing admission process due to any reasons must inform the Institute in writing for cancellation and must obtain cancellation letter for same.

6.2 Refund Rules:

- i) Refund of the fee will be subject to deduction of Admission Fee.
- ii) However, if withdrawal is after commencement of classes and during the continuation of the academic session Fee will be refunded after further deductions.
- iii) Refund after last date of admission shall not be considered under any circumstances.
- (iv) In case of withdrawal during the course, the student shall have to deposit the entire course fee.
- (v) Security is refundable only after on obtaining no dues from all concerned department, on completion of course.

6.3 Transfer of admission to Another Course

- (a) <u>During Process of Admission and Before Commencement of Class.</u> The transfer will be allowed on availability of seat in the desired course. A processing fee of Rs 500/- shall be charged for the same.
- (b) <u>After Commencement of the Course</u>. All the cases shall be treated as withdrawal and re-admission. Deduction as per procedure of withdrawal shall be applicable.
