RADHABAI PAONASKAR SCHOLARSHIP AND MEDALS FUND. :- One Scholarship, of Rs. 800/- p. m. one Gold and two Silver Medals. **Eligiblity**: A Scholarship of the value of Rs.800/- per month shall be awarded to the student who secures highest number of marks among the successful female candidate at the Higher Secondary School Certificate Examination (XII Standard) of the Maharashtra board of Secondary Education (Vidarbha Division). The recipient shall be called the Radhabai Paonaskar Scholar.

The Scholarship shall be tenable for 3 Academic years (total 34 months) while the scholar prosecutes regular course of studies in a college affiliated to the Nagpur University, with a view to qualify herse for Admission to the course of B.A. part I/B. Sc. part –I of Nagpur University in accordance with its regulations. On the scholar ceasing to prosecute such a course of studies to the satisfaction of the principal at any time during above period, the scholarship shall at once determine.

The Scholarship shall be open to confide residents of Vidarbha who have received the whole their University education, in one of colleges maintained by or admitted to the privileges of the University and shall be awarded only to graduates who have attained the degree of B.A. or B. Sc in the first or Second division of Nagpur University and shall be tenable in one of the college maintained by or admitted to the privileges of the University for a period of two years.
- 3. The holder of the Scholarship shall study for the M.A. or M. Sc. degree of Nagpur University and shall follow no trade of profession nor prosecute any other study during his tenure of the Scholarship.
- 4. Candidates for the Scholarship shall forward their application to the Academic Council of Nagpur University through the Principal of the college in which they are studying stating the course of study which they intend to pursue. The Academic Council of Nagpur University with the approval of State Government shall selected the scholarship holder from among the applicants after consideration of their individual qualifications.
- 5. It shall be within the power of the Academic Council of Nagpur University of Nagpur University with the approval of the State Government at any time to withdraw the fellowship or Scholarship if it has reason tonbe dissatisfied with the conduct or work of the fellow or scholar.
- 6. All matters no otherwise provided for in this scheduled shall be determined by the Academic Council of Nagpur University with the approval of the State Government and its decision 4 thereon shall be final.
