

About The University

GENESIS

The Prime Minister, in his address to the nation on August 15, 2007, announced the establishment of a Central University in each of the states that did not have a central university so far. Subsequently, 11th Plan provided for the establishment of 16 new Central Universities. Accordingly, the Central Universities Act 2009 (No. 25 of 2009) which received Presidential assent on 20th March 2009 provided for the establishment of Central University of Himachal Pradesh amongst others.

ESTABLISHMENT OF THE UNIVERSITY

The Central University of Himachal Pradesh is established under the Central Universities Act 2009 (No. 25 of 2009) enacted by the Parliament. The University is funded and regulated by the University Grants Commission (UGC). The University became functional with the assumption of charge by the first Vice Chancellor on 20th January 2010.

VISION OF THE UNIVERSITY

While the development of infrastructure of the University may take a while, it has an ambitious Vision Document prepared in consultation with eminent experts in the field of education. The Vision Document and Strategic Plan of the University as approved by the statutory authorities of the University are available at the website of the University (www.cuhimachal.ac.in).

Accordingly, in due course of time, the University will grow to have purpose-built, state-of-the-art campus that will have 17 Schools of Study with nearly 90 Departments of Study and about 50 Centres of Study.

LOCATION AND HEADQUARTERS

The Headquarters of the University is located at Dharamshala, District Kangra, Himachal Pradesh. Dharamshala is a place with profile and is known worldwide. Serene Location, pleasant climatic condition, spiritual environment provide an attractive ambience conducive to academic pursuits.

PERMANENT CAMPUSES


The University will have campus (es) as and when land is made available by the State Government free from all encumbrances.

TEMPORARY CAMPUSES

Pending the development of its own infrastructure and permanent campus (es), the University is presently operating from its Temporary Campuses comprising the following facilities:

CAMP OFFICE

The Camp Office, which presently serves as the Headquarters of the University is located in the Sanskriti Sadan (Writers' Home), at Dharamshala (Near International Cricket Stadium), District Kangra.



The Offices of the Vice Chancellor, Registrar and Finance Officer are located in the Camp Office.

TEMPORARY ACADEMIC BLOCK (TAB)

The Temporary Academic Block of the University is located in a newly constructed college building at Shahpur, District Kangra. Purpose-built, it is an eyecatching spacious three-storied building located amidst picturesque surroundings. Adequate to cater the present needs of classrooms, labs, faculty and students, it provides inspiring ambiance for academics. Large open space surrounding the building is enough for sports facilities and games. All Academic Programmes of the University are being run from the Temporary Academic Block.

TEMPORARY BOYS HALL OF RESIDENCE

The building hired for Boys' Hostel is purpose built and accommodates about 110 students of the University in two/three-bedded rooms and has facilities for kitchen and Dining Hall. The Hostel Mess is run on cooperative basis by the residents under the supervision of the Warden/Provost. All students who wish to opt for hostel accommodation have to join the hostel mess and make arrangement for transport on their own. However, at present the University has arranged transport facility to the residents and other students coming from Kangra and nearby areas to

Temporary Academic Block by paying a token bus coupon fee of ₹ 500 per month.

TEMPORARY GIRLS HALL OF RESIDENCE

The University has hired a building in Dari-Dharamshala on rent for the Girls Hostel of the University. The facility is purpose built and accommodates about 45 Girl students of the University. University has arranged transport facility to the residents of the hostel to commute between the Hostel and the Temporary Academic Block. However, to avail transport facility, students have to pay a token bus coupon fee of ₹ 500 per month.

ACCESSIBILITY & CONNECTIVITY

- Camp Office, Dharamshala is 12 km from Kangra Airport at Gaggal and 90 km from Pathankot.
- The Temporary Academic Block (TAB) of the Central University of Himachal Pradesh is at Shahpur, located nearly 30 km from Dharamshala on Mandi - Pathankot Highway. From TAB, Kangra Airport at Gaggal is at a distance of 16 km. and Pathankot Railway station is approximately 60 km. All buses from Pathankot scheduled for Dharamshala, Manali, Mandi, Baijnath and Shimla pass through TAB, Shahpur.

Applicants who are not eligible for Admission to RD Programme

The following shall NOT be Eligible for admission in the University:

- (a) A person who has been suspended, rusticated, debarred, expelled or removed from the roll of the University by a competent authority of the University.
- (b) A person who at any time, was admitted to a PhD programme in this University or has completed

PhD degree either from this University or any other University shall not be eligible to apply for the same.

(c) A person who at any time was admitted to an MPhil Programme in this University or has completed an MPhil Degree either from this University or from any other University shall not be eligible to apply for the same or any other MPhil Programme of this University.

Reservation of Seats in Admission

- The University shall follow reservation in admission as mandated under the Central Educational Institutions (Reservation of Seats) Act 2006, as amended from time to time.
- 2. The University shall also follow reservation in admission in all Programmes of Study in accordance with the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995.
- 3. Accordingly, the University shall reserve in all Programmes of Study seats for admission as under for the students belonging to:

- Persons suffering from not less than forty per cent (40%) of any disability as certified by a competent medical authority would be considered for admission under PWD category.
- There will be concession facilities of fee waiver, free accommodation, food and transport for students with disabilities.
- v. The Kashmiri migrant students shall have the following concessions in admission to various programmes during academic year 2014-15:

- Relaxation in cut off percentage upto 10% subject to minimum eligibility requirement.
- Increase in intake capacity upto 5% course-wise.
- Reservation of at least one seat in merit quota in technical/professional institutions.
- Waiving off domicile requirements.
- vi. Two seats are available under supernumerary quota for admitting students coming from the state of Jammu & Kashmir
- Candidates seeking admission under the reserved categories shall be required to fulfil the prescribed conditions of admission to the Course.
- Application Form of a candidate in the reserved category must be submitted along with the Caste/ Tribe/ Non-Creamy Layer certificate issued by the competent authority as per the certificate format enclosed with the application form.
- 6. Application Form received without the required certificates shall be rejected.
- 7. If a candidate in the reserved category qualifies for admission in the general category s/he shall be treated as a general category candidate. If sufficient number of candidates are not available to fill up the seats reserved for Scheduled Tribes, these may be filled up by suitable candidates from Scheduled Castes and vice-versa.

Salient Features of The University

ADMISSION BASED ON SINGLE COMMON ENTRANCETEST

The University has introduced aptitude-based common entrance examination for admission in all its Programmes of Study. Candidates seeking admission in the University shall be required to fill up only a single admission form indicating their preference of Programmes of Study and shall be required to take only one entrance examination. Accordingly, the University has introduced:

- HEAT (Higher Education Aptitude Test) as a single common entrance test for admission in all Undergraduate Programmes across all disciplines
- FEAT (Further Education Aptitude Test) as a single common entrance test for admission in postgraduate programmes across all disciplines except in MA English, MA Hindi and MFA (Painting)
- TREAT (The Research Entrance Aptitude Test) as a single common entrance test for admission to MPhil/ PhD programmes across all disciplines

INNOVATIVE PROGRAMMES & CURRICULAR FRAMEWORK

Guided by the reforms agenda in higher education and learning from the experiences of the best universities of the world, the University has introduced a number of innovations, as detailed below:

- ▶ Semester-based Academic Calendar All academic programmes of the University Undergraduate (UG), Post Graduate (PG) and MPhil/PhD i.e. Research Degrees (RD) are based on semester system, designed at par with global practices in terms of effective number of teaching days and teaching-learning inputs.
- Programmes based on Comprehensive Choice Based Credit System: The University has introduced Comprehensive Choice Based Credit System (CCBCS) largely on the lines of the best universities of the world.
- Programmes of Study are defined in terms of Credits: As opposed to papers/courses in the conventional system, a student shall be required to accumulate:
 - 120 UG Credits to earn a UG degree
 - 80 PG Credits to earn a PG degree
 - 60 RD Credits to earn an MPhil degree
 - 120 RD Credits to earn a PhD degree
- Students Mobility and Credit Transfer: The University has designed a framework to facilitate credit accumulation by its students from other recognised universities of India and abroad. The university has developed a structured mechanism to work out the

equivalence and accept the transfer of credits earned by its students from other universities as per the relevant Ordinance of the Central University of Himachal Pradesh.

- ▶ Students to accumulate required number of credits from across disciplines: The inter-disciplinary approach in the selection of courses is followed with 70 per cent courses from the department and 30 percent from other schools/departments of the university. In case of School of Business and Management Studies, students would offer 30 percent Courses University wide; 40 percent School wide and 30 percent department wide.
- Innovative approach in designing Programmes of Study: Departments would not design Programmes of Study as such. Instead, they would (a) Design and offer courses, based on the expertise and specialisation of their faculty members; (b) Specify pre-requisite and corequisites for each course offered; (c) Guide the students to make their own basket of courses to accumulate the required credits to complete their Programme of Study. Thus, the focus is on 'learner-centred approach' (as opposed to the conventional 'teacher-centred approach') to accommodate learner's needs and expectations to have wider choices in content, mode and pace of learning.
- Computation of Credits based on a Holistic Approach to Learning: In the Central University of Himachal Pradesh, one credit is defined as equivalent to the Total Student's Effort (TSE) of 30 hours comprising:
 - 10 hours of lectures/organised classroom activity/contact hours;
 - 5 hours of laboratory work/ practical/ field work/ tutorials/ teacher-led activities;
 - 15 hours of other workload such as independent individual/ group work; obligatory/ optional work placement; literature survey/ library work; data collection/ field work; writing of papers/ projects/ dissertation/ thesis; seminars, etc.

Thus, the focus is on in-depth learning driven by intrinsic curiosity and mastery of the subject by balancing the taught content with independent self-directed learning.

All Programmes of Study to be Modular: All Programmes of Study in the university are designed as modular with exit and lateral entry option. While most students may want to complete their UG/PG/RD without any break, some may opt out of the Programme of Study midway due to their personal compelling reasons. The University, therefore, provides a structured framework for students to opt out mid-programme, whereby, depending on the extent of time spent on campus and credits accumulated by them, they will be awarded certificate/diploma/ advanced diploma. For instance, if any student wants to quit study after two semesters, she/he can do so and would be awarded an appropriate Certificate/ Diploma/ Advanced Diploma and can rejoin her/his study from this point within two years again. Thus:

o A Student Admitted to UG Programme may get:

- Certificate (if opts out after 2 Semesters with 40 UG Credits);
- Diploma (if opts out after 4 Semesters with 80 UG Credits);
- Bachelor's Degree (if stays on to complete full 6 semesters with 120 UG Credits).

o A Student Admitted to PG Programme may get:

- Advanced Diploma (if opts out after 2 semesters with 40 PG credits);
- Master Degree (if stays on for full 4 semesters with 80 PG credits).

Those who thus opt out would be eligible to join laterally to complete and earn their degree, if they return to the university within the next two years.

- All Programmes of Study to be Multi-disciplinary/Inter-disciplinary: While Departments of Study of the University are designed around basic disciplines (to enable faculty members to continue to focus on their specialised areas of research) each Programme of Study of the university is multi-disciplinary. The student is empowered to accumulate required number of credits from a wide variety of courses offered throughout the university (e.g. a student will be entitled to learn mathematics with music, physics with philosophy, and technical courses with humanities and so on). Accordingly:
 - o At PG level, a student would be required to accumulate:
 - 70% Credits through Department-wide courses;
 - 30% Credits through University-wide courses.

In case of PG Programmes offered by the School of Business and Management Study, a student would be required to accumulate:

- 30% Credits through Department-wide courses;
- 40% Credits through School-wide courses;
- 30% Credits through University-wide courses.

SALIENT FEATURES OF THE UNIVERSITY

▶ All Programmes to be based on Comprehensive Continuous Internal Assessment: Students in all Programmes of Study across disciplines and at all levels shall be assessed through Comprehensive Continuous Internal Assessment based on quizzes, assignments, independent works, group works, mid-semester and end-semester examination. As a general principle, the Comprehensive Continuous Internal Assessment shall comprise the following components:

Continuous Internal Assessment 25%
 Mid Semester Examination 25%
 End Semester Examination 50%

♠ All Programmes of Study to have Grading System: The University shall have grading system based on six point scale of evaluation of the performances of students in terms of marks, grade points, letter grade and class. The total performance of a student within a semester and continuous performance from the second semester onwards shall be indicated by (a) Grade Point Average (GPA); (b) Weighted Average Marks (WAM); (c) Cumulative Grade Point Average (CGPA); and (d) Overall Weighted Percentage Marks (OWPM).

INNOVATIVE RESEARCH DEGREE (MPhil/PhD) PROGRAMMES:

The University has rigorous full time Research Degree (RD) Programmes that aim at honing the research skills, grooming teaching abilities, producing quality research publications and proactive participation in seminars and conferences. Accordingly, the award of RD requires a student to accumulate credits through course work, teaching assistantship, published work and dissertation/ thesis. The duration and credit requirements for MPhil and PhD Programmes are as under:

MPhil: For successful completion of the RD Programme leading to the award of the MPhil degree, a student shall be required to accumulate a total of 60 RD Credits as under:

Course Work : 20 Credits
Dissertation : 20 Credits
Publications : 10 Credits
Teaching Assistantship : 10 Credits

PhD: For successful completion of the RD Programme leading to the award of the PhD degree, a student shall be required to accumulate a total of 120 RD Credits as under:

Course Work : 20 Credits
Dissertation : 60 Credits
Publications : 20 Credits
Teaching Assistantships : 20 Credits

- Programme shall be required to complete the prescribed course work in the first two Semesters of his/her admission. Notwithstanding the maximum prescribed duration of the Research Degree Programme, if a candidate fails to complete the prescribed course work in two semesters, his/her admission shall be cancelled and his/her name shall be removed from the rolls of the University. Provided further that no candidate admitted to the Research Degree Programme shall be permitted to proceed with the dissertation work till such time s/he completes the prescribed course work.
- Immediately upon the completion of formalities for admission in the Research Degree Programme, each candidate shall be required to submit in writing, on the prescribed format, as to whether s/he wishes to pursue MPhil or PhD Degree.
- Candidates admitted to RD Programme shall be required to complete the course work in the first Semester of his/her admission and accordingly, he/she shall not be permitted to proceed with dissertation work till such time that s/he completes the course work successfully.
- Computation of Credits for Published Work for MPhil and PhD degree would be made as under:

SALIENT FEATURES OF THE UNIVERSITY

- i) 2 credits for each popular article published / paper presented in national seminars/conferences/workshops;
- ii) 4 credits for each paper presented in international seminars/ conferences/ workshops;
- iii) 5 credits for each paper in approved refereed national journal;
- iv) 10 credits for each paper in approved refereed international journal;
- Each Department/Centre registering candidates for RD Programme shall be required to maintain an updated list of approved journals for publication.
- Computation of credits for Teaching Assistantships for the MPhil and PhD degree would be made as under:
 - i) 10 credits for independent teaching of a onesemester course of two credits;
 - 5 credits for working for shared teaching of a onesemester course of two credits:
 - iii) 1 credit for every 3 hours of involvement in assessment, evaluation, examination, course development, development of reading lists, etc. (supervisor concerned to audit the workload claimed under this category and certify)



Subject to the fulfilment of UGC / University norms and requirements, candidates admitted to MPhil/PhD Programmes shall be eligible to receive Fellowships and Contingency Grant as applicable to Non-JRF candidates as per UGC rules.

CLASSROOMS AND LECTURE THEATRES

The TAB has adequate classrooms and lecture theatres to cater to the present needs of the Programmes of Study being launched by the University. Classrooms are well-furnished and equipped with requisite multimedia aids for teaching.

University has a functional Central Library which is being further developed with adequate number of books, journals and reference material related to the disciplines in which Programmes of Study are being offered. Website of the University already provides links to e-resources. These are being enhanced and upgraded to provide e-learning resources and materials including e-books and e-journals. The Library has INFLIBNET facility for accessing online journals.

INFORMATION & COMMUNICATION TECHNOLOGY (ICT) LAB

A state of the art Computer Lab equipped with high-end 41 PCs loaded with necessary software is available for students.

INTERNET

1 GBPS fibre optic connectivity under the National Mission for Education - ICT has been installed. The TAB is equipped with Wi-Fi connectivity and students can access the Internet through their laptops.

LANGUAGE LAB

University is establishing a state of art multimedia digital language lab for helping the students to augment their linguistic and communicative proficiency. This lab would not only teach students English speaking but also other aspects of language such as grammar, phonetics and assist the students

in self-assessment and help the faculty in evaluation of students' progress in the language lab related courses.

FACULTY ROOMS AND CABINS

Faculty have well-equipped IT-enabled cubicles and workstations providing them all facilities for pursuing academic and research activities.

DISCUSSION CORNERS

To promote interaction of students with the faculty, counselling, advising, etc. the faculty members of the University have been provided with specially created discussion corners, Faculty Rooms and Cubicles. There is a special provision for group discussions and interactions among faculty members and students of RD Programme.

RESEARCH SCHOLARS' LAB

The university has created research environment by establishing fully computerised THREE research labs-cumworking spaces with the seating capacity of 114 research scholars at a time.

SEMINAR HALL

A well-equipped Seminar Hall, with a sitting capacity of about 140, has been created.

CONFERENCE HALL

For holding co-curricular activities and group presentations, a multi-purpose Conference Hall has been developed.

GAMES & SPORTS FACILITIES

The university has created facilities for sports like Badminton, Volleyball, Table Tennis and other indoor sports.



Enabling Services

FREESHIPS

In order to support the meritorious but needy students, the university grants Freeships to certain percentage of its students, limited to the percentage as may be prescribed by the University Grants Commission (UGC) in this regard from time to time. Award of Freeship includes exemption from the payment of all fees chargeable by the University on per credit basis, as notified in the prospectus, including exemption from professional development fees, if any. Such Freeships shall be granted by the Dean of the School concerned.

TRANSPORT FACILITIES

The University has arranged transport facilities, on nominal charge, to ferry students of the University from Dharamshala and Kangra to the Temporary Academic Block at Shahpur. Students residing in the hostels of the University are also covered by the transport facility from hostel to Temporary Academic Block at Shahpur.

TRAINING AND PLACEMENT CELL

The main objective of the Training and Placement Cell is to develop strong relationship with companies all over India. The personnel of this Cell visits potential employers in various companies and apprise them of the ample talent available at the Central University of Himachal Pradesh. The Training and Placement Cell organizes various activities such as industrial visits, invited lectures from industrialists, mock interviews, industry-academia interface, pre-placement talks and workshops, etc. which give ample opportunities to the industry as well as the students to interact with each other. Training and Placement Cell facilitates Summer Placement Programme for MBA students. An 8-Week On-the-Job Training is an integral part of the curriculum of the Management Programme of the School. This training helps the students in getting first hand exposure to corporate culture and developing their awareness, skills and values to improve their

readiness to shoulder the managerial responsibilities of future organizations at national and global level. Similarly students of MSW, MBA (T&T) and M. Lib. are required to do On-the-Job Training ranging from 4 to 8 Weeks during July-August. Efforts are being made to provide employment to the students of university. Campus placements are arranged for students of the university in reputed organisations.

UNIVERSITY-INDUSTRY INTERFACE

The University strives to have a vibrant university-industry interface aimed at collaborative work in the arena of curricula development, shared teaching, research and praxis. The University organised seminars and aptitude tests for MBA and Tourism students in collaboration with NIT, Bloomberg and Hotel Club Mahindra and Asppen Adventure.

COUNSELLING & GUIDANCE

Students of the University are provided with expert counselling and guidance.

GRIEVANCE REDRESSAL CELL

University has created a cell to address the grievances of students in order to promote cohesive and healthy corporate living on the campus.

To prevent any incidence of Sexual Harassment, a Committee in accordance with the relevant guidelines has been constituted.

FIELD WORKS/COMMUNITY LAB

University has unique programme for Community Lab to interact and network with the community in Himachal Pradesh, particularly the region in which the University is located. The Programme is integrated in the academic curricula. The students are assigned specific number of households in the identified villages. They collect data, prepare report, identify intervention strategies and work with the community towards their socio-cultural, educational and economic development and in the process enrich themselves with real-life experiences.

EXTRA-CURRICULAR ACTIVITIES

Limited facilities for games, sports and other extracurricular facilities are being made available at the Temporary Academic Block (TAB). These include outdoor games such as volleyball, badminton and basketball. Besides, a functional gym and facilities for selected indoor games are also being arranged.

CULTURAL ACTIVITIES

The University has a Cultural Society, a Debating Club, a Music Club, a Nature Club, a Film Club, a Theatre Group,

and a Photography Club. It has very rich corporate life.

EDUCATIONAL TOURS/INDUSTRIAL VISITS

Different Schools of the University organise Educational Tours and Industrial Visit for the students. These are aimed at exposing the students with the practical aspects of their discipline and sensitise them about the career opportunities and through that process help students chart out their career options and strategies.

SOCIAL AWARENESS CAMPAIGN

Students of the University proactively participate in a variety of activities leading to social awareness. These include poster competition, awareness programmes, sensitisation on social issues, organisations of debates and discussion, etc. This has led to the University forming Red Ribbon Club, which has now been upgraded and recognised as Youth Development Centre.

ACADEMIC EVENTS AND ACTIVITIES



Second Annual Convocation

The Second Annual Convocation of the Central University of Himachal Pradesh was held at its Temporary Academic Block (TAB) Shahpur on 12th February, 2014. The Visitor of the University, His Excellency Sh. Pranab Mukherjee, the President of India was the Chief Guest. Sh. Arun Maira, the Chancellor of the University presided over the Convocation. On this occasion, while degrees were conferred on 264 students, Advanced Diplomas were awarded to five students. Twelve students received Gold Medals. The University conferred on Dr. Vijay L Kelkar, an eminent economist and administrator, Honorary Degree (Honoris Causa) of Doctor of Philosophy. His Excellency while addressing the students said that education has an ability to alleviate human lives. He exhorted them to work towards the upliftment of their fortunate compatriots.

MoU WITH IIM AHMEDABAD

School of Business and Management Studies has signed an agreement with Indian Institute of Management Ahmedabad (IIMA) to access and download unlimited number of cases and technical notes developed by IIMA. IIMA will also provide necessary training and technical help to the faculty members of the school for developing cases as well as in using case study techniques in teaching pedagogy.

MOU WITH UNIVERSITY OF APPLIED SCIENCES, FRANKFURT, GERMANY

An MoU was signed between the University of Applied Sciences, Frankfurt, Germany and the Central University of Himachal Pradesh, Dharamshala to join hands in the sphere of academic & research programs, exchange of faculty, students & publications and other allied fields for furtherance of knowledge based enterprises, apt technical and management skills for future technology development, information exchange and work towards innovative & effective research, academic partnerships for Human Resource Development and R&D. The scope of the MoU will be to collaborate for research and teaching in the designated subjects of Social Work, Management, Economics, English & European Languages, Physical, Life Science and Environment Sciences. Education etc. This MoU will remain in force up

to five years and it can be extended on mutual agreement further.

MoU WITH INFLIBNET

An MoU has been signed with the INFLIBNET to facilitate research scholars of the University to submit their theses into "Shodhganga: A Repository of Indian Electronic Theses and Dissertations", which inter alia, entitled the University to access all resources that UGC may provide either directly to the universities or through INFLIBNET Centre in terms of digitisation of backfiles of theses or access to software tools to deter plagiarism in theses and dissertations. The MoU with INFLIBNET will also facilitate researchers to submit their synopses into "Shodhgangotri: Repository of Indian Research in Progress". In time, ETDs would become more commonplace, grant-giving agencies and accreditation bodies like NAAC and AICTE would make judgements regarding innovative universities by taking note of these initiatives such as ETDs and IRs.

MoU with Terminal Ballistics Research Laboratories

An MOU was signed between the Terminal Ballistics Research Laboratories (TBRL), Chandigarh and the Central University of Himachal Pradesh, Dharamshala to establish cooperative arrangements towards strengthening Indian Higher Education and Research through mutual understanding, exchange of information

and facilities as well as expertise available at CUHP in the School of Physical and Material Sciences and TBRL. TBRL is part of the Defence Research Development Organisation (DRDO) under the Ministry of Defence, GOI. Dr. Manjit Singh, Director, TBRL and the Registrar of CUHP were the signatories to the MOU from either side. This is an effective measure to establish Defence - Academia Partnership for Research and Development as well as for Human Resource Development. This MoU will remain in force up to five years i.e. 2018 and it can be extended on mutual agreement further.

As a part of the MOU, research programmes and conferences of mutual interest shall be taken-up jointly. This agreement enables to launch courses in emerging fields which may be equally useful to TBRL for its ongoing R & D programmes. Such an effort will create opportunities for undertaking research in cutting-edge technologies in critical defence areas. The facilities of TBRL will be extended to carry out research and project work for PG, M. Phil and PhD programmes.

Workshop on Quantitative Analysis

A three-day workshop on Quantitative Analysis and data mining was concluded at Central University of Himachal Pradesh, aimed at enabling faculty members and research scholars to be proficient in the use of various statistical software and develop conceptual clarity of various quantitative techniques in research. It was inaugurated on 23rd April, 2014 by the inspiring and knowledgeable academician Prof. Balkrishan Bali, Former Chairman, School of Commerce and Management at HP University, Shimla. The workshop was organised by the Management Society, School of Business and Management Studies.

Workshop on Case Study and Case Writing

The School of Business and Management Studies organized a three-day workshop on "Case study and Case Writing" conducted by Prof. M.R. Dixit from Indian Institute of Management, Ahmedabad on 31st July-2 August 2014. A total of 50 participants consisting of faculty members and research scholars

of School of Business Management Studies and Tourism and Travel Management attended this workshop. The objective of the Workshop was to equip the participants with the knowledge and skill in writing cases as well as using these cases in their teaching pedagogy to shift them from Teacher Led Teaching (TLT) to a Student Pull Learning (SPL).

Workshop on Time Series Econometrics and Panel Data

A two-day workshop on Time Series Econometrics and Panel Data was organised by the Department of Economics and Public Policy from Sept. 9-10, 2014 for postgraduate students, research scholars and faculty members. Prof. Gurmail Singh, Retired Professor, Department of Economics, Panjab University, Chandigarh was the resource person in the workshop. This workshop enabled participants to understand the theoretical logic behind times series and how predictions and forecasting are done using such time series and panel data sets.

Tourism Week

The Tourism Society of Central University of Himachal Pradesh, Dharamshala celebrated Tourism Week from September 20-27, 2014. The theme of World Tourism Day 2014 was "TOURISM AND COMMUNITY DEVELOPMENT". This was a combined effort of students and faculty members of the School of Travel Tourism and Hospitality Management who organized various events based on the theme. A number of events were organized which included Collage-making competition, Photo Caption Competition, Rangoli Competition, Tree Plantation, Declamation Contest, Workshop on "Community Development through Tourism", Himachal Inter School Quiz competition and National Tourism Quiz. The "Atithi Samman" was also organized on 27th by Tourism Society at various places which include Gaggal Airport, Kangra bus stand, and Dharamshala bus stand.

Workshop on Research Methodology in Social Sciences

The School of Education organised a 10 day ICSSR sponsored Workshop on Research Methodology in

Social Sciences from November 12-21, 2013. This workshop was meant for Ph.D. research scholars with a focus on Research Methodology; and its applicability and suitability within the emerging paradigms of social sciences. The workshop also emphasised upon the limitations of positivist research methods and explored alternatives that are more adaptable to the emerging needs in the research of social sciences. Components of TREAT

Aptitude based test comprising 180 Multiple Choice Questions (MCQs) of 3 hours duration, TREAT shall broadly have the following components. There shall be no negative marking.

- 1. **Verbal Ability:** Intended to test the candidates' understanding of the basic rules of grammar and English usage, this section will cover Pronouns, Misplaced Modifiers, Subject-Verb agreement, Parallel Constructions, Verbs, Quantifiers, Comparatives, Idiomatic Expression, Vocabulary, Synonyms and Antonyms and Sentence Completion.
- 2. **Critical Reasoning:** Intended to assess aspirants' ability to analyze arguments, find underlying assumptions, discern flaws in arguments and ascertain their validity and also to assess aspirants' ability to critically evaluate statements and situations; the questions in this part shall be based on short passages.
- 3. **Reading Comprehension:** Intended to assess candidates' ability to understand and analyze information presented in text and also to assess aspirants' ability to apply concepts and information presented in a passage to parallel situations, in this part, candidates shall be provided one or more passages accompanied by sets of questions.
- 4. **Quantitative Aptitude & Numerical Ability:** This section is intended to assess the quantitative aptitudes of the applicants. Intended to evaluate aspirants' understanding and ability to apply the knowledge of basic mathematical concepts. This section shall have questions pertaining to Functions, Algebra, Coordinate System, Inequalities, Time, Speed, Distance, Ratios and Proportions, Sets, Profit & Loss, Simple and Compound Interest and Elementary Statistics, Central Tendency, Dispersion, Probability, etc.
- 5. **Data Analysis and Data Sufficiency:** Intended to measure candidates' ability to analyze a situation and make decisions based on available data, this section shall have questions based on data given either in a tabular form or in the form of diagrams of different types, this section shall comprise of questions based on Graphs, Tables, Bar-charts, etc.
- 6. **Reasoning and General Intelligence:** Intended to assess aspirants' ability and capacity to draw inferences from various given situations and their ability to use logic and general intelligence, this section will have questions that will require aspirants to use logic to draw inferences and make effective decisions.

Selection Criteria for JRF/NET/SLET qualified candidates and In-service Teachers

- a. The JRF/NET/SLET qualified candidates shall be exempted from TREAT for admission to RD Programmes. For the purpose of calculating composite score, the JRF qualified candidates shall be deemed to have scored 100% marks in the TREAT whereas the NET/SLET qualified candidates shall be deemed to have scored marks equivalent to the marks scored by the topper of that year's TREAT.
- b. Subject to the fulfilment of minimum conditions for admission, a teacher who has been awarded Teacher Research Fellowship by the UGC and is working in any institution of higher education shall be exempted from TREAT and that he/she shall be considered at par with NET/SLET qualified candidates.
- c. Subject to the fulfilment of the following conditions, a person already employed in teaching/research profession shall be exempted from the requirement of appearing in TREAT and shall be treated at par with NET/SLET qualified candidates:

- I. He/she must meet the minimum eligibility condition for admission in the Research Degree Programme
- ii. He/she must have been working as Lecturer/ Assistant Professor/Associate Professor/Professor or in an equivalent position on a regular basis for at least 10 (Ten) years in a state or central university/government or government-aided college/ institution of national importance/ government research institution or laboratory
- iii. His/her application for admission in the Research Degree Programme must have been duly forwarded by the present employer with the undertaking that he/she shall be granted leave to pursue the Programme of Study on full-time basis.
- The cut-off marks for calling applicants for GD/PI shall be 55% of TREAT Score plus Academic Score for general category students and 50% for SC/ST/OBC & Persons with Disabilities categories.
- Subject to the fulfilment of the minimum cut-off marks as prescribed above, candidates equivalent to three times the number of seats in a research area chosen by the applicant shall be called for Group Discussion/ Personal Interview (GD/PI) strictly on the basis of merit.
- 4. Final selection for admission to RD Programme in a research area/discipline shall be made on the basis of merit of the composite score, subject to fulfilment of the minimum cut-off marks that will be 55% of composite score for general /OBC category and 5% relaxation for SC/ST/Persons with Disabilities.

- 3) Application for admission to various RD Programmes can be made in one of the following manners:
 - a) Online Application: A candidate can apply online by clicking on the link given at the University website (www.cuhimachal.ac.in). Application fee shall be payable as per the instructions given on the Website of

- the University.
- b) Hard Copy: In case a candidate is not able to apply online, he/she may download/obtain the application form from the University and send the duly filled-up application form along with a non-refundable Application Fee through DD payable at Dharamshala, District Kangra, HP drawn in favour of Finance Officer, Central University of Himachal Pradesh.
- 4) The application fee for admission to PG/RD programmes for different categories of applicants shall be as under:
 - a) General Category: ₹400/-
 - b) OBC Category: ₹300/-
 - c) SC/ST/PH Categories: ₹100/-
- Last Date for the receipt of Application: duly completed application form for admission in the RD programme must reach the University on or before November 28, 2014
- 6) An applicant can apply only for one RD Programme on an application form.
- 7) Applicants for admission shall be required to indicate his/her specialisation in PG Programme of Study in their application forms. The admission shall be made strictly on the basis of merit in composite score, category and specialisation wise.
- 8) The merit shall be determined on the basis of composite score comprising academic background, TREAT and GD/PI scores.

Admission of The Foreign Nationals/ NRIs/PIOs - Supernumerary Seats

- In all the courses 15% seats may be filled as Supernumerary Seats meant for Foreign Nationals (FN), Non-Resident Indians (NRI) and Persons of Indian Origin (PIO) category. Out of the above 15% Supernumerary Seats, one-third shall be earmarked for the children of Indian workers in the Gulf.
- ii. Candidates belonging to the FN/NRI/PIO category shall not be required to appear for the single common entrance examination of the University. However, they will have to fulfil minimum eligibility conditions for admission. Additionally, they may be required to qualify internationally accepted aptitude tests like SAT/ GMAT/ GRE/TOEFL as prescribed for admission in different Programme of Study as specified in the Prospectus of the University.
- iii. Admission to these categories of students shall be granted on merit determined either by their past academic records or by internationally conducted aptitude tests for admission in higher education or a combination thereof with due regards to need for providing opportunities to the nationals belonging to different countries.
- iv. Candidates seeking admission under the above quota of Supernumerary Seats shall be required to submit their application on a prescribed form, along with the certified

- copies of all the necessary documents, as per the procedure specified in the Prospectus, to the office of the Foreign Students Advisor (FSA) in advance throughout the year but not later than 30th April for the current academic session.
- Application for admission should be submitted to the Dean of the School/Head of the Department concerned along with the attested / certified copies of all the necessary documents.
- vi. Candidates seeking admission under FN/NRI/PIO category shall be required to pay fees and other charges as applicable to their category and as specified in the ordinances relating to fee structure and as notified in the Prospectus.
- vii. Candidates admitted under the FN/PIO category shall be required to undergo a medical test (including test for HIV/ AIDS) within a week from the date of admission.
- viii. Candidates admitted under the FN/PIO category shall be required to produce STUDENT VISA within one month of the date of completion of the admission but prior to the commencement of the academic session and submit a copy of the same in the Office of the Foreign Students Advisor, failing which their admission shall stand cancelled.

Completion of Admission Formalities

- No candidate shall be entitled to claim admission as a matter of right and that the University reserves the right to refuse admission in any individual case without assigning any reason.
- ii) A candidate shall be considered as admitted to a Programme of Study and be eligible to avail the privileges of a student of the University only after he/she has completed all admission formalities including payment of the prescribed fees, as per the Prospectus. If a candidate fails to complete the admission formalities by the prescribed date, he/she will automatically forfeit his/her right of admission.
- iii) List of selected candidates shall be displayed on the University website (www.cuhimachal.ac.in) and on the Notice Boards of the Controller of Examinations and School/Department concerned. No intimation to the selected candidates will be sent by post.
- iv) The candidates shall be required to get their admission completed by the dates given in the Schedule.
- v) The selected candidates shall be required to produce, for verification at the time of interview/ last date for completion of the admission formalities, the following documents in original:
 - a. Certificates, Diplomas, Degrees, Mark-Sheets of all educational qualifications
 - In case of the working students, a No Objection Certificate (NOC) from the employer clearly mentioning that the employer has no objection to the candidate's pursuing higher education in the Central University of Himachal Pradesh on full time basis
 - c. In case of gap between the qualifying examination and the year of seeking admission in the university, the candidate shall be required to submit an affidavit indicating the reasons for such gaps and the activities in which s/he was engaged during the intervening period
- vi) Admission to a Programme of Study will be granted only to those candidates whose results of the

- qualifying examinations are complete in all respects.
- vii) Admission of candidates to a Programme of Study shall be subject to the clearance from the Proctor of the University.
- viii) Admission of candidates seeking admission after a gap of three or more academic years of their taking Certificate/ Diploma/ Degree/ Post-Graduate Degree from this University or any other University/ Educational Institution/Board, shall be subject to the clearance by the Admission Review Committee consisting of the Dean, Students' Welfare (DSW), the Dean of the School concerned, the HOD concerned, and the Proctor.
- ix) At the time of admission, every student shall be required to sign a declaration to the effect that she/he submits herself/himself to the disciplinary jurisdiction of the Vice Chancellor and other authorities of the University.
- x) All the students admitted to Programmes of Study shall be required to submit Transfer Certificate/ Migration Certificate in original within 30 days from the date of admission, failing which their admission in the university may be cancelled.

GENERAL RULES RELATING TO ADMISSION

- The University shall be open to the persons of either sex and of whatever caste, creed, race or class, and it shall not be lawful for the University to adopt or impose on any person, any test whatsoever of religious belief or profession in order to entitle him to be admitted as a student in the University or to graduate thereat or to enjoy or exercise any privilege thereof;
- ii) The University shall maintain an all-India character and high standards of teaching and research and shall admit students strictly on merit as determined through a common national level entrance test conducted by the University either individually or with other universities;
- iii) No candidate, pursuing a full-time programme of study in the University shall be allowed to take up a

job without prior and explicit permission of the University.

- Provided that those already employed at the time of admission shall submit, within thirty days, in original, a certificate from their employer to the effect that the employer has granted him/her leave for the whole duration of the Programme of Study.
- ii. Provided further that the above shall not prohibit, exclude or exempt a student from undergoing obligatory or optional work placement, if completion of the Programme of Study in which he/she has taken admission so requires.
- iv) No student pursuing a Programme of Study in the University shall be permitted to take any other regular examination leading to another degree of this University or any other education institution. However, a student would be eligible to take courses, subject to the prior permission of the Dean of the School concerned, under Career Oriented Proficiency/ Certificate/ Diploma Programmes simultaneously either from CUHP or any other university/educational institution/board, etc.
- Provided further that a student may also be permitted to take additional courses, over and above the minimum prescribed for a semester. In such a case, the following conditions shall apply:
 - a. She/he shall be required to pay fees for the additional courses registered
 - b. Her/his marks sheet would reflect such courses having been studied by him as additional courses
 - The additional courses so taken would not be considered for the computation of total credit for the award of the degree
- vi) Similarly, a person who is not a student of a university and is not registered for any Programme of Study of the university, may, with the prior permission of the Dean of the School concerned, be allowed to register

for select courses of the university subject to the following conditions:

- a. No more than two courses in a semester may be allowed to be taken
- b. She/he shall meet minimum eligibility conditions to pursue such courses
- She/he shall be required to pay a Non-refundable Registration fee of ₹2000/- per semester plus the Tuition Fees twice the rate as applicable to such courses
- d. She/he shall not be considered to be a student of the University and shall, therefore, not be eligible to the privileges of a student of the University. However, she/he shall be subject to the disciplinary jurisdiction of the University authorities
- e. Subject to the successful completion of all credit requirements for the courses so taken, she/he shall be eligible to receive a testimonial from the university indicating the courses that she/he has so attended and qualified. This may however, not entitle her/him to receive any certificate/ diploma/degree of the university
- vii) If at any time it is discovered that a candidate has made a false or incorrect statement or has furnished false or incorrect information or has used any other fraudulent means have been used for securing admission her/his name shall be removed from the rolls of the University
- viii) A student admitted to the University shall be a member either of a Hall of Residence Hostel or Non-Resident Students Centre of the University
- ix) A student admitted to a Programme of Study if detained due to the shortage of attendance in the first Semester, will no longer remain the student of the University. Such students will have to seek fresh admission and will be required to go through the entire admission process
