Dear Participants,

In response to your application/nomination from the Commissioner, College Education, I wish to inform that you have been selected to participate in the **Short Term Course in Physical Education & Yoga** scheduled to be held from **14.09.2015 to 19.09.2015** at Human Resource Development Centre, University of Rajasthan, Jaipur. **Registration will start at 9:00 a.m. on 14.09.2015** at the **UGC-HRDC office, first floor, VC Secretariat, University of Rajasthan, Jaipur.**

Necessary information/guidelines pertaining to the course are given below:-

LODGING: The outstation participants are necessarily required to stay in the HRDC guest house situated on JLN Marg, Behind B-1 Bungalow, near Gandhi Circle.

PAYMENT OF T.A. and D.A.: The T.A will be paid as per UGC rules. Under the UGC guidelines only AC IIIrd railway fare will be admissible to the participants (of all trains) on production of tickets failing this only ordinary class fare shall be admissible. In case of travel by deluxe bus, the production of used ticket would be necessary. D.A. for outstation participants is Rs.400/- per day including Sundays and for local participants Rs.300/- per day excluding Sundays. Lunch and other hospitality is compulsory for all the participants.

IMPORTANT GUIDELINES:

1. Every participant is required to send a letter of acceptance/consent either through e-mail or by post.
2. Every participant shall have to pay an admission/registration fee **Rs.1000/- (non-refundable)** and **Rs.100/- (non refundable)** HRDC Guest House development fee by getting its receipt from the HRDC. **THE DEMAND DRAFT OF RS.1000/- MUST BE SENT FAVOURING DIRECTOR, UGC-HRDC, UNIVERSITY OF RAJASTHAN, JAIPUR. IN THE EVENT OF POSTPONEMENT/CANCELLATION OF THE COURSE, THE DEMAND DRAFT SHALL BE RETURNED. IN THE EVENTUALITY OF NOT JOINING THE COURSE, YOUR REGISTRATION FEE (RS. 1000/-) WILL BE FOREFEITED.**
3. **In case of cancellation/postponement of the course no TA/DA shall be admissible.**
4. The participants will have to remain under the discipline of HRDC. Since the programme involves intensive course work, the participants should come prepared to devote their entire time to the programme. **There will be NO HOLIDAY / CASUAL LEAVE (CL) during the course except on Sundays.**
5. You are requested to bring **three passport size photographs** along with you.
6. There will be compulsory evaluation of every participant as per new UGC rules. The evaluation system will be explained to the participants by the Course coordinator.
7. **This may be noted that gap between two Courses (Orientation/Refresher) must not be less than one year.**
8. **For participants who need to attend the course within a gap of one year to get the benefit of CAS, a certificate stating the same from the concerned authority of the Institution/Directorate is mandatory to submit along with the application form.**
9. **It is also mandatory to submit the original relieving certificate from the concerned authority of his/her institution at the time of registration.**


