MBBS & PG Degree / Diploma from recognized Institute / University approved by Medical Council of India / State Medical Council with 3 years post-qualification experience from a **Hospital / Clinic** in the relevant Speciality. (For Surgery, Medicine & Pulmonary Medicine -minimum qualification is PG Degree only)

Qualification for Post No.1 (b): (as on 04-Mar-15)

MBBS & PG Degree / Diploma from recognized Institute / University approved by Medical Council of India / State Medical Council in the relevant speciality. (For Surgery, Medicine, and Pulmonary Medicine -minimum qualification is PG Degree only).

Qualification for Post No.2: (as on 04-Mar-15)

For Sr. Medical Officers- MBBS from recognized Institute/University approved by Medical Council of India/ State Medical Council with minimum 60% marks in aggregate for General & OBC (Non Creamy layer) candidates and minimum 55% marks in aggregate for SC/ST & PH candidates.

In case grade/ grade point etc. is awarded instead of marks, a certificate from the Registrar of University/ Head of the Institution is to be submitted specifying exact equivalent percentage. Mere range of percentage will not be sufficient for consideration and in that case, application liable to be rejected.

Candidates appearing for their final examination or their results are expected to be declared before the interview schedules are also allowed to apply for the post.

Upper Age Limit: (as on 04-Mar-15)

Post No.1 (a) -35 yrs. for General, 38 years for OBC and 40 years for SC/ST candidates and relaxation of additional 5 years for Physically Handicapped (PH) candidates.

Post No.1(b) & 2 - 30 yrs. for General, 33 yrs. for OBC and 35 yrs. for SC/ST & relaxation of additional 5 years for Physically Handicapped (PH) candidates.

Mode of Selection: Personal Interview

Only Indian Nationals are eligible to apply

For all the posts - Age, Qualification & experience would be as on: 04-Mar-15

Candidates must have completed one year compulsory internship on the date of interview.

Candidates should have obtained Registration No. from Medical Council of India / State Medical Council on the date of interview.

Unless they produce the final result /passing certificate they will not be allowed to appear in the interview.

For Employees of CIL/Subsidiary Company: The employees have to apply through proper channel, however, an advance copy may be sent to this office for on-time submission of their application. There is no **age bar & application fee,** however, they will have to fulfill all other advertised norms at par with outsiders.

Application Fee: General / OBC (NCL) candidates are required to pay non-refundable application fee of Rs.500/- through branches of State Bank of India. SC/ST/PH category candidates are exempted from application fee. The Challan format can be downloaded from our website. SBI will accept the payment from 03-Mar-15. Fee once paid will not be refunded under any circumstances

Others terms and conditions:

- 1. The Post applied for should be very clearly mentioned on top of the envelope.
- 2. In support of age, candidates will have to submit Matriculation / Secondary Board level certificate.
- 3. In support of educational qualifications, percentage of marks & experience, candidates will have to enclose self-attested copy of the relevant mark-sheet / certificates along with application.
- 4. Candidates belonging to OBC (Non-creamy Layer)/SC / ST will have to attach self-attested copy of caste certificate. For PH category, certificate in the prescribed format of Govt.of India duly issued by the competent authority, has to be attached.
- 5. Reservation of posts for OBC (Non-creamy Layer) / SC / ST & PH as per Govt. Directives. The reservation for PH candidates is on horizontal basis.
- 6. Candidate applied for higher post may be considered for lower post in case they fail to fulfill the advertised norms for the higher post.
