#### 1.3] IMPORTANT NOTE FOR ESSENTIAL QUALIFICATION:-

- (i) Diploma should be ofminimum 3 years duration and should be recognized by AICTE. (Six semester marksheet is essential for 3 years diploma)
- (ii) Diploma should be in the prescribed discipline as mentioned in the essential qualification (no equivalency will be acceptable).
- (iii) ITI should be recognized by State Board of Technical Education(SBTE) / National Council for Vocational Training (NCVT).
- (iv) Graduate / Post Graduate Degree, Post Graduate Diploma should be from a University / Institute recognized by UGC/AICTE/AIU.
- (v) Candidates should have acquired qualifications as a regular candidate.
- (vi) Ex-Servicemen have to produce Discharge Certificate at the time of interview.
- (vii) For Persons with Disabilities Certificate should be issued by the Notified Medical Authority. The minimum Degree of Disability for a person to be eligible for any concession / benefits would not be less than 40%.
