- 1. The candidate will have to pay fee for whole year at the time of admission or up to the date notified by the Institute.
- 2. Free structure is subject to modification. Student is required to pay the difference of fee from the retrospective effect if necessary orders for fixation of Fee by Competent Authority is passed accordingly or belatedly.
- 3. Fee will not be refundable under any circumstances.

A separate copy is also given to the student for this purpose alongwith list of Anti Ragging Committee and other related details given to the students.
- 11. It is mandatory for every student to notify his/her full local and permanent address alongwith telephone and/or mobile nos. etc. and subsequent changes if any within 7 days in writing.
- 12. Student/ Hosteller must deposit his/her fee in the college Office only and should obtain the receipt failing which the college will not be responsible. No duplicate receipt will be issued.

#### UNDERTAKING/ DECLARATION IN RESPECT OF RAGGING

#### **Broadly speaking, Ragging is:**

- Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which acuses or is likely to cause annoyance, hardship of physiological harm or to raise fear or apprehension thereof in a fresher or a junior student of asking the students to do any act or perform something which such student will not do in the ordinary course and which has the effect or causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.
- ❖ I we are aware that ragging is a criminal offence. I will not tolerate Ragging I will not indulge in Ragging/ in any form of ragging even in words or intensions.
- Strong legal action will be taken against the guilty, by the Principal of the college, Regsitrar of the University and the Police.
- No act of Ragging shall be tolerated by the Institute hence any act of Ragging shall not go unnoticed and unpunished.
- Ragging is totally banned in the institution and anyone indulging in Ragging is likely to be punished appropriately, which punishment may include expulsion from the institution/university, suspension from the institution or classes for a limited period or fine with a public apology. The punishment may also take the shape of: (i) withholding scholoarships or other benefit. (ii) debarring from representation in events and campus recruitments (iii) withholding results (iv) suspension or expulsion from the hostel or mess. (v) an entry of activities/involvement of ragging and punishment awarded in the certificates to be issued by the institution and other authorities besides general conduct and behavior and the like.
- Collective punishment could be resorted by the Institute/ University/ Police and any other authorities against raggers if individuals committing or abetting Ragging are not identified.
- ❖ A printed Leaf-let detailing the names/ address and telephone nos. of the members of Anti Ragging Committee/ Proctorial Committee is also enclosed to enable the students to turn for information help and guidance for various purposes.
- These guidelines are only illustrative and are not intended to come in the way of the institution and authorities devising ways and mens to curb ragging if there are legislation governing Ragging or any provisions in the statue/ ordinances or local laws governing Ragging. They shall also be followed by me/us.
- ❖ I have gone thorough the above carefully and hereby undertake to follow the same in toto. Any violation/indulgence in the ragging will tantamount to punitive action as per law for which the sole responsibilities lies on me/us.
