Allotment of posts to the candidates has been done as far as possible, in order of their preference given, subject to merit and vacancy position. The allotment is purely tentative.

In order to take care of the shortfall in the formation of the original panel, the number of candidates being called for document verification is 30% more than the actual number of vacancies (wherever such number of candidates is available). It is also made clear that merely calling a candidate in the Main List or in the Wait List for document verification does not in any way entitle him/her for final empanelment/appointment on the Railways. The candidature of all the above mentioned candidates are purely provisional and subject to correction/amendment arising out of their entitlement and eligibility in all respects for which the administration reserves the right to rectify the error at any stage from empanelment to appointment, and even after appointment.

Candidates are required to attend the office of Railway Recruitment Board/Jammu as per dates of document verification indicated above, with their original certificates and marks sheets (semester wise, year wise) of educational/technical qualification, caste certificate, proof of age, J&K resident to bring original state subject certificate etc. and also their Photostat copies attested by a Gazetted Officer, for verification. Even if any of the above candidate does not get letter for document verification he/she must also attend this office for document verification as per above schedule. The candidates belonging to OBC community should bring original caste certificate in the prescribed format of the Central Government, issued for the current year and valid on the date of verifications of certificate, the caste certificates should be current and should have clause of non creamy layer. Candidates should come with all the documents in original. Candidature of those candidates shall stand cancelled/rejected if it is found during document verification that they do not posses the requisite qualifications or failed to satisfy the eligibility criteria.

Though the letters to individual candidates are being sent through speed post but RRB will not be responsible for the postal delay or wrong delivery, if any.

While every care has been taken in preparing the result, the possibility of inadvertent errors can not be ruled out. The Board do not take responsibility for such errors and reserve the right to rectify the same at later date.
