1. JAMIA MILLIA ISLAMIA

Jamia was established in 1920 by a group of Nationalist Muslim intelligentsia like Maulana Mohammed Ali Jauhar, Shaikhul Hind Maulana Mahmoodul Hasan, Hakim Ajmal Khan, Shri A.M. Khwaja, Dr. Mukhtar Ahmad Ansari, Dr. Zakir Husain and other such luminaries, at Aligarh (Uttar Pradesh) in the wake of the anti colonial activism signified by the Khilafat and the pro independence aspirations symbolized by the non cooperation movement of the Indian National Congress which helped to harness creative energies and the subsequent making of Jamia Millia Islamia. Its campus shifted from Aligarh to Delhi in 1925 and the foundation stone of the present campus was laid on 1st March 1930. Since then, the university has expanded and become known as a premier educational institution of the country. Recognizing its contributions in the field of teaching, research and extension work, the University Grants Commission (UGC) bestowed the "deemed university" status to it in 1962. The Jamia was made a Central University by an Act of Parliament in 1988 vide Jamia Millia Islamia Act 1988 (No.58 of 1988). The Degrees/Diplomas/ Certificates offered by Jamia Millia Islamia, are recognized by all the members of the Association of Indian Universities(AIU) and are at par with Degrees/Diplomas and Certificates of all Indian Universities, Deemed Universities and institutions. Subsequently, the National Commission for Minority Educational Institutions on 22 February 2011 granted "Minority Institution" status to Jamia Millia Islamia under Article 30(1) of the constitution read with Section 2(G) of the National Commission for Minorities Institutions Act.

Jamia reflects the original concern of its founders, which was to encourage the indigenous roots of education. It has cherished and has continued to encourage a critical appreciation of the country's history and culture and also the history of Islam with its rich cultural and intellectual traditions. It seeks to foster a national and cosmopolitan perspective in its academic programmes as well as in cocurricular activities. From its inception, the Jamia had catered to students from disadvantaged backgrounds and its course curriculum was suited to meet the needs of such students. The medium of instruction and learning has been Urdu, Hindi and English. The university was an active participant in spreading Gandhiji's idea of naitalim. Vocational training and school education became one of the cornerstones of Jamia education and models for innovative teaching.

Today, Jamia Millia Islamia is an "A" grade Central University accredited by NAAC and is an ensemble of a multi layered educational system which covers all aspects of schooling, under graduate and post graduate education. The university recognizes that teaching and research are complementary activities that can advance its long term interest. It has Natural Sciences, Social Sciences, Engineering & Technology, Education, Humanities & Languages, Architecture & Ekistics, Fine Arts, Law and Dentistry Faculties. Also, it has a well known AJK Mass Communication Research Centre. Jamia Millia Islamia has over thirty research centres that have given an edge to Jamia in terms of critical research in various areas. Some of these are Centre for Peace and Conflict Resolution; Academy of International Studies; Centre for Culture, Media and Governance; Centre for Dalit and Minorities Studies; Centre for Nanosciences and Nanotechnology; FTK Centre for Information Technology; Centre for Management Studies; Dr. K.R. Narayanan Centre for Dalit & Minority Studies; Centre for West Asian Studies; Centre for Physiotherapy & for Theoretical Physics; Centre for Interdisciplinary Rehabilitation Sciences; Centre Research in Basic Sciences, etc.

2. CENTRE FOR DISTANCE AND OPEN LEARNING (CDOL)

The Centre for Distance & Open Learning was established in Jamia Millia Islamia with the assistance of Distance Education Council in September 2002. Major objective of the Centre is to provide opportunities for higher education to those who are not able to draw benefits from formal system of education. The Open Learning System allows a learner to determine his /her pace of learning and provides education at the doorstep of the learner. The mode of transaction is through self-learning print material, supplemented by audio and video programmes. It has further scope of students accessing material through internet and various other media. The Centre started functioning in the session 2002-2003. The Centre for Distance and Open Learning was approved by Ministry of Human Resource Development, Govt of India in 2009 and all the programmes running by the Centre for Distance and Open Learning are recognized by joint committee DEC,AICTE,UGC/ NCTE. The Centre has established 62 study/programme centres. These centres are located at various places in Delhi, UP, Punjab, Haryana, Bihar, Karnataka, Tamil Nadu, Kerela, Assam, West Bengal, Jharkhand, Maharashtra and Manipur.

The Centre also runs an Urdu Certificate Course. Its purpose is to teach Urdu by means of different languages (Hindi & English) through distance mode. This certificate programme is offered free of cost. But the candidate shall remit Rs. 100/- through Postal Order to meet the Postal Charges for the dispatch of books and correspondence. Candidates from outside India should send an amount equivalent to US\$ 20 in case of SAARC nations and US\$ 50 in case of countries other than SAARC by bank draft drawn in favour of "Jamia Millia Islamia" payable at "New Delhi". The admission is open throughout the year for the Urdu Certificate Course.

- **2.1 INSTRUCTIONAL SYSTEM:** The distance education programme delivery system includes the multi-media approach, i.e., self-learning print material, audio/video components, assignments, counselling sessions, practical work and workshops.
 - **2.1.1 Study Centre:** It is the contact point for the student. All the important communications are sent to the Programme coordinator / Incharge of the study centre. A copy of important circulars /notification will be displayed on the notice board of the study centre so as to get the latest information about the assignments, submission of the examination forms, datesheet, list of admitted students and declaration of result etc.
 - **2.1.2 Printed Material :** The print material is in the form of self-instructional material for both theory and practical components of programme. It is supplied to each student in the form of blocks. Normally each block contains 3 5 units, and each programme consists of 3-5 blocks of Print Material.
 - **2.1.3** Audio and Video Programmes : The Audio and Video programmes are supplementary, meant for clarification and enhancement of understanding in various courses of the programme. These are used during counselling and workshop sessions at the study centres.

2.1.4 Distribution of Study Material :

The University gives study materials and assignments to the students. For non receipt of study material, students are required to write to the Hony.Director, CDOL, JMI where they stand enrolled/admitted.

2.1.5 Counselling Sessions : Generally the counselling sessions will be held at the study centres during Sundays and long holidays. Within the general schedule of the programme, the coordinators at the study centres will decide on the coverage of these sessions. The study centre coordinator will also provide the counselling schedule. The counselling sessions will include clarifications required in the print material and other related difficulties through active interaction with students. Attending counselling sessions is optional.



2.1.6 Medium of Instruction for Counselling, Assignment and Term-end-Examination: The Medium of instruction for counseling, assignments and term-end-examinations in most of the programmes (except BAG, DECCE) run by CDOL is English only. The printed self learning material, assignment s and term-end-examination papers in these programmes will be available in English only. However students can attempt their assignments and term-end-examination papers in Hindi and Urdu also.

The Medium of instruction for counseling, assignments and term-end-examinations in few programmes BAG, DECCE is English and Hindi both. The printed self learning material, assignments and term-end-examination papers in these programmes will be available in English and Hindi both. However students can attempt their assignments and term-end-examination papers in Urdu also.

2.1.7 SMS Alert Service: The CDOL has an SMS Alert Service, wherein a student gets connected with the Centre by receiving / sending messages. SMS Alert Service has the uniqueness that the student gets updates regarding academic activities related to his/her programme. However the students are advised not to be fully depended on SMS rather be in touch with your study centre or CDOL, Jamia Millia Islamia, New Delhi.

2.2 EVALUATION SYSTEM

The system of evaluation at CDOL, Jamia Millia Islamia contains ;

- (i) Theory / Practical Assignments
- (ii) Dissertation/Workshop / Project Work / Practical/Viva (wherever applicable)
- (iii) Term-end-Examination

All the above are compulsory components for a learner of each programme (wherever applicable) to successfully complete the programme.

- **2.2.1 Term End Examination:** The University conducts Term-End-Examination once in a year and the student is advised to take his/her examination at the end of each academic year. The examination will be conducted at various Study / Examinations Centre or any convenient place as decided by CDOL in May / June every year.
- **2.1.2** Theory / Practical Assignments: Assignments are an integral and compulsory component of the instructional system. There are tutor-marked assignments for each theory programme. The students will have to work on specified number of assignments per programme. These assignments are to be submitted at the study centre in accordance with the submission schedule provided by the Programme Coordinator / Incharge of the respective Centres.
- **2.1.3 Dissertation / Workshop/ Project / Practical / Viva:** In some programmes students are required to do dissertation / Project / Practical etc (wherever applicable) as part of their course work. These activities enable the students to have a practical exposure and in field experience. The viva-voce (if any) is held so that the learner may defend the practical activity that he/she has done during his/her dissertation/project/practicals.

- (ii) There is no provision of nomination on any seat by any authority of the Jamia and no application/ request shall be entertained in this regard.
- (iii) Jamia reserves the right to make any change / modification in the provisions made in this Prospectus and the same shall be duly notified and published. The candidates shall not be informed of any such change individually.
- (iv) No candidate shall be entitled to claim admission as a matter of right.
- (v) Admission to any programme of CDOL may be cancelled, at any stage, if any information furnished by the candidate is found to be incorrect or if a candidate has been wrongly admitted due to any reason.
- (vi) Application Forms will be accepted during working hours (except lunch hours) on all working days. The office of the CDOL, JMI remains closed on Saturday, Sunday and holidays recognized by the Jamia Millia Islamia.
- (vii) Candidates are strongly advised to regularly check the University website (<u>http://jmi.ac.in</u>) for admission related notices and other information. Few important URLs on the University website may please be seen (Page No 44).

4 **GUIDELINES FOR ADMISSION**

- (i) List of provisionally admitted candidates shall be displayed on the Notice Board of the concerned Study Centre and CDOL, JMI as well as on the Jamia's website.
- (ii) If a candidate fails to complete the admission formalities by 20th October 2015 date, he/she will automatically forfeit his/her right of admission.
- (iii) If a candidate intentionally or otherwise marks multiple categories for his/her candidature or does not mark any category, JMI shall consider such candidates as **"General"**.
- (iv) The candidate must have passed the qualifying examination from a board/university/institute recognized by JMI. Jamia Millia Islamia recognizes degrees of all central universities, state universities, institutions of national importance and foreign universities, provided that their equivalence has been established by the Association of Indian Universities (AIU). Besides, the university also recognizes certain qualifications from reputed madarsas, the details of which are given in (Pages 43) of the prospectus.
- (v) Write complete mailing address (in CAPITAL LETTERS only) with Postal Pin Code and contact Telephone/Mobile No. in the Application.
- (vi) Passport size Colored photographs
 - Passport size colored photographs with full face front view displaying all facial features taken within last three months.
 - The applicant should not look down or up or to either side, in photo.
 - The candidate should take photograph without Cap or Spectacles/Goggles/Sun Glasses etc.
 - The photograph should not be attested.
 - Blurred photograph or photograph with dark, hazy, or patterned backgrounds will not be accepted.
 - Please paste the photograph firmly in the space provided and do not attach with staple or clip etc.
- (vii) For downloaded forms, candidates are advised to enclose a Demand Draft / Pay Order in favour of "Jamia Millia Islamia" payable at "New Delhi." along with the downloaded form. It should be of the appropriate amount as given in the Table-I on Page No. 06. The candidate must write his/her name and number of his/her application form at the back of the Draft / Pay Order.



- (viii) **Policy on pursuing two or more programmes simultaneously** : Two Degree Programmes cannot be allowed to be pursued simultaneously according to the UGC guidelines. However, a student can pursue two programmes simultaneously through distance mode or combination of distance and regular modes from the same or different Universities / Instructions in various combinations,. Viz.,
 - (a) One Degree and One Diploma / P.G. Diploma / Certificate
 - (b) One P.G. Diploma and One Diploma / Certificate
 - (c) One Diploma and One Certificate
 - (d) Two P.G. Diplomas
 - (e) Two Diplomas
 - (f) Two Certificates

Pursuing two academic **Degree Programmes** either from the same University, or one from the Open University (under ODL mode) and the other from Conventional University (regular or face-to face mode) is not permitted, as of now, except Certificate/Diploma/PG Diploma programme.

4.1 How To Obtain Application Form

Admission at CDOL, JMI is simple and easy. Centre for Distance & Open Learning, JMI is starting the policy of 'spot admission' which means that one can apply for admission in July every year and get provisional admission on the same day. Application forms are available online, at Maktaba Jamia and at Study Centres also. Filled-in application forms can be submitted at the Centre for Distance & Open Learning JMI, or its study centres concerned during the admission period.

- (i) Candidates seeking admission to any programme at CDOL for the academic session 2015-2016 may obtain the prescribed Application Form along with the Prospectus from the Study Centre or from the Maktaba Jamia Ltd., Jamia Millia Islamia, New Delhi on cash paymen. The cost of the prospectus along with the application form for various programmes is given in the Table above.
- (ii) The application form may also be downloaded from the official website of Jamia <u>http://www.jmi.ac.in</u> and submitted along with the prescribed fee as mentioned above. Only web downloaded Application Forms with the Inscription "JMI-WADF-2015" will be accepted, not the photocopies.
- (iii) The Application Form and Prospectus may also be obtained through post by sending a crossed Demand Draft of Rs. 500/- drawn in favour of "Jamia Millia Islamia" payable at "New Delhi" clearly indicating the name of the programme for which the Application Form is required along with a self-addressed envelope of 30x25 c.m. size affixing postage stamps worth Rs.150/-
- (iv) The request for sending a set of Application Form and prospectus should be addressed to The Hony. Director, Centre for Distance and Open Learning, Jamia Millia Islamia, Arjun Singh Block, Maulana Mohammed Ali Jauhar Marg, New Delhi - 110025

4.2 Submission of Application Forms and Compeletion of Provisional Admission

The candidate seeking admission is required to :

- Go through the Prospectus carefully.
- Satisfy the eligibility requirement for the programme applying for
 - The eligibility of the candidate for the Programme will be checked at the time of admission. However, it shall be the sole responsibility of the candidate to ensure the eligibility at the time of submission of application form. No claim of any sort in this matter shall be entertained at any stage



- Fill in application form, duly self attested, complete in all respect should be submitted in person, in the office of the Hony. Director, Centre for Distance and Open Learning, Jamia Millia Islamia, New Delhi 110025, on or before the last date of submission or at your nearest study centre chosen for verification & provisional admission.
- Produce the relevant documents in original as well as self attested photocopies and original affidavits at the time of completing the admission formalities.
- Submit the 1st year programme fee by Demand Draft drawn in favour of "Jamia Millia Islamia" Payable at "New Delhi"

For JMI, Delhi & NCR study centres submission, verification & admission will be done at CDOL, JMI. For outside Delhi & NCR the same will be done at respective Study Centre.

4.3 Documents required at the time of admission; a check list

- (i) Three Passport Size Photograph
- (ii) Certificates in support of your educational qualification(s), age, attach marks sheet as proof.
- (iii) Experience certificate wherever required.
- (iv) Category certificate (for Muslim OBC/ST (non-creamy layer) Minority candidates).
- (v) Character Certificate from the Institution last attended.
- (vi) Migration /Transfer Certificate in original from the institutions last attended (in case of Masters and Bachelors Programmes) must be submitted within 60 days from the date of admission, failing which the admission of the students is liable to be cancelled.
- (vii) Demand Draft for the Programme Fee for the first year with your name, programme code and application number written on the reverse of the Demand Draft.
- (viii) Students of Jamia Millia Islamia have to submit documentary proof for enrollment number if allotted earlier by Jamia Millia Islamia.
- (ix) No Objection Certificate from the present employer wherever required
- (x) Candidates shall be required to submit an affidavit on Rs. 10/- Non Judicial Stamp Paper, certified by a first class Magistrate assuring not to indulge in any form of ragging or undesirable activities, in a format obtainable from the office of the Department/ Faculty/Centre concerned.

4.4 Rejection of Application Form

Jamia Millia Islamia reserves the right to reject the application form(s)/cancel admission on account of any of the following:

- (i) The application forms with different photographs/ Xerox copies of photograph or the photograph not confirming the prescribed specification,
- (ii) If a candidate seeks admission in more than one degree programmes violating the UGC policy on pursuing two or more degree programmes simultaneously. (Page No. 8)
- (iii) Incomplete application form (s),
- (v) if any information furnished by the candidate at the time of admission is found to be incorrect.
- (vi) If a candidate fails to submit his/her result/certificate of the qualifying examination(s) or fails to complete any of the other admission formalities by the last date of submission of application form as notified by the CDOL.
- (vii) Application Form given on any format other than the one prescribed for the programme is liable to be rejected. Application Form not supported by the requisite Demand Draft will be summarily rejected
- (viii) Overwriting, cuttings, erasing in the application form and incomplete form may lead to rejection of the form.

5. COMPLETION OF ADMISSION FORMALITIES

(i) A candidate seeking admission for a programme if eligible should bring his/her original documents for verification at the time of admission. The candidates will be considered "Provisionally Admitted" only after the payment of the prescribed fee and verification of documents on or before the last date given in the admission schedule.



- (ii) The candidates seeking admission to a programme should ensure that the Demand Draft pertaining to the fee of a programme is attached to the Application From.
- (iii) Provisional admission may be offered to candidates whose final year results are not declared till the cut of dates mentioned in the prospectus provided they submit their marksheets on or before the last date of admission.
- (iv) The verification of candidates and their documents shall be done by the Office of the CDOL at the time of completion of admission process or at the Study Centre chosen by the candidates.
- (v) The Re-verification process of students admitted in various Programmes shall be done at the Head office, Centre for Distance & Open Learning, Jamia Millia Islamia, Maulana Mohammed Ali Jauhar Marg, Jamia Nagar, Okhla, New Delhi. In case of any discrepancy, appropriate police/criminal action shall be taken against the erring students.
- (vi) The original certificates will be returned after verification. However, if required, CDOL may seek the documents at any time later.

5.1 Identity Card

Identity Card will be issued only to students whose admission is completed in all respects (after the process of verification) by the Hony. Director, Centre for Distance & Open Learning, Jamia Millia Islamia, New Delhi. The students should produce three-passport size photographs along with the prescribed form for the issue of Identity Card at the time of verification.

In case of loss of Identity card the student has to submit a copy of the FIR and a demand draft of Rs. 200/- in favour of Jamia Millia Islamia payable at New Delhi.

6 **PROGRAMME FEE**

Rules regarding Fees

- (i) The programme fee (as shown in Table No.1 Page No. 06) has to be paid at the time of submission of Application Form.
- (ii) The programme fee should be paid only through <u>a Demand Draft</u> in favour of <u>'Jamia Millia</u> <u>Islamia'</u>, payable at <u>'New Delhi'</u>. Please write in capital letters your name and the programme to which admission is sought at the back of the Demand Draft / Pay Order.
- (iii) Part- payment is not allowed, except in those programmes for which already notified in the prospectus.
- (iv) Programme Fee once paid will not be refunded. It is also not adjustable against any other programme of this University. However, in case of cancellation of admission, the programme fee will be refunded after deduction of processing fee within 30 days from the date of admission. 80% of the total fees may be refunded, if any, through A/c Payee Cheque only. No relaxation in days will be admissible. The candidate would be admitted at a study centre if there are sufficient numbers of admission seekers in a programme. However, if there are not adequate number of admission seekers at a study centre, students may be given the following options
 - may be admitted at other study centre where there are sufficient number of admission seekers available if he/she whishes to do so.
 - may change the programme at the same study centre, fees will be adjusted.
 - may withdraw his /her admission, 100% programme fees will be refunded.
- (v) In case a provisionally admitted student is unable to submit the documentary evidences in support of the eligibility for the programme by the last date of admission of that particular programme, all fee deposited by him/her shall be forfeited.
- (vi) The student who has paid his/her programme fee will be given a roll number, which will also be mentioned in the Identity Card. The enrollment number and the roll number thus allotted will continue for the maximum period allowed for the programme or until the Programme-work is over, whichever is earlier. The number will change only if one registers afresh for the same programme .The enrollment number does not change if one seeks deferment.
- (vii) Old students shall pay the fee as per prospectus issued for the current academic session or they will be informed by the office.



7. POST ADMISSION GUIDELINES

- (i) The admission of a candidate will not be deemed to be complete unless he/she has an Identity Card issued by the Centre for Distance & Open Learning, JMI . Admission is liable to be cancelled, if a student does not have a valid Identity Card issued by the CDOL, JMI.
- (ii) A student shall not ordinarily be allowed to change the optional subject (s) of a Programme (if any) unless the same is applied for and permitted by the CDOL. Such applications should be submitted to the Hony. Director, CDOL, JMI.
- (iii) Students are advised to collect Programme Guide for the current academic session from the office of CDOL or Study Centre. The Programme Guide contains academic calendar and other important rules related to counseling, assignment, examinations, detailed syllabus.
- (vi) Students who are already enrolled in a programme of one year or longer duration can also simultaneously register themselves for any Certificate/Diploma/PG Diploma programme (page no. 8). However, if there is any clash of dates of counselling or examination schedule between the two programmes taken, the University will not be in a position to make adjustments.
- 7.1 Change of Optional Course : Change in Optional Course is permitted after the receipt of Self Learning Material on payment of Rs.1500/-. Payment should be made by way of a Demand Draft drawn in favour of "Jamia Millia Islamia" payable at "New Delhi" All such requests for change of Optional Course should be addressed to the Hony. Director, CDOL, JMI
- **7.2 Change of Medium (wherever applicable) :** Change of Medium of the Self Learning Material is permitted on payment of Rs.1000/-. The Payment should be made by way of a Demand Draft drawn in favour of "Jamia Millia Islamia" payable at "New Delhi" All such requests for change of Medium should be addressed to the Hony. Director, CDOL, JMI.

7.3 Correction/Change of Name/Surname of Student

Spelling mistakes, if any, committed at the time of data entry stage will be rectified at the Study Centre and corrected data transmitted to CDOL,JMI for updating in the database. However, students are expected to write their correct name (as indicated in the High School Certificate) in the Admission Form. In case any change in the name (other than the one mentioned in his/her High School Certificate), it is mandatory for the prospective learners to furnish legal evidence of having changed his/her name/ surname while submitting the admission form.

8. RESERVATION OF SEATS

For liberal programme, ordinarily there is no limit to the number of seats available. However, the number may be limited by the infrastructure capacity of the study centre.

8.1 General Guidelines

- (i) Seats in various programmes shall be reserved or special provisions be made for certain categories of candidates, and procedure to be adopted for purpose of admission as per details given below or as may be decided from time to time by the Majlis-i-Talimi (Academic Council) of Jamia Millia Islamia.
- (ii) Candidates seeking admission under the reserved categories shall be required to fulfill the prescribed eligibility conditions of the Programme.
- (iii) If a reserved category candidate qualifies the Entrance Test for admission under the General category, he/she shall be considered under the General category as well as the claimed reserved category.
- (iv) The relaxation in the minimum prescribed percentage of marks in the qualifying examination for admission to a Programme shall be permissible only in one of the categories.
- (v) A candidates can apply for reservation under ONE category only.



8.2 Muslim Minority

Vide Judgement dated 22.2.2011 in Case No. 1443 of 2006 (along with connected petitions), the Jamia Millia Islamia has been declared a Minority Educational Institution under Article 30 (1) of the Constitution of India read with Section 2 (g) of the National Commission for Minority Educational Institutions Act by the Commission. As a consequence thereof, the University shall provide for the following reservations:

- (i) 30% of the total number of seats in each Program shall be earmarked for Muslim applicants.
- (ii) 10% of the total number of seats in each Program shall be earmarked for Women applicants who are Muslims.
- (iii) 10% of the total number of seats in each Program shall be earmarked for "Other Backward Classes" (OBCs) and Scheduled Tribes who are Muslims, as per the list notified by the Central Government.

Note:

- The reservation for Muslim OBC candidates will only be applicable to the candidates belonging to "Non-Creamy Layer". All such applicants are required to submit an OBC (Central Government List) certificate from the competent authority, format of which is available on http://ncbc.nic.in/backwardclasses/index.html.
- If seats remain vacant in any program from amongst the 10% of the total number of seats earmarked as per Para 8.2 (ii) and (iii) above, such vacant seats shall stand transferred to the category (i) of above, i.e., Muslim applicants.

8.3 Persons with Disabilities

3% seats in all Programs in Jamia Millia Islamia shall be reserved for physically challenged persons in accordance with the provisions of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 under the following categories (to the extent of 1% each, and interchangeable intra in case of non availability of eligible applicants):

- (i) Blindness/low vision;
- (ii) Hearing impairment;
- (iii) Locomotor disability or cerebral palsy.

Candidates under these categories will be given relaxation to the extent of 5% marks in the qualifying examination.

Unless and otherwise provided, only such candidates shall be considered under this category who are suffering from not less than 40% of disability as certified by a competent medical authority.

8.4 Internal (Jamia) Students

5% seats in all Undergraduate Degree/Diploma/Certificate Programs shall be filled by internal students of Jamia who have passed their qualifying examination (X or XII) from the Jamia Schools as regular students, subject to the condition that such applicants must have been on the rolls of the School (s) for a continuous period of four years; Provided that the qualifying condition of four years on the rolls of Jamia School (s), as envisaged in Para 8.4 herein above, shall not apply to the students who have secured admissions in the said schools prior to <u>10-05-2011</u>. Provided further that the candidate claiming Jamia category shall submit a certificate to this effect, along with the Application Form, issued by the concerned Jamia School (s).

Note: Students permitted to appear in various examinations of Jamia as Private Candidates/ Distance mode, shall not be entitled for consideration under the Internal (Jamia) category.

9 **RESERVATION AND RELAXATION UNDER SPECIAL PROVISIONS**

9.1 Kashmiri Migrants

(i) Kashmiri migrants are required to apply and go through the entire admission process. Their admission will be considered over and above not exceeding 5% of the total seats in the program and not exceeding one seat in programs.



(ii) The candidates seeking admission under this category will be required to submit a certificate in support of their claim of being Kashmiri migrants obtainable from the registered Divisional Commissioner, Govt. of NCT of Delhi, New Delhi.

9.2 Foreign Candidates Under General Category

- (i) Candidates of foreign origin may apply under General category only apart from applying against supernumerary seats (Please see Section 10.2). Admission of such candidates shall be subject to the laid down eligibility conditions of the concerned programme and their position in the merit list of the entrance test and other components of the entrance test, wherever applicable. Provided further that the number of such candidates shall not exceed 10% of the regular seats.
- (ii) The process of admission for foreign candidates applying under General category shall be same as of general category students. However, the program fee shall be as mentioned in section 10.4

9.3 Outstanding Players

Seats in various programems shall be reserved or special provisions be made for outstanding players and procedure shall be adopted for the purpose of admission as per details given below or as may be decided from time to time by the Majlis-i-Talimi (Academic Council).

- (i) The Office of the Director, Physical Education may be contacted for any admission related queries.
- (ii) At the time of submission of admission form under sports category, a trial slip containing the photograph of the player shall be issued which the candidate must bring at the time of the trial.
- (iii) Relaxation to the extent of 5% of marks in aggregate or in the subject concerned, as the case may be, will be given to such candidates.
- (iv) Such candidates shall be considered for admission by the Shaikhul Jamia (Vice-Chancellor) over and above the seats allotted to each course on the recommendation of the Games & Sports Committee.
- (v) All candidates selected for admission under sports category shall have to give an affidavit on a Stamp Paper of Rs. 50/- for their conduct/participation in practice/representing the university team on being selected to do so, before they are admitted.
- (vii) All the original sports certificates shall be kept in the custody of Office of the Games & Sports for at least one year.
- (viii) Admission under sports category is limited to the following games: Athletics, Badminton, Basketball, Boxing, Cricket, Football, Hockey, Shooting, Table Tennis, Tennis, Volleyball and Wrestling.

9.4 N.C.C. Cadets

- (i) Relaxation to the extent of 5% marks in aggregate or in the subject concerned, as the case may be, will be given to N.C.C. cadets having the following N.C.C. Certificates for admission to all programs.
 - "A" or "B" Certificate for admission to undergraduate programs.
 - "C" Certificate for admission to postgraduate Programs.
- (ii) Students admitted on this basis shall have to continue in the N.C.C. for at least one year.
- (iii) The relaxation of marks shall be permissible only on production of relevant certificate duly verified by the N.C.C. Officer of the Jamia.

9.5 N.S.S. Volunteers

N.S.S. Volunteers, who have attended two 10-days Special Camps and one National Integration Camp or Republic Day Camp may be provided a relaxation of 2% marks in aggregate or in the subject concerned as the case may be, for admission to all programs. The relaxation of marks shall be permissible on the production of relevant certificates duly verified by the N.S.S. Program Coordinator of the Jamia.



10. ADMISSION OF FOREIGN/N.R.I. CANDIDATES UNDER SUPERNUMERARY SEATS/ICCR SPONSORED APPLICANTS

Jamia Millia Islamia offers admission to ICCR sponsored and Foreign/NRI candidates in various programs.

10.1 ICCR Applicants

ICCR applicants are nominated/ sponsored by Government Of India under various Scholarship Schemes of the Indian Council for Cultural Relations (ICCR). Candidates are advised to contact the nearest Indian Diplomatic Mission for necessary information about these cholarships. Under this category, 5% seats over and above the regular seats shall be offered to them, subject to sufficient infrastructural facilities.

10.2 Foreign Students and NRIs Under Supernumerary Category

Those Foreign Students and NRIs who fulfil the eligibility criteria of the program of their choice but do not wish to appear for the entrance test and interview may be considered for admission under this category. Admission to such candidates shall be given according to the merit list prepared on the basis of marks obtained by them in the qualifying examination.

Applicants seeking admission under Supernumerary Category are advised to send their applications on the prescribed form which can be obtained from the Office of the Foreign Students' Advisor on payment of Rs. 700/- or can be downloaded from the university website.

Under this category, 15% seats may be made available over and above the regular seats out of which 5% shall be earmarked for NRIs (Non-Resident Indians), their spouses, dependent son/daughter inclusive of legally adopted children. Provided that if sufficient number of applicants are not available either in NRIs or Foreign Passport holder (FPH) category, the vacant seats may be filled with applicants from the other category i.e. FPH to NRIs or vice versa.

Foreign Passport Holder (FPH) - An applicant shall be considered a "Foreigner" on satisfying the following terms and conditions: -

- (i) Possesses a valid foreign passport.
- (ii) Possesses a valid visa issued by a competent authority of the Indian Government clarifying the reasons of his/her stay in the country.

Non-Resident Indian (**NRI**) - The term "Non-Resident Indian" shall be as per the Income Tax Law of India. However, not withstanding any amendment in such laws, all rights, obligations and duties flowing from the law and subsisting at the time of submission of application shall be respected and mandated till finalization of the programme applied for.

Save as provided aforesaid NRI sponsored (popularly termed as "NRI SPONSORED CANDIDATES") is NOT PERMISSIBLE in Jamia Millia Islamia.

10.3 General Guidelines and Rules for Admission

- (i) Minimum eligibility qualifications for foreign students will be the same as for Indian students for each program mentioned in the University Prospectus.
- (ii) The program on which eligibility is to be relied upon must be from an Institute included in the list of the Association of Indian Universities (AIU). New Delhi-110002 (http://www.aiuweb.org)
- (iii) In case the University/Board is not included in the said list, the candidate has to obtain and submit an Equivalence Certificate to this effect from the Association of Indian Universities.
- (iv) English translations of all transcripts, duly attested, are to be submitted.
- (v) Candidates applying from their own country should get their transcripts attested by the concerned accredited authorized government agency and also duly certified by the Indian Embassy or Consulate.
- (vi) For candidates applying from India, all attestation must be done by the concerned Embassy/High Commission/Consulate of the relevant country in India.



- (vii) Applications without the attested documents shall be summarily rejected.
- (viii) Applicants must collect their admission letter personally or send their authorized representatives to collect the same from the Office of the Foreign Students' Advisor. Intimation about the admission shall also be sent to the selected candidates through e-mail.
- (ix) On being granted admission, all applicants should produce their Students Visa within one month of completion of admission formalities.
- (x) In case of failure to obtain a visa within the stipulated period, the admission shall stand cancelled. A copy of this visa is to be submitted in the Office of the Foreign Students' Advisor, JMI.
- (xi) The admission of Foreign diplomats wishing to study in Jamia Millia Islamia shall be governed by the prescribed applicable procedures and rules as notified by the Government of India from time to time.
- (xii) All foreign students (old/new) are required to fill a registration form available with the Office of the Foreign Students' Advisor (FSA), JMI, within 15 days of joining the course. Bonafide certificates shall not be issued if this is not complied with.
- (xiii) Upon arrival in India every foreign student must register with the Foreigners Regional Registration Officer (FRRO) within 14 days from the date of first entry into India as per the prescribed applicable procedure.
- (xiv) The category once filled in the application form shall be final and cannot be changed at any later stage.
- (xv) Once admitted, all foreign students shall pay the fee prescribed for their admission category throughout the duration of the program. However, JMI reserves the right to revise the fee at any time.
- (xvi) Once admitted, NRI students will pay the requisite fees for their admission category throughout the duration of the program even if they may not remain NRIs i.e. their status changes from NRI to Non-NRI.


NOTE :

Subject: Equivalence of Degrees awarded by Open and Distance Learning (ODL) Institutions at par with Conventional Universities/ Institutions

Sir/ Madam,

There are a number of Open and Distance Learning Institutions (ODLIs) in the country offering Degree/ Diploma/Certificate programmes through the mode of non formal education. These comprise Open Universities, Distance Education Institutions (either single mode or dual mode) of Central Universities, State Universities, Deemed to be Universities, Institutions of National Importance or any other Institution of Higher learning recognized by Central/State/Statutory Council/Societies registered under the Society Registration Act 1860.

A circular was earlier issued vide UGC letter F1 No- 52/2000(CPP-II) 2. dated May 05, 2004 (copy enclosed) mentioning that Degrees/Diplomas / Certificates/ awarded by the Open Universities in conformity with the UGC notification of degrees be treated as equivalent to corresponding awards of the traditional Universities in the country.

Attention is also invited to UGC circular No F1-25/93(CPP-II) dated 28th 3. July 1993 (copy enclosed) for recognition of degrees and diplomas as well as transfer of credit for courses successfully completed by students between the two types of universities so that the mobility of students from Open University stream to traditional universities/ institutions is ensured without any difficulty.



4. The Government of India, in exercise of its power conferred under section 20(1) of UGC Act 1956, issued directions dated 29th December 2012 entrusting UGC with the responsibility of regulating higher education programme in open and distance learning (ODL) mode. Consequently, Universities/ Institutions desirous of offering any programme through distance mode would require recognition of UGC.

5. As you are aware, the Government of India has envisaged a greater role for the Open and the Distance Education System. The envisioned role may be fulfilled by recognizing and treating the Degrees / Diplomas/ Certificates awarded through distance mode at par with the degrees obtained through the formal system of education. Open and Distance Education System in the country is contributing a lot in expansion of Higher Education and for achieving target of GER, without compromising on quality. Non recognition/ non equivalence of degrees of ODL institutions for the purpose of promotion/ employment and pursuing higher education may prove a deterrent to many learners and will ultimately defeat the purpose of Open and Distance Education.

6. Accordingly, the Degrees/ Diplomas/ Certificates awarded for programmes conducted by the ODL institutions, recognized by DEC (erstwhile) and UGC, in conformity with UGC Notification on specification of Degrees should be treated as equivalent to the corresponding awards of the Degree/Diploma/Certificate of the traditional Universities/ institutions in the country.
