NOTICE INVITING TENDER

Sealed **Item rate** tenders are invited by **Senior Manager Engg (Civil) – II, AAI, Coimbatore Airport** on behalf of Chairman, AAI from enlisted contractors of appropriate class of CPWD / MES / P&T / State PWD / PSUs for the work of **“Grading the area beyond basic strip at Coimbatore Airport SH: Development of RESA on 05 side of the Runway”** for an estimated cost of **Rs. 17.45 Lakhs**. Time allowed **two months**. Tenders will be issued from **29.02.2012 to 01.03.2012** and received till **13.03.2012 up to 15:00 hrs** and opened on the **same day at 15:30 hrs**.

1. Tender forms will be issued to those contractors who produce certificate from clients of having satisfactorily completed (# phase / Part completion of the scope of work in a contract shall not be considered.) at least three works each of **Rs6.98 Lakhs** or two works, each of **Rs. 8.73 Lakhs** or one work of **Rs. 13.96 Lakhs** in general civil works during the last seven years ending on **31.01.2012**. (Firms showing work experience certificate from Non Government / Non PSU organizations should submit 'Tax Deduction at source certificate' in support of their claim for having experience of stipulated value of works), produce proof of annualized average financial turnover of **Rs. 5.24 Lakhs/-** during the last three years ending **31st March, 2011**.
2. Application for issue of tender document shall be submitted up to **28.02.2012** on all working days along with **tender fee of Rs. 525 /- (Inclusive of VAT)** in the form of Demand Draft drawn in favour of Airports Authority of India payable at Coimbatore. The application shall be supported with copies of valid registration, Permanent Account Number (PAN) and client certificate for experience indicating date of completion as per agreement and actual date of completion of work. The financial turnover should be supported with annual report (abridge balance sheet and profit & loss account) and documentary proof of owning, leasing and possessing required machinery and T&P shall be submitted. Tender document will be issued only after verifying the original documents. Time extension shall not be given to produce any documents as sought in this notice. Consortium/Joit Venture companies shall not be permitted.
3. If at any stage, any information/documents submitted by the applicant is found to be false, the agency shall be liable for debarment from tendering in AAI, apart from any other appropriate legal action.
4. Contractors requesting for tender documents by post shall mention the same in application itself. AAI shall not be responsible for delay/loss documents
5. Purchase preference to central public sector under taking shall be applicable as per the directives of Govt. of India prevalent on the date of acceptance.
6. AAI reserves the right to accept or reject any or all applications without assigning any reasons. AAI reserves the right to disallow issue of tender document to working agencies whose performance at ongoing project(s) below par and unusually poor.
