SCOPE OF WORK

Without prejudice to the generality of the responsibilities, liabilities and obligations attached to the project, following shall inter-alia be the responsibilities, liabilities and obligations of the bid participant(s):

- 1. To provide and install Servision MVG 400 on two vehicles as earmarked by the client
- 2. To provide and connect 4 cameras to Servision MVG 400. The cameras shall be able to withstand the wear and tear due to weather and during general usage.
- 3. To commission the solution as mentioned in points 1 & 2 above and bring it online.
- 4. To provide the requisite software, hardware and other such support for smooth functioning of the solution, but excluding any data costs for transmission of data from the vehicle, and will include the warranty for the equipments provided.
- 5. To provide, install and commission the BriefCam Syndex FS solution on one computer as earmarked by the client.
- 6. To provide requisite support and training for usage and maintenance of the software and hardware components as offered in the bid.
- 7. Any other job/support as required by the client from time to time to ensure that the solution is working as per the agreed parameters.
- 8. Provide warranty for a period of 12 months.

OTHER CONDITIONS

- 1. All the prices quoted shall be in Indian Rupees only.
