## RESULT AND MERIT LIST

1. General category candidates shall have to secure a minimum of $50 \%$ marks and the reserved category candidates a minimum of $40 \%$ marks to qualify for admission to a postgraduate medical/dental course. General category physically handicapped student will have to secure a minimum of $45 \%$ for qualifying. Qualifying does not mean admission. Admission will be given according to merit at the time of Counseling.
2. Merit list for only those candidates who have qualified will be declared.
3. Candidates securing minimum qualifying marks (as given above) shall be given ranks according to the total marks obtained. There shall be a combined merit list (with State rank) for all category candidates. The merit rank of reserved category candidates in their respective categories (Category rank) shall also be indicated along with their combined merit (State rank).
4. In case of two or more candidates obtaining equal marks in the examination, their inter-se rank will be determined in order of preference as under :
a. Candidate scoring more marks in Section B.
b. Candidate scoring more marks in Section A
c. According to MBBS entry batch senior will get preference over junior.
d. According to age, older will get preference over younger.
e. If rank cannot be decided by above criteria, then tie shall be decided by toss of coin.
5. There is no provision of re-evaluation. However, there is provision of scrutiny for which candidate may apply within seven days of declaration of result along with a demand draft of Rs.350/- in favour of UPPGMEE-2016 payable at Lucknow, or deposit the same amount in either HDFC Bank A/c no. 50100135781194 , or Allahabad Bank A/c no. 50316825058 and send the scanned copy of deposit slip with the Bank seal affixed.

## DECLARATION OF RESULTS

The result of successful candidates with their combined rank along with category rank will be declared on the website of the University www.kgmu.org. The candidate can see his/her rank and marks on the website. A copy of the result will also be sent to the Secretary, Medical Education, Government of U.P., Director General, Medical Education and Training, U.P. Lucknow, the Principals of U.P. State Medical Colleges, Director RIMS Saifai and Dean Faculty of Medicine, and Dental Sciences, KGMU, Lucknow.

## COUNSELING:

1. Counseling shall be conducted by the Director General of Medical Education Uttar Pradesh. The detailed schedule and details of Counseling shall be announced by the Director General of Medical Education and Training, Jawahar Bhawan, $6^{\text {th }}$ Floor, Ashok Marg, Lucknow 226001 and shall be displayed on website www.updgme.in, after declaration of result, in leading newspapers of Uttar Pradesh. The UPPGMEE Office / helpline shall not be able to provide this information.
2. As per order dated- 18-06-2014 passed by Hon'ble Supreme Court in case of Dr. Fraz Naseem and other V/s Union of India, there shall be THREE COUNSELINGS. Candidates who get seat in 1st and Ind counseling shall also be eligible for second and third counseling for reshuffling of seats with candidates who were either absent or did not opt a seat in the first or second counseling.
3. Candidates are required to bring their application form duly verified by the Dean/Principal of the University/College from where the candidate has done his/her MBBS/BDS.
4. At the time of counseling each candidate is required to:
a. Sign the attendance sheet.
b. Deposit counseling fees of Rs. 800/- through online process. The detailed procedure for online deposition of counseling fee \& Security Money will be intimated at the time of Notification of counseling on the website of D.G.M.E. (www.updgme.in) and Newspapers.
c. Present all the original documents along with one extra photocopy as listed below-
i. Admit Card.
ii. High School certificate as proof of date of birth.
iii. Mark Sheet of all professional examinations.
iv. MBBS/BDS passing out certificate or degree.
v. Compulsory Rotatory Internship completion certificate.
vi. Permanent/Provisional Registration Certificate (U.P. State/MCI/DCI).
vii. Employer's "No Objection Certificate", if employed.
viii. SC/ST/OBC/Physically Handicapped Certificate, if applicable. The OBC certificate must have been issued after 10-12-2015.
ix. Identification certificate as mentioned in the application.
x. Verification sheet of the Principal/Dean of the College/University concerned.
xi. Two photographs attested by Principal with a clear stamp. Photographs must be the same as pasted on the application form.
5. The candidate shall be subjected to Finger Printing, Photographing and analysis of handwriting, which will be compared with those taken at the time of examination. This will be conducted by the examining body. If there are any doubts regarding the identity of the candidate the candidature of the candidate will be cancelled and a report will be lodged with the police and MCI/DCI will also be informed.
6. If found eligible the candidate will proceed to:
a. Submit the Receipt of Security Money of Rs. 30,000/- deposited online in favor of "Director General Medical Education \& Training, U.P.". This will be returned to the candidate after he/she takes admission. The claim for refund of the security deposit will be forfeited if:-
(i) The candidate does not join the course after allotment.
(ii) The candidate resigns the course after admission. This excludes resignation due to re-allotment in subsequent counseling UPPGMEE 2016.
The detailed procedure for online deposition of counseling fee \& Security Money will be intimated at the time of Notification of counseling on the website of D.G.M.E. (www.updgme.in) \& in Newspapers.
b. Candidate will be given registration document and allowed into the counseling hall where he/she shall study the seat matrix displayed on screen in different disciplines/specialties/medical college/medical University. The seat allotment will be done by the Counseling Board on Merit Cum Option basis.
7. Candidates who are applying for "Physically Handicapped Category" are required to submit attested photocopy of certificate on attached proforma (Annexure No. 4), issued by the Medical Board (constituted by Director General, Medical Education and Training, U.P. under chairmanship of Principal / Director, Medical College, Agra /Allahabad/Gorakhpur /Jhansi/Kanpur/ Meerut RIMS, Saifai and Dean, KGMU, Lucknow) of any Medical college on notified dates. Physically Handicapped Certificate issued by any other authority other than above mentioned Medical Board, shall not be entertained. The Disability Certificate shall be issued as per MCI norms.
Claim of Physical handicapped category shall not be allowed if the handicapped certificate is not brought at the time of counseling. Claim for this category shall not be entertained after the last date of receiving the completed application form.
8. Candidate eligible for the reserved category will be given admission as per rules of the State Government, applicable on the date of counseling.
9. Candidates who fail to produce required original documents during counseling or if any, concealment or falsification of facts comes to light at the time will not be entitled to any benefit of having appeared in the entrance examination and/or any benefit of acquiring a seat subsequently.
10. If candidate is absent in the counseling or does not join any course in a college after allotment of the seat by the due date shall forfeit any right of admission on the basis of said counseling/allotment.
11. If a candidate is absent when her/his name is called for counseling and comes at a later time, he/she shall only be considered for a seat from among the seats available at the time of his/her appearance in the counseling.
12. The option once exercised in the counseling cannot be altered under any circumstances.
13. Every candidate who wishes to opt for a seat in the counseling shall present himself/herself before the counseling board. Their representative, through authority letter is not allowed to participate in the counseling.
14. Candidates will be photographed and their identity checked at the time of counseling. If it does not match it will be counted as unfair means and their candidature will be cancelled.
15. In case a sufficient number of seats are left un-allotted at the end of the third round of counseling, then a "mop-up" round of allotment will be organized at a notified date, after due publicity, by DGME, UP. The purpose of the mop up round of seat allotment will be to ensure that there is no loss of PG seats in the current academic year. Seats will be offered to eligible candidates strictly according to their position in the merit list.
The terms and conditions for participation by candidates in this mop up round will be as follows:-
16. Candidates who are admitted/allotted but not joined/resigned in any seat in UP will not be eligible for participation.
17. Any candidate who has taken admission in any PG course in any medical college in India also will not be eligible for participation.
18. The candidate must present himself/herself with all original documents.
19. No request for re-allotment of seats already allotted in the first and second round will be entertained.
20. It will be mandatory for each candidate to furnish, at the time of counseling an undertaking on plain paper, and subsequently at the time of admission at the concerned college a bond, on the prescribed stamp paper (to be informed later). The undertaking/bond is to ensure that in case the student leaves the seat after the 2 nd /final counseling, or at any time during the course of study, leading to a loss of the seat, then the candidate will deposit an amount of Rs $5,00,000 /$-. In case the candidate does not take admission after the last allotment process leading to the consequential vacant seat for the academic session, he shall also be subjected to the deposit of Rs. 5,00,000/-, Failure to comply with terms of the bond will automatically debar the candidate from all future PG entrance examinations conducted by the DGME Uttar Pradesh.

## ADMISSION

1. Admission of the candidate to various P.G. Degree/Diploma course will be given by the Principal/Dean/Director of the respective Medical College/ Institute or Medical/Dental faculty of K.G. Medical University, Lucknow as the case may be.
2. A candidate who has been allotted a P.G. Degree/Diploma course in a particular Medical/Dental College shall have to complete all the admission formalities including depositing the prescribed fees, by the date notified for this purpose by the respective Principal/Dean/Director of Medical College/ Institute or K.G. Medical University, Lucknow as the case may be. Those who fail to do so will loose their claim for admission.
3. Admission shall be given only after the candidate produces, in original and one photocopy each of the following documents at the office of the Principal/Dean/Director of the Medical College / Institute concerned or the Registrar, KG Medical Uníversity, Lucknow, as the case may be
a. High School Certificate as proof of date of birth.
b. Mark sheets of all professional examinations.
c. MBBS/BDS passing out certificate or degree.
d. Compulsory Rotatory Internship completion certificate.
e. Permanent Registration Certificate (U.P. State/MCI/DCI).
f. Employers relieving certificate, if employed.
g. S.C./S.T./O.B.C./Physically handicapped certificate, if applicable.
h. Allotment letter, issued by Chairman of the Counseling Board of UPPGMEE-2016.
i. Admit Card of UPPGMEE-2016.
j. Identification certificate mentioned in the application form.
k. Verification sheet of the Principal/Dean of the College/University concerned.
4. Submission of the bond as mentioned in Point 17 under the heading "Counseling" on page no.15.
5. After the admission process is completed the candidate will submit in writing his/her joining report to the Head of the Department concerned.

After admission: The identity of the student would be established on the basis of his/her photograph, signature, handwriting analysis and finger prints after his/her admission. If the identity of the candidate does not match with that recorded at the time of taking examination it will be treated as impersonation and the Principal of the College/Director of the Institute/ Registrar of the University will cancel the admission of the candidate and lodge a police complaint for impersonation.
