Combined Recruitment for Assistant Grade III (General, Depot, Technical and Account Cadres) in FCI, 2013 - Declaration of final result

Staff Selection Commission conducted examination for recruitment for Assistant Grade III in General, Depot, Technical and Account Cadres in FCI, 2013 on 10th & 11th November, 2012 at various centres all over the country. The result of written examination held on above mentioned dates were declared on 20.12.2012. The written examination of candidates declared qualified for Paper-II and Paper-III for the post of Assistant Grade III was held on 7.04.2013 and its result was declared on 05.09.2013. Total number of candidates declared qualified to the called for Computer Proficiency Test (CPT) was 32,299 (for post code A, B and D) and 12,327 (for post code C).

5. Resolution of Tie-Cases (as per Notice of Examination): If candidates for a particular post have the same aggregate marks in both Paper-I and Paper-II/Paper-III of the Examination then the tie will be resolved by referring to the total marks of Paper-II/Paper-III of the examination i.e. a candidate having more marks in Paper-II/Paper-III will be given preference, wherever such papers are prescribed. If the tie still persists then the total marks in Paper-I of the examination will be referred to i.e. a candidate having more marks in this Paper will be given preference. This procedure will be followed by Date of Birth, i.e., the candidate older in age will get preference. Lastly, if the tie still persists, the tie will be finally resolved by referring to the alphabetical order of names, i.e., a candidate whose name begins with the alphabet which comes first in the alphabetical order will get preference

- 6. The above said lists are subject to fulfilling all the eligibility conditions prescribed for the respective post in the Notice of Examination and also subject to thorough verification of their identity with reference to their photographs, signatures, handwritings, etc., on the application forms, admission certificates, etc. The candidature of the candidates are liable to be cancelled by respective Regional Directors/Deputy Directors in case candidates are found not fulfilling eligibility conditions or any other genuine reasons, including but not limited to resorting to unfair means.
- 7. It is important for the candidates belonging to reserved category for whom certain percentage of vacancies is reserved as per the policy of the Government, to note that some of them may have been declared eligible for the Computer Proficiency Test for the specific category mentioned in the result. It is, therefore, in the interest of the candidates concerned to contact immediately the respective Regional Offices of the Commission in all such cases where they do not belong to the categories shown against their roll numbers. Candidates whose name and Roll No. do not match should also bring such mismatch to the notice of concerned Regional Offices for detailed examination.
- 8. Candidates may note that as per notice of the examination and instructions given in the answer sheets, they were required to code/write their particulars correctly and append their signature/LTI on the answer sheets. Such answer sheets which are without signature/LTI and where particulars such as name, roll number, ticket number and test form number have been coded incorrectly, have been rejected and awarded ZERO marks. The OMR answer sheets of those candidates found possessing mobiles phones & accessories and other electronic gadgets within the premises of examination centers, whether in use or in switch off mode and on person or otherwise have **not been evaluated**.
