1. **Definition:** An “Apprentice” means a person who is undergoing Apprentice training in pursuance of a contract of apprenticeship
2. **No. of seats and Educational qualification:**
A candidate shall be eligible for being engaged as Apprentice Trainee, if he/she satisfies the following minimum educational qualification

3. **Period of Training :** The period of Apprentice training will be limited to one year only.

4. **Age Limit** : The applicant should not be more than 30 years of age and less than 18 years on the closing date for receipt of applications. However, the upper age-limit is relaxable as per standing instructions of Government of India on this subject for SC/ST candidates.
5. **Reservation of seats**: The reservation for candidates belonging to SC/ST category will be as per Rules applicable for the State of Assam.

6. Stipend :

Stipend to the selected Apprentice trainee in the above two categories will be as under :

7. **Employment in BSNL** : The applications invited are only for Apprenticeship and apprenticeship automatically ceases on completion of the stipulated period of training of one year and as such no candidate can claim for employment in Bharat Sanchar Nigam Limited.

8. **Selection Criteria:**

- i) **Candidates must apply in the prescribed form only.** The prescribed application form is included in this advertisement. Legible print out of Application (only on one side of paper) on A4 size paper (30 cms x 20 cms) may be taken.
