## STAFF SELECTION COMMISSION RECRUITMENT OF SECTION OFFICER (AUDIT) EXAM.,2008 DECLARATION OF FINAL RESULT

Staff Selection Commission conducted the Section Officer (Audit) Examination, 2008 on 30.11.2008 at various centres all over the India. Interview of the candidates who had qualified in the written examination were held **in the month of July**, **2009.** Following is the list of 483 candidates, in roll number order (with rank number), who have been recommended for appointment subject to thorough verification of their eligibility conditions in all respects and correctness of the information furnished by them in their applications. Category-wise break-up of the number of candidates recommended for appointment is given below;

2. Result of 17 candidates bearing Roll Number 1212852, 6060014, 5550483, 5011632, 5011768, 5310008, 2010775, 5150100, 5530158, 5151987, 2292452, 6150060, 1218146, 7530146, 1232506, 1219195 and 1218129 have been withheld pending clearance of provisional status from RDs concerned.

3. Maximum and Minimum Marks of the candidate in each category are as under :-

4. Candidates may note that as per notice of the examination and instructions given in the answer sheets, they were required to code/write their particulars correctly and sign answer sheets. Such answer sheets which are without signature and where particulars such as name, roll no., ticket no. and Test Form no. have been written and/or coded incorrectly, have been rejected/awarded 'ZERO' marks.

5. Nomination of candidates and their appointment would depend on the actual number of vacancies available in the user department and also on candidates satisfying various conditions of eligibility prescribed in the Notice of the Examination. Candidates who do not fulfill any condition of eligibility will not be nominated.

6. The lists of recommended candidates are purely PROVISIONAL and subject to the candidates fulfilling all the eligibility conditions prescribed in the Notice of said examination and also subject to, among other things, thorough verification of their identity with reference to their photographs, signatures, handwritings, etc. on the application forms, admission certificates, etc.

7. In respect of candidates belonging to reserved categories for whom certain vacancies are reserved as per the policy of the Government, the category status has been indicated against their Roll Numbers. It is important to note that some of

these candidates have been declared qualified for the category mentioned against their Roll Numbers. If any candidate does not actually belong to the category mentioned against his Roll Number, he may not be eligible to be included in the list. It is, therefore, in the interest of the candidates concerned to immediately contact the respective Regional Offices of the Commission in all such cases where they do not belong to the category shown against their Roll Numbers.

8. Any query/clarification in respect of this result may be sought by the candidates within one month from the date of publication of result in the Employment News/Rojgar Samachar. Thereafter, no correspondence in regard to this result will be entertained by the Commission.
