IMPORTANT INSTRUCTION TO THE CANDIDATES FOR DOCUMENT VERIFICATION

- The candidates must bring the original call letter for document verification along with the upper portion of call letters of first stage (02/09 December 2012) and second stage (18 Aug 2013) written examination/aptitude test (20-24 Jan 2014) /typing test (22 Jan 2014) as applicable.
- 2. The candidates are advised to bring the following certificates (as applicable) in original along with one set of self- attested photocopies.

a. Certificates of Educational qualification and mark sheets.

- Matriculation/Higher Secondary/SSC/SSLC certificate issued by Examination Board in support of Date of Birth.
- c. Cast Certificate in the prescribed format (Annexure 3 of CEN 3/2012) from the competent authority mentioned therein, for SC/ST candidates. OBC candidate should submit the caste certificate in format (Annexure 4 of corrigendum) and self- declaration in format (Annexure 5 of corrigendum).
- d. Medical certificate in format (Annexure 6 of corrigendum).
- e. Discharge certificate (applicable for Ex. Serviceman only)
- f. Physical handicapped certificate (applicable for PH candidates only)
- No objection certificate (Applicable fir serving employees in any Govt. Department. Or PSU including Railways)
- h. Two color photographs, preferably as pasted on application form.
- Minority Community declaration affidavit on non judicial stamp paper. (applicable for minority certificates who have claimed waiver of examination fees- Annexure 8 of 03/2012)
- j. Certificate of Economically Backward Section in format (Annexure 7 of 03/2012)
- Railways Recruitment Board, reserves the right to cancel the candidature of the certificate who fail
 to submit the original certificates as asked for in Para. 2 above.
- If the certificate do not satisfy any condition of the eligibility, the Railways Recruitment Board, reserves the right to disqualify them at any stage of selection.
- SC & ST candidates are eligible for free travel authority for to and fro journey. All other candidates are expected to pay his / her own traveling expenses.
- 6. Candidates are advised to plan for one / two more day(s) stay, if required.
- Candidates who adopt unfair means in the Railways Recruitment Board examination are liable to be disqualified and face legal action as deemed fit.
- 8. The Request for change in the date of Document verification will normally not be considered.

- उम्मीदवार अपने साथ दस्तावेज सत्यापन के मूल बुलावा पत्र के साथ प्रथम चरण (02 एवं 09 दिसंबर,2012) / द्वितिय चरण लिखित परीक्षा (18.08.13) / अमिक्षमता परीक्षा (20–24 जनवरी,, 2014) / टंकण परीक्षा (22.01.14) के बुलावा पत्रों का उपरी भाग अवश्य लाएँ।
- 2. उम्मीदवारों को सलाह दी जाती है कि वे अपने साथ निम्नलिखित मूल प्रमाण पत्र (जैसा लागू हो) साथ ही साथ स्वयं अभिप्रमाणित सभी प्रमाण पत्रों की एक प्रतिलिपि अवश्य लाएँ।

- (x) आर्थिक रूप से पिछड़ा वर्ग के उम्मीदवारों के लिए प्रमाण पत्र (केरोसू क.03/2012 के अनुलग्नक क.7) अवश्य लाएँ।
- 3. यदि उम्मीदवार उपर्युक्त पैरा 2 में दर्शाए गए मूल प्रमाण पत्र को प्रस्तुत करने में असमर्थ होता है तो रेलवे मर्ती बोर्ड ऐसे उम्मीदवारों की उम्मीदवारों को रद्द करने का अधिकार रखता है।
- 4. यदि उम्मीदवार निर्धारित अर्हता की शतों को पूरा नहीं करता है, तो रेलवे भर्ती बोर्ड चयन के किसी भी स्तर पर उसे अयोग्य घोषित करने का अधिकार रखता है।
- 5. अनुसूचित जाति और अनुसूचित जनजाति के उम्मीदवार आने—जाने के लिए मुफ्त रैलवे पास पाने के हकदार है। अन्य सभी उम्मीदवारों को स्वयं यात्रा खर्च वहन करना होगा।

FORM OF CASTE CERTIFICATE FOR SCIST

A candidate who claims to belong to one of the scheduled caste or scheduled tribe should submit in support of his / her claim a self attested copy of a certificate in the form given below from the district magistrate or the subdivisional officer or any other officer as indicated below of the district in which his / her parents (or surviving parents) ordinarily reside and who has been designated by the State Government concerned as competent to issue such a certificate. If both the parents are dead, the officer signing the certificate should be of the district in which the candidate himself / herself resides otherwise than for the purpose of his / her own education. Wherever, photograph is an integral part of the certificate, the RRB would accept only self attested photocopies of such certificates and not any other attested or true copy.
