Subject: - Supply of medicines / drugs, surgical items, sutures etc. to HP Govt. hospitals and other Health institutions for the year 2015-16.

Memo:

The e-tender of medicines / drugs, surgical items, sutures etc. has been finalized by the HP State Civil Supplies Corporation Ltd. Kasumpti, Shimla-9 for the year 2015-16 for purchase the medicines from the firms who have signed the agreement for supplying of the medicines / items as per the terms and conditions of the e-tender of medicines document which is being forwarded to you as such for implementation of the tender conditions.

From this year onward supply order will be generated at the district level after considering and consolidated the demand for various facilities within the district & will be sent to the vendors directly which will supply the medicines or other consumables directly to the district from where these will be supplied to the blocks as per their indents.

For the district Lahaul & spiti demand of Lahaul will be supplied thorough District Kullu and Kaza (spiti) through District Kinnaur.

After receipt of the bills in duplicate and checking & verifying these in all respect, CMO's concerned will made the payment directly to the vendors through electronic transfer or on request by the Demand Draft but the commission of the bank will have to be deducted from the payment of the vendors.

Any other discrepancy i.e. late supply of the medicines or any other may be intimated to the undersigned for further action in the matter.

For quality check name and numbers of the empanelled lab will be intimated shortly after that sample will be lifted from the each batch supplied by the vendor till such intimation sent by the HQ regarding the empanelled Labs supply may be accepted after getting the analytical test report from the vendor of the respective batches. Supply of the medicines / items will be done with bar code as mentioned in the tender document for reading these bar codes, equipments & procedure will be shared with your office shortly.

Various terms and conditions of the tender document are being appended below for your information and adhere to strictly if any change or amendment is required in these terms & conditions, it should be intimated to this office which can be done only at the appropriate level & will be intimated to you accordingly.

1. ELIGIBILITY CRITERIA FOR PARTICIPATION IN THE TENDER:

	At the time of opening of tenders only Technical Bid containing Cost of tender documents, Earnest money deposit, certificates and documents, information as required per Form "A" and Form "B" would be opened and Financial bid/BOQ will be opened only of those tenderers who fulfill following minimum criteria:
i)	The tenderer should be manufacturer having valid manufacturing license or direct importer holding valid <u>import license of quoted medicines/drugs, sutures, surgical items</u> . If the product is imported, an attested photocopy of valid/renewed import license in Form 10 with Form 41 (as per Rule 122A of Drugs & Cosmetics Act) is required to be submitted.
ii)	The tenderer quoting rates for the medicines/drugs, sutures, surgical items should have minimum annual turnover of INR 5 Crores during the financial year 2010-11, 2011-12 and 2012-13 in medicines/drugs, sutures, surgical items duly authenticated by a Chartered Accountant based on the Balance Sheets, Profit and Loss Account of the tenderer as per prescribed Format at Annexure "P1" .
iii)	The tenderer should have at least have 3 years Market Standing as a manufacturer/importer for each drug quoted in the tender as a manufacturer/importer.
iv)	The tenderer has to submit cost of tender document in the shape of cash/ bank draft/RTGS.
v)	The tenderer has to submit Earnest Money Deposit (EMD) as required vide Clause No. 2 (i) & (ii) in the shape of Bank Draft/RTGS.
vi)	The tenderer has to submit and upload Annexure "P10" i.e. Form for scrutiny of tender document duly filled in, signed and complete in all respects furnishing all the required information and documents with Page No.'s. The sample document is enclosed as Annexure "P11" .
vii)	The tenderer shall have the average monthly production capacity not less than one and half times of the quantity earmarked for HPSCSC for each drug. However, after evaluation of the price bid, the eligible tenderers may revise the quoted quantity for a particular drug and the production capacity earmarked for such drug, provided, the total production capacity earmarked on such revision shall not exceed the sum of originally earmarked production capacity for all the quoted items. However, downward revision of the quoted quantity and/or production capacity is not permitted. HPSCSC Ltd. has the prerogative either to accept or reject the revision given by the

	tenderer among the items.
viii)	The tenderer has to submit and upload instruments such as Power of Attorney, Resolution of Board of Director etc. authorizing an officer of the tenderer to transact the business with Tender Inviting Authority in Technical Bid and such authorized officer of the tenderer should sign the Tender documents.
ix)	The tenderer has to submit and upload Authorization letter nominating a responsible person of the tenderer to transact the business with the Tender Inviting Authority with duly attested signature & photograph.
x)	The tenderer has accepted and signed Form "A" and Form "B" of the tender.
xi)	The tenderer has to submit and upload Turnover Certificate for the financial year 2010-11, 2011-12 and 2012-2013 duly authenticated by a Chartered Accountant as per format at Annexure "P 1" .
xii)	The tenderer has to submit & upload valid GMP (GOOD MANUFACTURING PRACTICES) certificate(s) as laid down under revised schedule - "M", or WHO-GMP/COPP (for importer) of the Drugs and Cosmetics Rules issued by Licensing Authority.
xiii)	The tenderer has to submit & upload valid 'GLP' (GOOD LABORATORY PRACTICES) certificate(s) as per schedule L1 of the Drugs & Cosmetic Rules.
xiv)	The tenderer has to submit & upload attested photocopy of valid Drug Manufacturing License(s), Import License(s) against which products have been quoted.
xv)	The tenderer has to submit & upload attested photocopy of product license(s) from concerned Drug licensing authority in respect of quoted products.
xvi)	The tenderer has to submit & upload attested photocopy of Manufacturing & Marketing certificate for the year 2010-11, 2011-12 and 2012-13 in respect of quoted products issued by the concerned Drug licensing authority as per format at Annexure "P2" .
xvii)	The tenderer has to submit & upload Non-conviction certificate(s) issued by the concerned Drug licensing authority. The certificate should be latest one i.e. issued during past twelve months prior to the date of opening of tender along with certificate that the quoted products has not been declared as not of standard quality/spurious/adulterated for past three years.
xviii)	The tenderer has to submit & upload the list of quoted products as per Annexure "P 3" .
xix)	The tenderer has to submit & upload an affidavit as per Annexure "P4" giving an undertaking on the affidavit that they have not been convicted, black listed, prosecuted for producing/supplying any sub-standard or misbranded or spurious medicines/drugs, sutures, surgical items by the Central Govt./State Governments or any Government undertaking/ Institutions under their control.
xx)	The details containing the name & address of manufacturing premises where the items quoted are actually manufactured to be given as per format in Form B, Part-II.
xxi)	The details of technical personnel employed in the manufacture & testing of drugs (Employee Name, Qualification, and Experience) as endorsed in license.
xxii)	The tenderer has to submit & upload latest VAT/Sales Tax clearance certificate and the tenderer should be assessed upto financial year 2010-11.

xxiii)	The tenderer has to submit & upload attested copy of CST No. of branch office/depot/dump/C&F agent from where supplies are to be executed.
xxiv)	The tenderer has to submit & upload attested copy of PAN.

2. EARNEST MONEY DEPOSIT:

i)	Every tenderer shall furnish an EMD (Earnest Money Deposit) of INR 1 lakh alongwith the tender in the shape of bank draft in favour of 'H.P. State Civil Supplies Corporation Limited' except for wholly Government owned Manufacturing Units; payable at any scheduled bank at Shimla which shall be kept in a separate envelope super-scribing as "Earnest Money Deposit".
ii)	EMD should be either be submitted along with the tender document in Technical Bid and placed at top or through RTGS in H.P. State Civil Supplies Corporation's current account no. 55070899845 with State Bank of Patiala, Branch at Kasumpti, Shimla (IFS Code No. STBP 0000717); failing which the bid shall be out-rightly rejected. The earnest money of unsuccessful tenderers will be returned in due course i.e. after the finalization of tenders and issuance of supply orders. In case of remittance of cost of tender documents, Earnest Money Deposit through RTGS, details of remittance i.e. Name of Bank, UTR No. and Date of remittance is to be furnished.

3. PERFORMANCE SECURITY DEPOSIT& AGREEMENT:

i)	<p>On being informed about the acceptance of the tender and before signing the Agreement, the successful Tenderer shall pay the Security Deposit as indicated below in the form of Demand Draft or irrevocable Bank Guarantee in favour of Managing Director, H.P. State Civil Supplies Corporation Limited. In case the Security Deposit is paid in form of Bank Guarantee, the bank guarantee shall be valid for a period of 2 years from the date of communication of the acceptance letter from the Tender inviting Authority. The format of Bank Guarantee is at Annexure "P 8".</p> <p>(a) Total value of contract upto Rs. 50 Lakhs - 5% of the contract value subject to a minimum of Rs.5,000/-</p> <p>(b) Total Value of contract Exceeding Rs. 50 Lakhs - Rs. 2.5 Lakhs Plus @ 3% of the order value over and above Rs. 50 Lakhs</p>
ii)	<p>The successful Tenderer shall execute an agreement (3 copies) on a non-judicial stamp paper of value of Rs.100/- (stamp duty to be paid by the Tenderer) within 15 days from the date of the intimation from Tender Inviting Authority informing that his tender has been accepted. The Specimen form of agreement is available in Annexure "P 7" and also available in the HPSCSC Website (http://www.himapurti.gov.in).</p> <p>The Tenderer shall not, at any time, assign, sub-let or make over the contract or the benefit thereof or any part thereof to any person or persons what so ever.</p>

4. RATES OFFERED:

i)	The rates quoted should be <i>F.O.R door delivery basis</i> at our “ AAROGYA REGIONAL DRUG WAREHOUSES ” listed at Annexure “P 9” and inclusive of Excise Duty, Custom Duty, Transportation, Insurance, Entry Tax on Entry of Goods in H.P. (wherever applicable), Handling, Clearing charges, VAT/Sales tax. No other charges & taxes will be paid extra.
ii)	The tenderer is required to upload the breakup of Landed price per unit of the quoted items as per Annexure “P 12” in the Financial Bid part.
iii)	The price quoted by the tenderers shall not, in any case exceed the controlled price , if any, fixed by the Central/State Govt. and the Maximum Retail Price (MRP). In the event of any decrease in the rates during the contractual period, the tenderer shall submit notarized undertaking to reduce rates correspondingly from the date, the rates have been reduced.
iv)	The rates of medicines/drugs, sutures, surgical items etc. shall be quoted online.
v)	Rates should be inclusive of cost of packing/packing material/tins etc./forwarding/handling and clearing charges. No separate cost on this account shall be payable.
vi)	The rates should be filled in carefully and correctly online. After approval of rates, no representation will be entertained for amendment in rates, presentation/pack; a penalty of INR 10,000/- will be levied for each such default.
vii)	Item-wise rates quoted by the tenderers will be compared electronically and supply orders issued subject to approval by the State Level Store Purchase Committee (SLSPC) keeping in view the quality of medicine/drugs, sutures, surgical items etc., and reputation of the tenderers in the market and their past performance (In case they were on the list of approved suppliers during past years with the Corporation).

5. METHODOLOGY FOR PLACING ORDERS:

i)	Orders will be placed periodically based on the stock position only. Orders will be placed normally with the L1 firms. However, in case of any exigency or in case of failure of L1 to supply timely, at the discretion of the Tender Inviting Authority, the orders may also be placed with the other firms who have matched with the L1 rates.
ii)	For the above purpose the following procedures will be adopted: a. After opening of Price Bid digitally, the lowest offer of the Tenderer is found as L1 rate and L1 supplier for an item or items of Drugs/Medicines for which the tender has been invited. b. The Tenderer, who has been found as L1 supplier for certain item or items of Drugs/Medicines, shall execute necessary agreement for the supply of the tendered quantity of such drugs/medicines as specified in the Tender Document on depositing the required amount as Performance Security and on execution of the agreement such Tenderer is eligible for the

placement of Purchase Orders.

c. If two or more than two Tenderers are found as L1 suppliers for the same item of Drugs/Medicines, such Tenderers shall execute necessary agreement as specified in the Tender Document on depositing the required amount as Performance Security and on execution of the agreement such Tenderer is eligible for the placement of Purchase Orders for such item or items of Drugs/Medicines for which they are found as L1.

d. As Price Bid opening will be online, Tenderers who had qualified for Price Bid opening may submit their consent to HPSCSC for matching with the L1 rate for the item of the Drugs/Medicines quoted by them and the Tenderers who agree to match L1 rate, will be considered as Matched L1.

e. If the L1 supplier fails to supply the required Drugs/Medicines within the stipulated time or within the extended time, as the case may be, HPSCSC will cancel such purchase orders and on cancellation, HPSCSC will place Purchase Orders with the Matched L1 Tenderer for purchase of the Drugs/Medicines, provided such Matched L1 Tenderer shall execute necessary agreement indicating the production capacity as specified in the Tender Document on depositing the required amount as Performance Security and on execution of the agreement such Tenderer is eligible for the placement of Purchase Orders for the item or items of Drugs/Medicines quoted by them.

f. Subject to para (e) above, while HPSCSC has chosen to place Purchase Orders with the Matched L1 supplier and there is more than one such Matched L1 supplier, then the Purchase Orders for the requirement of Drugs/Medicines will be placed among them in equal proportions.

g. The Matched L1 supplier, on placement of Purchase Order, will be deemed as L1 rate supplier for the purpose of the tender and all provisions of the tender documents applicable to L1 rate Tenderer will apply mutatis mutand to the Matched L1 supplier.

h. If the supplier fails to supply the Drugs/Medicines for the three Purchase Orders, at any point of time, either fully or partly, within the stipulated time, HPSCSC is at liberty to place Purchase Orders with other Tenderers (in ascending order, viz., L2,L3 and so on) at the price offered by them and in such cases the supplier is liable to indemnify HPSCSC, WITH OUT ANY PROTEST OR DEMUR, for the difference in cost incurred by HPSCSC and the HPSCSC is entitled to recover the difference in cost from the amount due/payable to the supplier.

i. The supplier shall start supply of the Drugs/Medicines required by HPSCSC at the destination mentioned in the Purchase Order, within the period stipulated here under.

	<p>j. The Drugs/Medicines supplied in excess of the ordered quantity shall not be accepted and the supplier shall take back the excess at their cost. HPSCSC will not be responsible for the loss to the supplier and will not entertain any demand/claim.</p> <p>k. The supplier shall supply the Drugs/Medicines at the specified destination and submit a copy of the excise invoice, Purchase order, Delivery Challan and other relevant documents at the destinations.</p> <p>l. After supply of Drugs/Medicines at the specified destinations, the supplier shall submit Excise Invoice (Original), Test Report and other relevant documents etc., at the Head Office, HPSCSC for claiming payment.</p> <p>m. The supplier shall take utmost care in supplying the quality Drugs/Medicines and ensure that the batch number mentioned in the packages of the Drugs/Medicines tally with the batch number mentioned in the Invoice produced to HPSCSC for payment. Also, the supplier shall ensure the quantity relevant to the Batch Number of the Drugs/Medicines is mentioned in the invoice. Any variation will delay the payment for the supply.</p> <p>n. It is the duty of the supplier to supply Drugs/Medicines at the destinations mentioned in the Purchase Order and supply shall conform to the conditions mentioned in the provisions of tender documents.</p> <p>o. Subject to para (m) above, HPSCSC will process the invoices submitted by the supplier and the payments against supply will be made, within 30 days from the date the Drugs/Medicines supplied has been declared of STANDARD QUALITY, by the Empanelled laboratory of HPSCSC subject to various terms and conditions of the tender.</p> <p>p. Subject to the conditions mentioned in the Purchase Order, Tender Document, Agreement executed by the supplier and here under, the Supplier is entitled for the payment against supply. In case of any discrepancy in levy of LD, Penalty, Unexecuted Fine, Short Passing of Bills, such discrepancy shall be intimated within 15 days from the date of receipt of payment, failing which HPSCSC will not entertain any claim thereafter.</p>

6. SUPPLY CONDITIONS:

i)	Purchase orders along with the place of supply (destinations) will be issued on the successful Tenderer at the discretion of the Tender Inviting Authority.
ii)	Within 3 days from the receipt of purchase orders the Tenderer should upload on the website of the HPSCSC and/or inform through fax his confirmation for the receipt of the purchase order.
iii)	a. The supplier shall commence the supplies within 30 days of the issuance of the supply

	order and supply the entire ordered quantity before the end of 60 th day from the issue of purchase order at the destinations mentioned in the purchase order, if the above day happened to be a holiday for HPSCSC, the supply should be completed by 5.00 PM on the next working day.
	b. After 60 th day, the Liquidated damages will be levied as per Clause 11 .

7. SHELF LIFE:

i)	It shall be the duty of the tenderer to pack and forward only such medicines/drugs, sutures, surgical items, which pertain to the most recent manufacturing batch. The shelf life of the supplied medicines/drugs, sutures, surgical items etc. at the time of delivery should not be less than ¾ of the labeled shelf life.

8. QUALITY ASSURANCE:

i)	The approved suppliers shall have to provide test Certificate/Analysis report in respect of all batches of medicines/drugs, sutures, surgical items along with supplies separately from any of the NABL accredited Govt. Analytical Laboratories set up by the Central or State Govt. or any Analytical Drug Testing Laboratory licensed under Drugs & Cosmetics Act, 1940 and Rules there under as amended from time to time. The supplies will be deemed to be completed only upon receipt of above said analytical test report.
ii)	Samples of supplies in each batch will be chosen at the point of supply or distribution/storage points for testing. The samples will be sent to empanelled laboratories including Government Drugs Testing Laboratory for testing as decided by the Tender Inviting Authority. Handling and testing charges will be deducted by Tender Inviting Authority for the above purpose @ 2% of the supply value.
iii)	The Drugs shall have the active ingredients at the maximum permissible level throughout the shelf life period of the drug.
iv)	The supplier shall furnish evidence of the basis for expiration dating and other stability data concerning the commercial final package on request by the Purchaser.

9. MARKING OF SUPPLIES:

i)	While executing supplies against the supply order, the date of manufacturing, date of expiry, batch number etc. shall be clearly mentioned by the "Supplier" on the bill, each packing/container and such packing's/containers shall be duly Rubber Stamped/Printed " H.P. GOVT. /HPSCSC SUPPLY ONLY " in red ink.
ii)	The stocks supplied should have MRP (Maximum Retail Price) which should be approved rate plus 15%.

10. PACKING OF MEDICINES/DRUGS, SURGICAL ITEMS, SUTURES:

i)	All the tablets and capsules shall have to be quoted in standard packing's in aluminum foil strip or blister packing. In this regard, please refer to Annexure"P5" appended with this tender form and

	take note that all conditions detailed therein should be strictly adhered to in letter and spirit. The packing of drugs/medicines should also conform to schedule P1 of the Drugs & Cosmetics Rules wherever it applies.
ii)	The drugs and medicines shall be supplied in the package specified in Annexure "P 5" and Annexure "P 6" .

11. OTHER CONDITIONS:

i)	C&F Agents/Distributors/Stockists are not eligible to participate in the tender.
ii)	All the documents submitted in physical form & uploaded should be signed by the tenderer at the bottom of each page with the office seal/stamp duly affixed.
iii)	Form-B forming part of the tender document set should also be properly and exhaustively filled up and requisite documents to be attached and uploaded.
iv)	All consignment shall be insured by the suppliers for any transit losses. The suppliers shall also be responsible for any short-delivery and breakage in transit.
v)	Tenderer shall quote firm offers. Incomplete or conditional offers incorporating price variation will not be entertained.
vi)	The tenderer should indicate their manufacturing license no(s) and their validity period for the quoted items. An attested photocopy of manufacturing license(s), import license(s) must be enclosed (only attested copy of relevant page of the approved formulation is to be attached).
vii)	If the manufacturing license(s) is under renewal, it should be confirmed that application was made within time frame as per Drugs & Cosmetics Act, 1940, as amended from time to time and the quoted item(s) has/have not been deleted by the licensing authority.
viii)	The tenderer should have the services of at least one approved manufacturing chemist and one approved quality control chemist.
ix)	The stores offered by tenderer should strictly conform to the provisions of the Drug & Cosmetics Act, 1940 and the Rules made there under as amended from time to time.
x)	The State Govt. /undersigned reserve the right to have the premises of the manufacturers inspected for ensuring that " GMP " (GOOD MANUFACTURING PRACTICES) as per revised schedule 'M' and " GLP " (GOOD LABORATORY PRACTICES) as per schedule L1 of the Drugs & Cosmetics Rules, as amended from time to time are being observed by the manufacturers.
xi)	The State Level Store Purchase Committee (SLSPC) may select more than one supplier for the supply of a particular medicine/drug, sutures, and surgical items etc.
xii)	The approved suppliers may also be required to supply the approved items for sale through H.P. State Civil Supplies Corporation Limited for various medicine shops in the Pradesh on approved

	rates.
xiii)	After the expiry of contractual period of the tender the approved tenderer will furnish the following undertakings by way of an affidavit duly attested by a Public Notary: <ul style="list-style-type: none"> a) That they have executed all the supply orders issued by the Corporation from time to time against the tender of medicine for the year 2014-15. b) That, in case, the samples of any item is declared sub-standard or misbranded or spurious at any stage within the expiry period of items supplied, the total cost of the item so supplied under that batch shall be refunded within 30 days of the intimation by the Corporation.
xiv)	It is presumed that the tenderer has the requisite installed capacity for the quoted products as per tentative quantity required during the validity period of the rate contract.
xv)	The Purchase orders will be placed online and would be visible to the approved suppliers.

12. RAISING OF BILLS AND PAYMENT PROVISION:

i)	All bill(s)/invoices of medicines/drugs, sutures, surgical items should be raised in triplicate the name of the Director, Health Services, Swasthaya Bhawan, SDA Complex, Kasumpti, Shimla - 171 009 (H.P.) or as per directions given in the supply order and supplies shall be delivered at the concerned "AAROGYA REGIONAL DRUG WAREHOUSES" at different locations as mentioned in Annexure P 9 .
ii)	No advance payments towards costs of drugs, medicines etc., will be made to the Tenderer.
iii)	Payments towards the supply of drugs and medicines will be made upon confirmation of receipt of stock/items at the concerned "AAROGYA REGIONAL DRUG WAREHOUSES" and after the receipt of <u>the quality control reports</u> . The payment will be made either by means of Cheque or through RTGS (Real Time Gross Settlement System)/Core Banking/NEFT. The Tenderer shall upload the relevant details as per details asked in Part-I of Form B .
iv)	The payment to the suppliers shall be made through e-banking/cheques (payable at Shimla) or through a bank draft on a specific request from the suppliers. The draft charges payable to the bank shall be recovered from the suppliers while releasing the payments.
v)	Prorata deduction in payment shall be made if the supply is received in damaged conditions.

13. PENALTY ON DEFAULT/LATE DELIVERY OF STOCKS:

	It shall be incumbent upon the suppliers to complete the supplies so as to reach the concerned consignees within 60 days from the date of issue of supply order. In case of delay in supplies, liquidated damages shall be recovered to be computed as under:
i)	In case supply is delayed by 1 week penalty @ 1% of the value of medicines, items late delivered.
ii)	In case supply is delayed by 2 weeks penalty @ 3% of the value of medicines, items late delivered.
iii)	In case supply is delayed by 3 weeks penalty @ 5% of the value of medicines, items late delivered.
iv)	In case supply is delayed by 4 weeks penalty @ 10% of the value of medicines, items late delivered.
v)	In case the approved tenderer still fails to supply the ordered items, the supply order shall stand automatically cancelled after 90 th day from the date of issue of supply order. The security deposit (including earnest money deposit retained as security) shall stand forfeited and the State Level Store Purchase Committee (SLSPC) shall be at liberty to debar the approved supplier for three years from participation in the tender for supply of medicines/drug, sutures, surgical items etc. to H.P. Govt. Hospitals.
vi)	The State Level Store Purchase Committee (SLSPC) reserve the right to receive supply even after 90 days in exceptional case from the date of issue of supply order and in such cases liquidated damages will be levied @20% of the value of medicines late delivered.

14. PENALTY ON DECLARATION OF SUPPLIED PRODUCT AS NOT OF STANDARD QUALITY(SUB-STANDARD) OR MISBRANDED OR SPURIOUS:

i)	If the samples do not conform to statutory standards, the Tenderer will be liable for relevant action under the existing laws and the entire stock in such batch has to be taken back by the Tenderer within a period of 30 days of the receipt of the letter from Tender Inviting Authority. Such stock shall be taken back at the expense of the Tenderer. The Tender Inviting Authority has the right to destroy such "NOT OF STANDARD QUALITY" stock if the Tenderer does not take back the goods within the stipulated time. The tenderer shall be entitled to the benefit of this clause only if he informs in writing of the circumstances amounting to force majeure to HPSCSC Ltd. for each consignment/dispatch separately within 48 hours of the happening thereof by fax/e-mail immediately, followed by a confirmatory letter sent by Registered Post with acknowledgement due.
