7. APPEAL AGAINST DETAILED MEDICAL EXAMINATION:-

A candidate declared unfit in detailed medical examination if not satisfied with the findings of the Medical Officer, can submit an <u>appeal for his Re-Medical Examination (RME)</u> with duly filled Medical certificate (at Annexure-VII) as a proof of evidence about the error of judgment on the part of Recruitment Medical Officer.
