IV. <u>Age:</u>

VI. General Conditions:

a) Reservation

- (i) Government of India Directives on reservation applicable for SC/ST/OBC/PWD/ Ex-Servicemen candidates will apply and be strictly followed.
- (ii) In the case of Persons With Disabilities the degree of disability should be a minimum of 40%. The applicant should submit a <u>valid Certificate of disability</u> to this effect in the prescribed format obtained from a notified authority by Government of India / State Government along with their application.
- (iii) Applicants belonging to SC or ST or OBC (Non Creamy Layer), should submit a <u>valid recent community certificate</u> issued by the Revenue Authority not below the rank of the Tahsildar along with their application, failing which their candidature will not be considered against respective categories.

b) Qualification
