### **1** INTRODUCTION

#### 1 NATIONAL ELIGIBILITY CUM ENTRANCE TEST (UG)

As per regulations framed under the Indian Medical Council Act-1956 as amended in 2018 and the Dentists Act-1948 as amended in 2018, NATIONAL ELIGIBILITY CUM ENTRANCE TEST (UG) – 2018 (NEET-UG-2018) will be conducted by the Central Board of Secondary Education (CBSE), for admission to MBBS/BDS Courses in India in Medical/Dental Colleges run with the approval of Medical Council of India/Dental Council of India under the Union Ministry of Health and Family Welfare, Government of India except for the institutions established through an Act of Parliament i.e. AIIMS and JIPMER Puducherry.

#### Following is stated in the regulations:-

- a. There shall be a single eligibility cum entrance examination namely 'National Eligibility-cum-Entrance Test for admission to MBBS/BDS courses in each academic year.
- b. In order to be eligible for admission to MBBS/BDS Courses for a particular academic year, it shall be necessary for a candidate to obtain minimum marks in 'National Eligibility-cum-Entrance Test' held for the said academic year besides obtaining minimum prescribed marks at the qualifying examination.
- c. The reservation of seats in Medical/Dental colleges for respective categories shall be as per applicable laws prevailing in States/Union Territories. An All India Merit List of the eligible candidates shall be prepared on the basis of the marks obtained in National Eligibility-cum-Entrance Test for admission in MBBS/BDS courses from the said lists only.
- d. No candidate who has failed to obtain the minimum eligibility marks as prescribed by the Medical Council of India/Dental Council of India shall be admitted to MBBS/BDS Courses in the said academic year.
- e. All admissions to MBBS/BDS courses within the respective categories shall be based solely on marks obtained in the National Eligibility-cum-Entrance Test (UG).
- f. The Central Board of Secondary Education shall be the organization to conduct National Eligibility-cum-Entrance Test for admission to MBBS/BDS courses.

As per the directives of the Hon'ble Supreme Court of India in WP (C) 390/2017 dated 10.08.2017, the comprehensive affidavit as to how CBSE is going to conduct examination in future, was placed alongwith draft Information Bulletin before the Hon'ble Supreme Court of India. CBSE will therefore, hold NEET (UG), 2018 in compliance of the orders dated 25.01.2018.

The Central Board of Secondary Education will conduct the National Eligibility Cum Entrance Test for admission to MBBS/BDS Courses in the session 2018-19 on 6<sup>th</sup> May, 2018 (Sunday).

- The responsibility of CBSE is limited to the conduct of the entrance test, declaration of result and providing All India Rank to the Directorate General of Health Services, Ministry of Health and Family Welfare, Government of India for counselling of 15% All India Quota Seats, Deemed Universities/Central Universities/Seats of ESIC & AFMC including BHU & AMU and providing the result to the State Counselling Authorities and Admitting Institutions.
- The result of NEET (UG) may be utilized by other entities of Central/State Governments for admission purpose in accordance with their rules.
- The Counselling for successful candidates under 15% All India Quota seats, Deemed Universities/Central Universities/Seats of ESIC & AFMC including BHU & AMU will be conducted by the MCC/DGHS. The counselling for admission in seats under the control of other States/Universities/Institutions shall be conducted as per the notifications issued separately by the authorities concerned.
- During counselling, the eligibility criteria, self-declaration, various documents, etc. of the eligible candidates shall be verified as per norms specified by the respective authorities and Medical/Dental Colleges.

Admissions to all seats of MBBS/BDS will be done through NATIONAL ELIGIBILITY CUM ENTRANCE TEST (UG) - 2018. There are following quota seats available: -

- i. All India Quota Seats
- ii. State Government Quota Seats
- iii. Central Institutions/Universities/Deemed Universities
- iv. State/Management/NRI Quota Seats in Private Medical / Dental Colleges or any Private University
- v. Central Pool Quota Seats

#### 2 SHORT TITLE

These rules will be called as National Eligibility Cum Entrance Test (UG) Rules.

#### 3 **DEFINITIONS**

- (a) "Government" means Government of India.
- (b) "Ministry" means Ministry of Health and Family Welfare, New Delhi.
- (c) "DGHS" means Directorate General of Health Services, New Delhi.
- d) "Council" means Medical Council of India and Dental Council of India.

- (e) "Board" means Central Board of Secondary Education, Delhi
- (f) "MCC" means Medical Counselling Committee under DGHS for 15% All India Quota
- (g) "Medical Examination & NEET" means NATIONAL ELIGIBLITY CUM ENTRANCE TEST (UG)
- (h) "Qualifying Examination" means Examinations on the result of which the candidate becomes eligible to apply for the NATIONAL ELIGIBILITY CUM ENTRANCE TEST.
- (i) "Rules" means the rules specified by the Central Board of Secondary Education for the conduct of NEET (UG).
- (j) "Scheduled Castes" means Scheduled Castes as specified and laid down by the Government of India or any of the States/UTs Government.
- (k) "Scheduled Tribes" means Scheduled Tribes as specified and laid down by the Government of India or any of the States/UTs Government.
- 1) "Other Backward Classes" means Other Backward Classes (Non Creamy Layer) as specified and laid down by the Government of India or any of the States/UTs Government.
- m) "Physically Handicapped" means Physically Handicapped person in accordance with the Provisions of the Rights of Persons with Disability Act, 2016.

#### 4 DATE OF ENTRANCE TEST

NATIONAL ELIGIBILITY CUM ENTRANCE TEST (UG) will be conducted on 6<sup>th</sup> May, 2018 (Sunday) from 10.00 AM to 1.00 PM. The duration of test will be 3 hours.

The schedule will remain unaltered even if the date of test is declared a public holiday.

The selection and admission to MBBS/BDS seats in any Medical Institution recognized for offering MBBS/BDS Courses is subject to fulfilling the admission criteria, eligibility, rank in merit list, medical fitness and such other criteria as may be prescribed by the Government of India, respective States, Universities and Medical/Dental Colleges.
- (c) Applications of candidates submitting false and fabricated information will not be considered and such candidates will be further debarred from appearing in examinations conducted by the CBSE.

## 3 ELIGIBILITY AND QUALIFICATIONS

#### 1 ELIGIBILITY TO APPEAR IN NEET (UG)

Eligibility for appearing in NEET (UG) is as stipulated in Indian Medical Council Act-1956/Regulations as amended in 2018 and the Dentists Act-1948/Regulations as amended in 2018. Eligibility as per related regulations is as follows:-

- (a) He/she has completed age of 17 years at the time of admission or will complete the age on or before 31st December of the year of his/her admission to the 1<sup>st</sup> year MBBS/BDS Course.
- (b) The upper age limit for NEET(UG) is 25 years as on the date of examination with relaxation of 5 years for the candidates belonging to SC/ST/OBC category and persons entitled for reservation under the Rights of Persons with Disabilities Act, 2016.

The Age criteria for appearing in NEET (UG) - 2018 is as follows:

For Candidates of Unreserved Category (UR)	born on or between 07.05.1993 and 01.01.2002
For Candidates of SC/ST/OBC/PH Category	born on or between 07.05.1988 and 01.01.2002

(c) Indian Nationals, Non Resident Indians (NRIs), Overseas Citizen of India (OCIs), Persons with Indian Origin (PIOs) & Foreign Nationals are eligible to appear in NEET (UG)-2018.
(As per letter no. U.12023/16/2010-ME-II dated 13.01.2016. of MoH & FW)

### 2 ELIGIBILITY FOR SEATS UNDER THE CONTROL OF STATES/ DEEMED UNIVERSITIES/CENTRAL UNIVERSITIES /SEATS OF ESIC & AFMC INCLUDING BHU & AMU/CENTRAL POOL OUOTA

- (a) Indian Nationals, Non Resident Indians (NRIs), Overseas Citizen of India (OCIs), Persons with Indian Origin (PIOs) & Foreign Nationals are eligible for admission in Medical/Dental Colleges subject to rules and regulations framed by the respective State Governments, Institution and the Government of India.
- (b) Foreign nationals may confirm their eligibility from the concerned Medical/Dentals College/State.

#### 3 ELIGIBILITY FOR 15% ALL INDIA QUOTA SEATS

- (a) Indian Nationals, Non Resident Indians (NRIs), Overseas Citizen of India (OCIs), Persons with Indian Origin (PIOs) & Foreign Nationals are eligible for 15% All India Ouota Seats.
- (b) Candidates from State of J & K
  - (i) Students from State of J & K are NOT ELIGIBLE for 15% all India quota seats as State of J&K has opted out of All India Scheme since its inception. If they claim eligibility, they must submit online Self Declaration which will be generated and printed automatically alongwith confirmation page for the record and to present during counselling. The draft self-declaration is given in Appendix III.
  - (ii) The online Self Declaration of the candidates will be verified at the time of counselling and if found to be false at any time, the candidature/admission of such candidates shall be cancelled and criminal proceedings may be initiated against them.
  - (iii) Candidates from the State of J & K can appear in NEET (UG) for admission to Private Medical/Dental Colleges or any Private/Deemed University and Armed Forces Medical College (AFMC), Pune subject to the fulfilment of eligibility conditions.
  - (iv) The Government of Andhra Pradesh & Telangana vide their letter no.13021/C1/2016 dated 06.11.2017 & letter no.7072/C1/2017 dated 07.11.2017 respectively have informed that Government of Andhra Pradesh and Government of Telangana have decided to join and contribute to the All India Quota seats. Accordingly, the candidates of these States have also become eligible for 15% All India Quota seats (As per letter No. F.No. V.26012/05.2017-MEP/MEC dated 10.01.2018, Directorate General Health Services, Ministry of Health & Family Welfare, Govt. of India)

#### 4 QUALIFICATIONS AND QUALIFYING EXAMINATION CODES

#### CODE: 01

A candidate who is appearing in the qualifying examination, i.e., 12<sup>th</sup> Standard in 2018, whose result is awaited, may apply and take up the said test but he/she shall not be eligible for admission to the MBBS or BDS, if he/she does not pass the qualifying examination with the required pass percentage of marks at the time of first round of Counselling.

OR

#### **CODE** : 02

The Higher/Senior Secondary Examination or the Indian School Certificate Examination which is equivalent to 10+2 Higher/Senior Secondary Examination after a period of 12 years study, the last two years of such study comprising of Physics, Chemistry, Biology/Bio-technology (which shall include practical tests in these subjects) and Mathematics or any other elective subject with English at a level not less than the core course for English as prescribed by the National Council of Educational Research and Training after introduction of the 10+2+3 educational structure as recommended by the National Committee on Education.

Provided that 2 year of regular and continuous study of Physics, Chemistry, Biology/Bio-technology taking together shall be required at 10+2 level for all the candidates. Candidates who have passed 10+2 from Open Schools or as private candidate shall not be eligible to appear for NEET (UG). Furthermore, study of Biology/Bio-technology as an additional subject at 10+2 level also shall not permissible.

NOTE: where the course content is not as prescribed for 10+2 education structure of the National Committee, the candidates will have to undergo a period of one year pre - professional training before admission to the Medical Colleges.

OR

#### CODE: 03

The Intermediate/Pre-degree Examination in Science of an Indian University/Board or other recognised examining body with Physics, Chemistry, Biology /Bio-technology (which shall include practical test in these subjects) and also English as a compulsory subject.

OR

#### **CODE: 04**

The Pre-professional/Pre-medical Examination with Physics, Chemistry, Biology/Bio-technology & English after passing either the Higher Secondary Examination or the Pre-University or an equivalent examination. The Pre-professional/Pre-medical examination shall include practical test in these subjects and also English as a compulsory subject.

OR

#### CODE: 05

The first year of the three years' degree course of a recognised University with Physics, Chemistry and Biology/Bio-technology including practical tests in these subjects provided the examination is a University Examination and candidate has passed the earlier qualifying examination with Physics, Chemistry, Biology/ Bio-technology with English at a level not less than a core course.

OR

#### CODE: 06

B.Sc. Examination of an Indian University provided that he/she has passed the B.Sc. Examination with not less than two of the subjects Physics, Chemistry, Biology (Botany, Zoology)/Bio-technology and further that he/ she has passed the earlier qualifying examination with Physics, Chemistry, Biology and English.

OR

#### CODE: 07

Any other examination which in scope and standard (Last 02 years of 10+2 Study comprising of Physics, Chemistry and Biology/Bio-technology; Which shall include practical test in these subjects) is found to be equivalent to the Intermediate Science Examination of an Indian University/Board, taking Physics, Chemistry and Biology/Bio-technology including practical tests in each of these subjects and English.

Provided that to be eligible for Competitive Entrance Examination, candidate must have passed any of the qualifying examinations as enumerated above or appearing in the qualifying examination in 2018. Provided also that to be eligible for Competitive Entrance Test, the candidate must have passed in the subjects of Physics, Chemistry, Biology/Bio-technology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology/Bio-technology at the qualifying examination as mentioned in clause (2) of regulation 4 on Graduate Medical Education Regulations, 1997 as amended in 2018 and in addition must have come in the merit list of NATIONAL ELIGIBILITY ENTRANCE TEST (UG) – 2018 for admission to MBBS/BDS courses.

In respect of the candidates belonging to Scheduled Castes, Scheduled Tribes or Other Backward Classes, the marks obtained in Physics, Chemistry and Biology/Bio-technology taken together in qualifying examination shall be 40% marks instead of 50% marks for General Candidates. In respect of candidates with Bench Mark Disabilities specified under the Rights of Persons with Disabilities Act, 2016, the minimum marks in qualifying examination in Physics, Chemistry and Biology (or Botany & Zoology)/Bio-technology taken together in qualifying examination shall be 45% instead of 50% for General category candidates and 40% for SC/ST/OBC candidates.

Provided further that the students educated abroad seeking admission into medical colleges in India must have passed in the subjects of Physics, Chemistry, Biology/Bio-technology and English up to the 12<sup>th</sup> standard level with 50% marks and their equivalency determined as per regulations of the Medical Council of India and the concerned University. If a candidate does not fall within the qualifications prescribed as per Code number 01-07, he/she should furnish complete details to determine eligibility.

- Note:
  - > The Pre-medical course may be conducted either at a Medical College or at a Science College.
  - > Marks obtained in Mathematics are not to be considered for admission to MBBS/BDS Courses.
  - The candidates who have studied from the Foreign/International Board may ensure that the qualifying examination passed by them should, in scope and standard, be as explained in CODE: 07.

#### 4 ADMISSION AND RESERVATION

An All India Merit List of the qualified candidates shall be prepared on the basis of the marks obtained in the NATIONAL ELIGIBILITY CUM ENTRANCE TEST (UG) and candidates shall be admitted to MBBS/BDS courses from the said list only by following the already existing reservation policy. CBSE will provide All India Rank. Admitting Authorities will invite applications for counselling and merit list shall be drawn based on All India Rank by the Admitting Authorities. Admission to MBBS/BDS Courses within the respective categories shall be based solely on marks obtained in the National Eligibility Cum Entrance Test. The admitting/counselling authorities will draw merit list of the candidates in the respective categories declared by the candidates at the time of applying for admission/counselling.

#### (a) RESERVATION OF SEATS IN GOVERNMENT MEDICAL COLLEGES UNDER 15% ALL INDIA QUOTA:

- (i) 15% seats are reserved for SC candidates,
- (ii) 7.5% seats are reserved for ST candidates,
- (iii) 27% seats as per Central Act are reserved for non-creamy layer OBC candidates only in Central Educational Institutions. Reservation would be applicable to the castes mentioned in the Central list of OBC. Thus, the candidates falling in this list may mention OBC-NCL in the Category Column in application form. Candidates from creamy layer and those who do not come under Central List of OBC are advised to mention their category as Unreserved (UR).
- (iv) Differently abled candidates as per MCI guidelines-are:

Persons having Bench Mark disabilities and entitled for reservation under the Rights of Persons with Disability Act, 2016, 5% seats of the annual sanctioned intake capacity shall be filled up by candidates with Bench Marked Disabilities in accordance with the provisions of the Rights of Persons with Disabilities Act, 2016 based on the merit list of "National Eligibility Cum Entrance Test". For this purpose, the specified disability contained in the schedule to the Rights of Persons with Disabilities Act, 2016 is available at **Appendix-XIV**. If the seats reserve for the persons with disabilities in a particular category remain unfilled on account of unavailability of candidates, the seats should be included in the Annual Sanctioned Seats for the respective category. Detailed information in this regard is available on the website of Medical Counselling Committee – <a href="https://www.mcc.nic.in">www.mcc.nic.in</a> and on website of the Ministry of Health and Family Welfare – <a href="https://www.mcc.nic.in">www.mcc.nic.in</a>

Candidates who considered themselves eligible for this category are advised to ensure their eligibility by getting themselves examined at any Government Medical College/District Hospital/Government Hospital. However, candidates may kindly note that in case of selection under PH category, they will be required to produce Disability Certificate from one of the disability assessment boards, constituted at the four metro cities, mentioned below, before their scheduled date of counselling:

- (v) Reservation will be made as per 2200 point reservation roster. The mode of implementation of reservation will be available on DGHS website-www.mohfw.nic.in.

### (b) ADMISSION IN STATE MEDICAL COLLEGES/UNIVERSITIES/INSTITUTIONS/PRIVATE MEDICAL COLLEGES FOR SEATS OTHER THAN 15% ALL INDIA QUOTA.

- (i) Admission under State Quota Seats shall be subject to reservation policy and eligibility criteria prevailing in the State/Union Territory as notified by the respective State/Union Territory from time to time.
- (ii) The reservation of the seats in medical colleges for respective categories shall be as per applicable laws prevailing in State/Union Territory concerned.
- (iii) Admission to MBBS/BDS Courses in Private Medical Colleges shall be subject to policies of the Government of India/State/Union Territory.

### (c) ADMISSION TO DEEMED UNIVERSITIES/CENTRAL UNIVERSITIES/SEATS OF ESIC AND AFMC INCLUDING BHU AND AMU

- (i) Admission to Deemed Universities/Central Universities/seats of ESIC including BHU and AMU will be conducted by DGHS and reservation policy will be as per rules and regulations of the concerned University or Institution.
- (ii) Admission to AFMC, Pune shall be subject to the norms prescribed by the Directorate General of Armed Forces Medical Services, Ministry of Defence, Government of India. Candidates who apply for NEET (UG) –2018 and also seeking admission in AFMC will also have to apply to AFMC on <a href="www.afmc.nic.in">www.afmc.nic.in</a> / <a href="www.afmcdgld.gov.in">www.afmcdgld.gov.in</a>. The short listed candidates will be required to appear for a second stage Screening Test conducted by AFMC. Candidates are advised to contact AFMC for further and exact details. The counselling will be conducted by DGHS.

## 4 MODE OF SUBMISSION OF APPLICATION FORM AND PAYMENT OF FEE

A candidate can apply for the NEET (UG) only on-line by logging on to www.cbseneet.nic.in.

Identity Card Number, Date of Birth, Address, Mobile Number, E-mail ID, etc. may be kept ready. For more details about the information to be filled in, candidates may go to link "Replica of Application- 2018" on the website.
- (ii) The candidates have to provide the Aadhaar/Identity details as given below:

- (a) If decided to pay fee through Debit/Credit Card, check the validity of the Card and keep it ready while logging on to website for submitting application form.
- (b) If decided to pay fee through Net Banking/UPI, follow the instructions as communicated during the online processing.
- (c) If decided to pay the fee through e-wallet, follow the instructions as communicated during the online processing.

  - (a) Fill in the on-line application form Step-1 and note down the registration number.
  - (b) Upload images of photograph and signature in JPEG format at Step-2 of the application.
  - (c) Make payment of fee as per available options in Step-3.
  - (d) Take print out of Confirmation page(s) at Step-4 of online application form and preserve it for future reference alongwith copy of proof of fee deposited.
- Open the link "Proceed to apply online NEET (UG) 2018".
- Follow the instructions and complete the process of submission of application form.
- > Kindly follow the instructions carefully and submit the information. At the end of this page, two links "Next and Preview" and "Reset" are given. If you are satisfied that filled in information is correct then Click "Next and Preview" otherwise "Reset". After opening "Next and Preview", information submitted can be checked and if information is correct, go for "Next" otherwise go for "Back".
- After this step the candidates will create password and enter OTP sent on their registered mobile phone. On submission, the Provisional Registration Number of the candidate will be generated and displayed on screen. The Provisional Registration Number will also be sent on the registered E-mail Id and mobile phone of the candidate.
- At this stage the candidate will be given an option to continue filling-up his application by clicking on the link "Continue" or completing the form "Later". If "Later" is selected the candidate can log-in to his account at any time before the last date to complete the application form.

- > By Clicking on the "continue" the candidate may submit the required information and complete the step-1 of application form. At any time during this step the candidate may keep on saving the data filled in the application form. At the end of this step, the candidate may preview the data filled up by them before finally submitting the form.

- (i) The Candidates are not required to send the confirmation page of his/her Online Application form to the Board. However he/she is advised to preserve sufficient copies of the Confirmation Page alongwith the proof of fee paid for any future reference.
- (j) Candidates from State of J & K are required to submit online Self Declaration as indicated in para 3(b) of Chapter-3 for seats under 15% All India Quota. Appendix-III.
- (k) Request for change in any particulars in the online Application shall not be entertained under any circumstances.
- (l) Incomplete Applications shall be rejected.
- (m) Candidates are advised to submit only one Application Form. If a candidate submits more than one Application Form, his/her candidature will be cancelled.
- (n) The candidates should bear in mind that any online transaction password generated on the NEET website while registering/submitting the form will be valid for 15 minutes only. After the lapse of this period, candidates need to click on the link "RESEND" OTP to generate new OTP.

Candidates may please note that if it is found that photograph affixed is fabricated i.e. de-shaped or seems to be manipulated or digitally edited, the form of the candidate will be rejected and the same would be considered as using unfair means practices and candidate would accordingly be dealt with as per the rules of unfair means.
- (b) The candidates are required to upload their signature in the appropriate box given in the online Application Form in running hand writing. Writing full name in the Box in Capital letters would not be accepted as signature and the Application Form would liable to be rejected.
- (c) Ensure that photograph and signature are uploaded in the respective fields.
- (d) The candidates are required to upload their photograph as shown above. The system will allow uploading of photograph with one face only by using the technique of face-detection.
- (e) Further, it is mandatory for the candidate to bring an additional passport size photograph indicating clearly the name of candidate alongwith the date of taking the photograph for affixing it on the specific space in the attendance sheet on the day of examination.

#### 8 INFORMATION REGARDING ONLINE APPLICATION AND FEE

Information related to candidature will be available in the candidate's login account. If confirmation page is not shown in login account, candidates are advised to immediately complete Step-3 of online Application and get the printout of confirmation page (Step-4) to complete the process within the prescribed last date of transaction of fee. The confirmation page is the only proof of payment and Updation of fee in the account of the candidate.

#### 9 ADMIT CARD

The CBSE will provide the facility of downloading Admit Cards of NEET (UG) on the Board's website. Candidates are required to download the admit cards from the website and follow the instructions given therein. Candidate may please note that admit cards will not be sent by post. When candidate will download the Admit Card, a copy of the same in pdf format will also be emailed to the candidate on the registered email id. The Admit Card will bear the candidate's Roll Number, Name, Father's Name, Category, Sub-Category, Photograph, Signature, Date of Birth, Language of Question Paper with Name and Address of examination centre allotted. The candidate should carefully examine the Admit Card downloaded by him/her for all the entries made therein.

#### 10 REQUIREMENT OF AADHAR

Aadhaar was introduced in the year 2017 successfully. 97% candidates registered for the NEET(UG), 2017 with the help of Aadhaar number/Aadhaar Enrolment number/Aadhaar Registration Number. Remaining 3% candidates registered the application form with Bank Account number/Passport number/Ration card number and other Government valid Identity Cards. Accordingly, the same practice is being followed for NEET (UG), 2018.

- (a) The use of Aadhaar for the candidates of NEET (UG)-2018 will result in accuracy of the candidates' details. This will also help in ascertaining identities of the candidates at the examination centres in a convenient and hassle free manner. Aadhaar obviates the need for producing multiple documents to prove one's identity.
- (b) The provisions of the Aadhaar Act and Regulations under the Act have come into effect from 14th September 2016 and notifications to this effect have been published in the Official Gazette. Section 57 of the Aadhaar Act 2016 permits the use of Aadhaar number for establishing the identity of an individual for any purpose pursuant to any law or any contract to this effect.

- (c) Accordingly, CBSE has decided to use Aadhaar for the candidates in NEET (UG)-2018, and notifies the following:
  - i) Candidates, who are in possession of Aadhaar, shall enter Aadhaar number, name, date of birth & gender in online application for NEET (UG)-2018 for the purpose of his/her identity and authentication thereof.
  - ii) Candidates not yet enrolled for Aadhaar, are hereby required to make application for Aadhaar enrolment in case he/she is entitled to obtain Aadhaar as per section 3 of Aadhaar Act. Such applicant may visit any Aadhaar enrolment centre (list available at www.uidai.gov.in) to get enrolled for Aadhaar.
  - iii) In order to facilitate such candidates who are not having Aadhaar, the CBSE has specially set up facilitation centres in each city of examination for the purpose of Aadhaar enrolment. The candidates can approach such facilitation centres who will not charge any amount from any applicant for Aadhaar enrolment. The list of the facilitation centre is available on www.cbseneet.nic.in. These candidates who have enrolled for Aadhaar and have not received Aadhaar should enter 14 digits Aadhaar Enrolment ID (including slash) printed on the Aadhaar enrolment slip at the time of filling online application form for NEET (UG)-2018.
  - iv) In case Aadhaar enrolment facility is not available at the facilitation centres, the candidates should submit a request for Aadhaar enrolment. The facilitation centre will issue a registration number to such candidates. This registration number should be entered by the candidates at the time of filling online application form for NEET (UG)-2018.
- (d) The above provisions shall be applicable in all States except J&K, Assam & Meghalaya as per Aadhaar Act.
- (e) The candidates who have passed or appearing in Class XII examination from the states of J&K, Assam & Meghalaya (if not having Aadhaar) need to enter the passport number, ration card number, bank account number or any other valid Govt. identity number provided they should select the city of examination in these States only.
- (f) NRI candidates if not having Aadhaar, need to enter the passport number.
- (g) Foreign Nationals, Overseas Citizen of India (OCI's) and Persons of Indian Origin (PIOs) need to enter the passport number.

## INSTRUCTIONS TO BE FOLLOWED IN THE EXAMINATION HALL

#### 1 GENERAL

- (a) The Examination Centre will be opened 2 hours and 30 minutes before the commencement of the test. No candidate shall be allowed to enter in the examination centre after 09.30 a.m. Therefore, kindly ensure that candidates must leave home well in advance considering all facts like traffic, location of the centre and weather conditions, etc. Candidates are expected to take their seats immediately after the opening of the Examination Hall.
- (b) The candidate must show, on demand, the Admit Card for admission in the Examination Hall. A candidate who does not possess the valid Admit Card shall not be admitted to the Examination Hall under any circumstances by the Centre Superintendent.
- (c) During the examination time, the invigilator will check Admit Card of the candidates to satisfy himself/herself about the identity of each candidate. The invigilator will also put his/her signatures in the place provided in the Answer Sheet on SIDE-1.
- (d) A seat with a roll number will be allotted to each candidate. Candidates must find out and occupy their allotted seats. If a candidate is found appearing in the Test from a seat or room other than the allotted one to him/her, his/her candidature shall be cancelled.
- (e) A candidate who comes after 09.30 am shall not be permitted to enter in the examination centre under any circumstances.
- (f) Candidates are not allowed to carry any material except the Admit Card and photograph inside the Examination Hall.
- (g) Candidates are not allowed to bring any barred item or any item which could be used in unfair means. Possession of any such article with the candidates inside the centre premises will attract the penalties of unfair practices.
- (h) Candidates are advised in their own interest not to bring any of the barred items (Chapter-11) to the venue of the examination as arrangement for safe keeping will not be made and candidates found in possession of these items will not be allowed entry in the examination centre.
- (i) No candidate will leave his/her seat or the Examination Room/Hall until the Test concludes as per schedule. Candidates should not leave the Room/Hall without handing over their Answer Sheets to the invigilator on duty.
- (j) Smoking in the examination centre is strictly prohibited.
- (k) Water Bottles, Tea, coffee, cold drinks or snacks etc. are not allowed to be taken by the candidates into the examination centre.
- (l) The Test will start exactly at the time mentioned in the Admit Card and an announcement to this effect will be made by the invigilator.
- (m) Before the start of test, some important instructions will be communicated to the candidates by the invigilator for strict compliance by the candidates.
- (n) A signal will be given at the beginning of the examination and at half-time. A signal will also be given before the closing time when the candidate must stop marking the responses.
- (o) The candidate must sign twice on the Attendance Sheet at the specified place, first time immediately after the commencement of examination and second time while handing over the Answer Sheet to the invigilator. The candidates are also required to put their Finger Impressions in the space provided on the Attendance Sheet.
- (p) The candidate will check and ensure that the Test-Booklet contain as many number of pages as are written on the top of the cover page.
- (q) For those who are unable to appear on the scheduled date of test for any reason, re-test shall not be held by the Board under any circumstances.
- (r) The candidates, suffering from Diabetes Type I, may be taken care of at the centre as per the instructions issued by CBSE.

#### 2 THE TEST-BOOKLET

- (a) Fifteen minutes before the commencement of the test, candidates will be given a sealed Test Booklet.
- (b) Immediately on receipt of the Test Booklet, the candidates will fill in the required particulars on the cover page of the Test Booklet with Ball Point Pen provided at the Centre. Candidates will not open the Test Booklet until asked to do so by the invigilator.
- (c) Five minutes before the commencement of the Test, the candidates will be instructed to break/open the seal of the Test Booklet and take out the Answer Sheet carefully. The Candidate should check carefully that the Test Booklet Code printed on Side-2 of the Answer Sheet is the same as printed on Test Booklet. In case of discrepancy, the candidate should immediately report the matter to the invigilator for replacement of both the Test Booklet and the Answer Sheet.
- (d) Candidate will then write particulars with ball point pen on both the sides. After completing this step, the candidate will wait for the signal by the Invigilator to start the test.
- (e) After completing the Test and before handing over the Answer Sheet, the candidate should check again that all the particulars required in the Answer Sheet have been correctly written and marked.
- (f) Candidates should ensure before leaving the Examination Hall that they have handed over the Answer Sheet to the invigilators on duty and that they have **signed on the Attendance Sheet second time also**.

#### 3 THE ANSWER SHEET

- (a) The Answer Sheet will be found placed inside the sealed Test Booklet. The seal will be broken/ opened by the candidate on the announcement by the invigilator and only then the Answer Sheet shall be taken out. **Do not open/break the seal before the announcement.**
- (b) Side-2 of each Answer Sheet will have a pre-printed Test Booklet Code A, B, C and D etc. The candidates are required to check that the Test Booklet Code pre-printed on SIDE-2 of the Answer Sheet is the same as printed on the Test Booklet.
- (c) The format of the Answer Sheet which will be used for answering questions is given in **Appendix-VIII**. Candidates are advised to go through it and be conversant with the requirements of giving particulars and marking the answers.
- (d) The Answer Sheet used will be of special type which will be scanned on Optical Scanner. There will be two sides of the Answer Sheet:

#### SIDE 1

This side of the Answer Sheet contains the following columns which are to be filled in neatly and accurately by the candidate with Blue/Black ball point pen provided at the Centre (Use of pencil on OMR sheet is not allowed. OMR sheet filled in with pencil would be summarily rejected for evaluation):

- (i) Roll Number
- (ii) Name of the candidate
- (iii) Father's Name
- (iv) Centre Number
- (v) Name of the Examination Centre
- (vi) Signature of the candidate

#### SIDE 2

This side of the Answer Sheet contains the following columns which are also to be filled in by the candidate with Blue/Black Ball Point Pen provided by Centre:

- (i) Roll Number
- (ii) Centre Number
- (iii) Test Booklet Number
- (iv) Test Booklet Code
- (v) Question 001 to 180





#### 4 MARKING THE RESPONSES

- (a) Use Blue/Black Ball Point Pen to darken the appropriate circle. Answers marked with pencil would not be evaluated.
- (b) Mark should be dark and should completely fill the circle.
- (c) Darken only one circle for each entry as the Answer once marked cannot be changed.
- (d) A light or faint darkened circle may be treated as a wrong method of marking and may be rejected by the Optical Scanner.
- (e) Mark the responses only in the space provided.
- (f) There will be four alternatives for each of the question numbering 001 to 180. The candidate will indicate response to the question by darkening the appropriate circle completely with Ball Point Pen.
- (g) The responses given by the candidate in the OMR sheet will be evaluated by the method of Optical Mark Recognition by the computer and in case any candidate does not follow the correct method of marking the responses his response may not be recognised by the computer.

If the candidate does not want to attempt any question, he/she should not darken the circle meant to mark the response. Please do not fold the Answer Sheet and do not make any stray mark on it.

#### 5 CHANGING AN ANSWER IS NOT ALLOWED

The candidates must fully satisfy themselves about the accuracy of the answer before darkening the appropriate circle as no change in answer once marked is allowed. Use of eraser or white fluid on the Answer Sheet is not permissible as the Answer Sheets are machine gradable and it may lead to wrong evaluation.

## 6 MERIT LIST AND QUALIFYING CRITERIA

#### 1 ELIGIBILITY CRITERIA

The Central Board of Secondary Education will prepare an All India Merit List of successful candidates of NEET (UG) – 2018 on the basis of the eligibility criteria provided by the Medical Council of India and Dental Council of India as given in Graduate Medical Education Regulations-1997 issued under Indian Medical Council Act-1956 and BDS Course Regulations, 2007 issued under the Dentists Act, 1948. The eligibility criteria are as follows:

- (a) In order to be eligible for admission to MBBS/BDS Courses for a particular academic year, it shall be necessary for a candidate to obtain minimum of marks at 50<sup>th</sup> percentile in National Eligibility Cum Entrance Test to MBBS/BDS Courses held for the said academic year. However, in respect of candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes, the minimum marks shall be at 40<sup>th</sup> percentile. In respect of the candidates with Bench Marked Disabilities specified under the Rights of Persons with Disabilities Act, 2016, the minimum marks shall be at 45<sup>th</sup> percentile for General category candidates and 40<sup>th</sup> percentile for SC/ST/OBC candidates. The percentile shall be determined on the basis of highest marks secured in the All India common merit list in National Eligibility Cum Entrance Test for admission to MBBS/BDS courses.
- (b) Provided when sufficient number of candidates in the respective categories fail to secure minimum marks as prescribed in National Eligibility Cum Entrance Test held for any academic year for admission to MBBS/BDS Courses, the Central Government in consultation with Medical Council of India and Dental Council of India may at its discretion lower the minimum marks required for admission to MBBS/BDS Courses for candidates belonging to respective categories and marks so lowered by the Central Government shall be applicable for the said academic year only.
- (c) To be eligible for admission to the MBBS/BDS Courses, a candidate must have passed in the subjects of Physics, Chemistry, Biology/Bio-technology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry, Biology/Bio-technology at the Qualifying Examination as mentioned in Graduate Medical Education Regulations-1997 as amended in 2018 and BDS Course Regulations, 2007 and in addition must have come in the merit list of National Eligibility Cum Entrance Test for admission to MBBS/BDS Courses. In respect of the candidates belonging to the SC, ST and OBC category, the marks obtained in Physics, Chemistry, Biology/Bio-technology taken in qualifying examination and competitive examination (Physics, Chemistry, Biology) be 40% marks instead of 50%. In respect of the candidates with Bench Marked Disabilities specified under the Rights of Persons with Disabilities Act, 2016, the minimum marks in qualifying examination in Physics, Chemistry and Biology/Bio-Technology taken together be 45% instead of 50% for General category candidates and 40% for SC/ST/OBC candidates.-Provided that 2 years of regular and continuous study of Physics, chemistry and Biology/Bio-Technology taken together shall be required at 10+2 level for all the candidates. Candidates who have passed 10+2 from open schools or as a private candidate shall not be eligible to appear for National Eligibility Cum Entrance Test (UG). Furthermore, study of biology/bio-technology as an additional subject at 10+2 level also shall not permissible. Provided that a candidate who has appeared in the qualifying examination, the result of which has not been declared, he may be provisionally permitted to take up the competitive entrance examination and in case of selection for admission to the MBBS/BDS courses, he/she shall not be admitted to that course until he/she fulfils the eligibility criteria as specified above. For details candidates may refer to Graduate Medical Education Regulations, 1997 and BDS Course Regulations, 2007.

A list of the successful candidates in order of All India Rank based on the score obtained in the examination will be prepared by the CBSE.

#### 2 THE INTER-SE-MERIT OF CANDIDATES FOR TIE-BREAKING

In case of two or more candidates obtaining equal marks in the **NEET (UG) - 2018**, the inter-se-merit of such candidates shall be determined in order of preference as follows:

- (a) Candidates obtaining higher marks in Biology (Botany & Zoology) in the Test.
- (b) Candidates obtaining higher marks in Chemistry in the Test.
- (c) Candidates with less number of attempted wrong answers in all the subjects in the Test.
- (d) Candidates older in age to be preferred.

#### 3 MERIT LIST FOR COUNSELLING UNDER 15% ALL INDIA QUOTA

The merit list of the eligible and successful candidates who have opted for 15% All India quota seats will be prepared by the CBSE on the basis of score obtained in the NEET (UG) - 2018. The list of successful candidates shall be forwarded to **the Directorate General of Health Services (Medical Examination Cell), Ministry of Health and Family Welfare, Government of India** for the purpose of allotment of seats by Online Counselling to 15% All India Quota Seats.

#### 4 MERIT LIST FOR SEATS OTHER THAN 15% ALL INDIA QUOTA

- (a) CBSE will provide All India Rank. Result will be given to the DGHS, Ministry of Health and Family Welfare, Govt of India to provide the same to the Admitting Authorities.
- (b) Admitting Authorities will invite applications for Counselling and merit list shall be drawn based on All India Rank by the Admitting Authorities subject to their applicable rules.
- (c) The admitting/counselling authorities will draw merit list of the candidates in the respective categories declared by the candidates at the time of applying for admission/counselling based on State rules.

#### POST EXAMINATION ACTIVI Chapter ND DECLARATION OF RESULT DISPLAY OF OMR SHEETS AND RESPONSES ON WEBSITE The CBSE will display the images of OMR Answer Sheets and Responses graded by the Machine of all the candidates on the website www.cbseneet.nic.in. For exact date of display the images of OMR Answer Sheets and Responses, candidates may remain in touch with website. (b) Candidates will be given an opportunity to submit representation against the OMR grading on payment of non refundable processing fee of Rs.1000/- per response challenged. (c) Representations made by the candidates against the OMR grading will be verified by the CBSE from the actual record and the same will be updated in the data, if challenge is found correct. However, no intimation in this regard will be sent to individual All candidates are advised to remain in touch with the website www.cbseneet.nic.in for viewing and downloading of his/her answer sheet and responses captured by the machines. 2 DISPLAY OF ANSWER KEY FOR CHALLENGE The CBSE will display Answer Key of the questions giving opportunity to the candidates to challenge in case of any doubt in the answer on the website www.cbseneet.nic.in. For exact date of display of Answer Key, candidates may remain in touch with website. Candidates will be given an opportunity to make online challenge against the Answer Key on payment of non refundable processing fee of Rs.1000/- per answer challenged. Challenges made by the candidates will be verified by the CBSE with the help of its subject experts. If found correct, the answer key will be revised accordingly. Based on the revised Answer Key, result will be prepared and declared. No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge. The key finalized after the challenge will be final. DECLARATION OF RESULT 3 The Central Board of Secondary Education will conduct the NEET(UG)-2018, evaluate the Answer Sheets and the result will be hosted on website www.cbseneet.nic.in. The CBSE will prepare the merit list as per the directives of, DGHS, MCI No category wise result sheet will be prepared. As soon as the result is ready, CBSE will host the results on the website and thereafter candidates may download the Result Sheets. Online counselling would be conducted by the Medical Counselling Committee of the Directorate General of Health Services. Information for online counselling would only be available on Medical Counselling Committee (MCC) website (<a href="www.mcc.nic.in">www.mcc.nic.in</a>). Qualified candidates are advised to read the counselling related information carefully and understand the course of action to be taken by them for appearing in the Counselling. Any query related to 15 % All India Quota, Central Institutions including AFMC, ESI, BHU, AMU and Deemed Universities Counselling may be referred to the following address:

#### 2 COUNSELLING AND ADMISSION OTHER THAN 15% ALL INDIA SEATS:

Candidates wishing to apply for admission in State Medical Colleges/Universities/Institutions using merit list of NEET (UG) - 2018 shall follow the instructions of the State Government and/or authorities of the Medical/Dental colleges/Institution/University concerned for counselling. Counselling for Private Medical Colleges (except Deemed) will be with the respective State Governments.

The admitting/counselling authorities will draw merit list of the candidates in the respective categories declared by the candidates at the time of applying for admission/counselling. The CBSE will not make any change in candidates' data after the opportunity for the same is given. In no case, the change of data submitted by candidate in the online application form shall be made by CBSE, after declaration of result.

In the application form, categories of the candidates have been obtained as per Central Category List. For the counselling and admission on seats other than 15% All India Quota Seats, candidates will register for counselling as per their eligibility by giving the category based on the State category list and merit list will be prepared accordingly by the concerned Counselling Authority.

The domicile criteria would be as per the State concerned and CBSE has no role to play in it.

The list of State Government authorities is placed at **Appendix – IV**.

## UNFAIRMEANS PRACTICES & BREACH OF EXAMINATION RULES

#### 1 **DEFINITION:**

Unfairmeans practice is an activity that allows a candidate to gain an unfair advantage over other candidates. It includes, but is not limited to:

- (a) Having in possession any item or article which has been prohibited in examination centre or may be used for unfair practices including any stationery item, communication device, accessories, eatable items, ornaments or any other material or information relevant or not relevant to the examination in the paper concerned;
- (b) Paying someone to write examination (impersonation) or prepare material for copying;
- (c) Breaching examination rules or any direction issued by CBSE in connection with the conduct of NEET/AIPMT examination from time to time;
- (d) Assisting other candidate to engage in malpractice, giving or receiving assistance directly or indirectly of any kind or attempting to do so;
- (e) Writing questions or answers on any material other than the answer sheet given by the Centre Superintendent for writing answers;
- (f) Tearing of Answer Sheet, any page of the test booklet etc.;
- (g) Contacting or communicating or trying to do so with any person, other than the Examination Staff, during the examination time in the examination centre;
- (h) Taking away the answer sheet out of the examination hall/room;
- (i) Smuggling out Question Paper or its part or smuggling out answer sheet or part thereof;
- (j) Threatening any of the officials connected with the conduct of the examination or threatening any of the candidates;
- (k) Using or attempting to use any other undesirable method or means in connection with the examination;
- (1) Manipulation & fabrication of online documents viz. admit card, rank letter, self declaration, etc.;
- (m) Forceful entry/exit in/from Examination Centre/Hall;
- (n) Use or attempted use of any electronic device after entering the examination centre;
- (o) Affixing/uploading of morphed photograph on the application form/admit card/proforma;
- (p) Erasing or obliterating any information printed on the OMR sheet;
- (q) Providing wrong information on the answer sheet;
- (r) Making fake claim by manipulating the responses in OMR sheet uploaded on website for challenge before or after declaration of result.
- (s) Creating obstacles in smooth and fair conduct of examination.

#### 2 PUNISHMENT FOR USING UNFAIRMEANS PRACTICES:

During the course of examination, before or after the examination if a candidate is found indulged in any of the above or similar practices, he/she shall be deemed to have used unfair practices and booked under UNFAIRMEANS (U.F.M.) case. Such candidates would be debarred for 3 years in future and shall also be liable for criminal action and /or any other action as deem fit.

#### 3 CANCELLATION OF RESULT

- (a) The result of the candidates found indulged in Unfairmeans Practices will be cancelled and will not be declared.
- (b) Similarly, the result of those candidates who appear from the centre other than allotted to them, write on the Test booklet/OMR Sheet of other candidates or allow other candidates to write on their Test Booklet/OMR Sheet will be cancelled and will not be declared.

### INFORMATION FOR PARENTS/GUARDIANS It is expected from parents/guardians to guide their wards appropriately on the following issues before leaving home for appearing in the NEET (UG), 2018: He/She will not be allowed to enter in the examination centre after 09.30 a.m. Therefore, he/she shall leave home well in advance considering all facts like traffic, location of the centre and weather conditions, etc. He/She will follow all the instructions and maintain the discipline in the examination. He/She will not breach any examination rule. He/She will not use and promote any unfair means activity during the examination. In case, he/she finds that if any candidate is using unfair means in the examination, the same may immediately be informed to the invigilators on duty. He/She will bring only the following at the examination centre: Admit Card alongwith passport size photograph affixed on it; One passport size photograph to be affixed on attendance sheet. He/She will not bring any barred item at the centre. He/She will cooperate with the staff at examination centre in frisking. He/She will report at allotted examination centre well in advance to make him/herself available for compulsory physical frisking. He/She will follow the dress code for appearing in NEET Examination. If candidate is wearing customary dress he/she need to report at the allotted examination centre latest by 8.30 AM on the day of examination. In case, your ward is found not obeying above instructions, he/she will not be permitted to enter in the examination centre and will not be allowed to appear in the examination. If your ward is found indulged in any unwanted activities he/she shall be debarred from taking this examination as per rule and shall also be liable for criminal action and/or any other action deemed fit by the Board. A wall clock will be displayed at the main entry point of the examination centre to ensure that no candidate is allowed to enter after 09.30 a.m. The time of the wall clocks in the centre will be set as per the time displayed in the clock available on the NEET website. Candidates are advised to set their clock as per the time displayed in the clock available on the NEET website. Ensure that your ward is reaching to the examination centre on or before 9.30 a.m. on the day of examination. For the same, your ward should leave the home well in advance considering traffic, location of the centre and weather condition etc. It would be appropriate to visit the centre a day before the examination to confirm the location, distance etc. to avoid any problem reaching late to the centre and then not being allowed to appear in the examination.

### BARRED ITEMS AND DRESS CODE

#### 1 BARRED ITEMS:

The candidates are not allowed to carry the following items inside the examination centre under any circumstances. The candidates will be subjected to extensive and compulsory frisking before entering the examination centre with the help of highly sensitive metal detectors.

- (a) Any stationery item like textual material (printed or written), bits of papers, Geometry/Pencil Box, Plastic Pouch, Calculator, Pen, Scale, Writing Pad, Pen Drives, Eraser, Calculator, Log Table, Electronic Pen/Scanner etc.
- (b) Any communication device like Mobile Phone, Bluetooth, Earphones, Microphone, Pager, Health Band etc.
- (c) Other items like Wallet, Goggles, Handbags, Belt, Cap etc.
- (d) All ornaments like Ring, Earrings, Nose-pin, Chain/Necklace, Pendants, Badge and Brooch etc.
- (e) Any Watch/Wrist Watch, Bracelet, Camera, etc.
- (f) Any metallic item
- (g) Any eatable item opened or packed, water bottle etc.
- (h) Any other item which could be used for unfairmeans, for hiding communication devices like camera, Bluetooth device etc.

#### No arrangement will be made at the centres for keeping any articles/items belonging to the candidates.

In case any candidate is found in possession of any of the barred items inside the centre, it will be considered as use of unfair means and action will be taken against the candidate in accordance with the relevant provisions.

#### 2 DRESS CODE:

The candidates are instructed to follow the following dress code while appearing for NEET(UG):

- (a) Light clothes with half sleeves not having big buttons, brooch/badge, flower etc. with Salwar/Trouser.
- (b) Slippers, sandals with low heels and not the shoes.

In case, candidates are coming in customary dress for appearing in the examination, they should report at least an hour before the last reporting time i.e. 9.30 AM, so that they could be frisked properly.

It is desired from the candidates to follow instructions issued by the CBSE strictly, in case of dress code. This will help them in the fair conduct of examination.

One of the biggest concerns of the CBSE is how to provide uptodate information to the aspirant candidates at the earliest and in the easiest manner.

It is considered that if candidates are having proper information, then only they can submit their application form for NEET without any problem. CBSE had made many efforts to provide the desired information to the candidates.

#### The initiatives are as under:-

#### • NEET WEBSITE

Website has been made informative and user friendly so that any candidate can explore the website for easy access of information.

#### • INFORMATION BULLETIN

Information Bulletin has been developed chapter wise so that all related information is available at one place.

#### FREQUENTLY ASKED QUESTIONS

Frequently Asked Questions have been hosted on website. These have been prepared based on the previous years experience on the query raised by the candidates and also based on new information for NEET (UG)-2018.

#### • REPLICA OF THE APPLICATION FORM ON WEBSITE

Replica of the application form has been developed and a link has been given on website with a view that all the candidates before submission of application form will go through the replica, gather the desired information and then submit their application form. This replica is exactly the same as you will see at the time of submission of application form.

#### APPLICATION FORMAT

A format of application has also been developed by giving instructions that what information is to be filled in by the candidates. This format has been uploaded on the website www.cbseneet.nic.in with a view that all the candidates before submission of application form must fill in the same format so that based on the same they can fill their application correctly.

#### • INSTRUCTIONS AT THE TIME OF SUBMISSION OF APPLICATION FORM

A modern method has been used to develop the application of NEET in which candidate will be guided on each step that what information is to be given. Following the online instructions, application could be submitted correctly.

However, it has been observed that despite the above efforts, candidates are not adhering to the instructions given by CBSE which lead to wrong submission of application form. Thereafter, candidates will request the CBSE to rectify the mistake committed by them.

The submission of application has further been upgraded in which candidate can save the draft of application and once, they are certain that information given is correct, application could be submitted by them finally.

The CBSE has put in place a candidates friendly, strengthened Grievance Redressal System to ensure quick redressal of candidates grievances in NEET (UG)-2018. This is the only correct method of getting the grievance redressal. In this system, the candidates will login in their login account with their registration number and password and thereafter they will send their request as per steps given below:-

- 1. Login with given credentials i.e. application no. and password into your account.
- 2. Choose the subjects from the drop-down menu.
- 3. Enter the details of request/grievance in a crisp and clear language not more than 1200 characters.
- 4. The reply of request/grievance can be checked online by the candidate after login, into his/her account afterwards.

Note: Offline requests/grievances or those sent via email by the candidates already registered and desirous of appearing in NEET (UG)- 2018 will not be considered.

- Dynamics of uniform circular motion. Centripetal force, examples of circular motion (vehicle on level circular road, vehicle on banked road).

- Elastic behavior, Stress-strain relationship. Hooke's law, Young's modulus, bulk modulus, shear, modulus of rigidity, poisson's ratio; elastic energy.
- Viscosity, Stokes' law, terminal velocity, Reynold's number, streamline and turbulent flow. Critical velocity, Bernoulli's theorem and its applications.
- Surface energy and surface tension, angle of contact, excess of pressure, application of surface tension ideas to drops, bubbles and capillary rise.
- Heat, temperature, thermal expansion; thermal expansion of solids, liquids, and gases. Anomalous expansion. Specific heat capacity: Cp, Cv- calorimetry; change of state latent heat.
- Heat transfer- conduction and thermal conductivity, convection and radiation. Qualitative ideas of Black Body Radiation, Wein's displacement law, and Green House effect.
- Newton's law of cooling and Stefan's law.

- Force on a current-carrying conductor in a uniform magnetic field. Force between two parallel current-carrying conductors-definition of ampere. Torque experienced by a current loop in a magnetic field; moving coil galvanometer-its current sensitivity and conversion to ammeter and voltmeter.
- Current loop as a magnetic dipole and its magnetic dipole moment. Magnetic dipole moment of a revolving electron. Magnetic field intensity due to a magnetic dipole (bar magnet) along its axis and perpendicular to its axis. Torque on a magnetic dipole (bar magnet) in a uniform magnetic field; bar magnet as an equivalent solenoid, magnetic field lines; Earth's magnetic field and magnetic elements.
- Para-, dia-and ferro-magnetic substances, with examples.
- Electromagnetic and factors affecting their strengths. Permanent magnets.

atoms, stability of half filled and completely filled orbitals.

#### **UNIT III: Classification of Elements and Periodicity in Properties**

• Modern periodic law and long form of periodic table, periodic trends in properties of elements- atomic radii, ionization enthalpy, electron gain enthalpy, electronegativity, valence.

#### **UNIT IV: Chemical Bonding and Molecular Structure**

• Valence electrons, ionic bond, covalent bond, bond parameters, Lewis structure, polar character of covalent bond, valence bond theory, resonance, geometry of molecules, VSEPR theory, concept of hybridization involving *s*, *p* and *d* orbitals and shapes of some simple molecules, molecular orbital theory of homonuclear diatomic molecules (qualitative idea only). Hydrogen bond.

#### **UNIT V: States of Matter: Gases and Liquids**

- Three states of matter, intermolecular interactions, types of bonding, melting and boiling points, role of gas laws of elucidating the concept of the molecule, Boyle's law, Charle's law, Gay Lussac's law, Avogadro's law, ideal behaviour of gases, empirical derivation of gas equation. Avogadro number, ideal gas equation. Kinetic energy and molecular speeds (elementary idea), deviation from ideal behaviour, liquefaction of gases, critical temperature.
- Liquid State- Vapour pressure, viscosity and surface tension (qualitative idea only, no mathematical derivations).

#### **UNIT VI: Thermodynamics**

- First law of thermodynamics-internal energy and enthalpy, heat capacity and specific heat, measurement of  $\Delta U$  and  $\Delta H$ , Hess's law of constant heat summation, enthalpy of : bond dissociation, combustion, formation, atomization, sublimation, phase transition, ionization, solution and dilution.
- Introduction of entropy as state function, Second law of thermodynamics, Gibbs energy change for spontaneous and nonspontaneous process, criteria for equilibrium and spontaneity.
- Third law of thermodynamics- Brief introduction.

#### **UNIT VII: Equilibrium**

Equilibrium in physical and chemical processes, dynamic nature of equilibrium, law of chemical equilibrium, equilibrium constant, factors affecting equilibrium-Le Chatelier's principle; ionic equilibrium- ionization of acids and bases, strong and weak electrolytes, degree of ionization, ionization of polybasic acids, acid strength, concept of PH., Hydrolysis of salts (elementary idea), buffer solutions, Henderson equation, solubility product, common ion effect (with illustrative examples).

#### **UNIT VIII: Redox Reactions**

• Concept of oxidation and oxidation and reduction, redox reactions oxidation number, balancing redox reactions in terms of loss and gain of electron and change in oxidation numbers.

#### UNIT IX: Hydrogen

• Occurrence, isotopes, preparation, properties and uses of hydrogen; hydrides-ionic, covalent and interstitial; physical and chemical properties of water, heavy water; hydrogen peroxide-preparation, reactions, uses and structure;

#### UNIT X: s-Block Elements (Alkali and Alkaline earth metals)

- Group I and group 2 elements:
- General introduction, electronic configuration, occurrence, anomalous properties of the first element of each group, diagonal relationship, trends in the variation of properties (such as ionization enthalpy, atomic and ionic radii), trends in chemical reactivity with oxygen, water, hydrogen and halogens; uses.
- Preparation and Properties of Some important Compounds:
- Sodium carbonate, sodium chloride, sodium hydroxide and sodium hydrogencarbonate, biological importance of sodium and potassium.
- Industrial use of lime and limestone, biological importance of Mg and Ca.

#### **UNIT XI: Some p-Block Elements**

- General Introduction to p-Block Elements.
- *Group 13 elements:* General introduction, electronic configuration, occurrence, variation of properties, oxidation states, trends in chemical reactivity, anomalous properties of first element of the group; Boron, some important compounds: borax, boric acids, boron hydrides. Aluminium: uses, reactions with acids and alkalies.

- Important compounds of silicon and a few uses: silicon tetrachloride, silicones, silicates and zeolites, their uses.

#### UNIT XII: Organic Chemistry- Some Basic Principles and Techniques

- General introduction, methods of purification qualitative and quantitative analysis, classification and IUPAC nomenclature of organic compounds.
- Electronic displacements in a covalent bond: inductive effect, electromeric effect, resonance and hyper conjugation.
- Homolytic and heterolytic fission of a covalent bond: free radials, carbocations, carbanions; electrophiles and nucleophiles, types of organic reactions.

#### **UNIT XIII: Hydrocarbons**

- *Alkanes* Nomenclature, isomerism, conformations (ethane only), physical properties, chemical reactions including free radical mechanism of halogenation, combustion and pyrolysis.

#### **UNIT XIV: Environmental Chemistry**

• Environmental pollution: Air, water and soil pollution, chemical reactions in atmosphere, smogs, major atmospheric pollutants; acid rain ozone and its reactions, effects of depletion of ozone layer, greenhouse effect and global warming-pollution due to industrial wastes; green chemistry as an alternative tool for reducing pollution, strategy for control of environmental pollution.

- Respiration: Exchange gases; Cellular respiration-glycolysis, fermentation (anaerobic), TCA cycle and electron transport system (aerobic); Energy relations-Number of ATP molecules generated; Amphibolic pathways; Respiratory quotient.



### **SPECIFIED DISABILITIES**

### (As per PWD Act, 2016 and as given in amended regulations of MCI)

### 1. Physical disability

- **A.** <u>Locomotor disability</u> (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including-
  - (a) "leprosy cured person" means a person who has been cured of leprosy but is suffering from-
    - (i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity;
    - (ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
    - (iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;
  - (b) "cerebral palsy" means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;
  - (c) "dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less;
  - (d) "muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterized by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue; (e) "acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

### B. Visual impairment

- (a) "blindness" means a condition where a person has any of the following conditions, after best correct-
  - (i) Total absence of sight; or
  - (ii) Visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or
  - (iii) Limitation of the field of vision subtending an angle of less than 10 degree.
- (b) "low-vision' means a condition where a person has any of the following conditions namely:
  - i) Visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
  - (ii) Limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree

### C. Hearing impairment -

- (a) "deaf" means persons having 70 DB hearing loss in speech frequencies in both ears;
- (b) "hard of hearing" means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;
- **D.** "Speech and language disability" means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.
- Intellectual disability, a condition characterized by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behaviour which covers a range of every day, social and practical skills, including-
  - (a) "<u>specific learning disabilities"</u> means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgrphia, dyscalculia, dyspraxia and developmental aphasia;
  - **(b)** "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

3. <u>Mental behaviour</u> - "meantal illness" means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviour, capacity to recognize reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterized by subnormality of intelligence.

### 4. <u>Disability caused due to </u>-

### (a) Chronic neurological conditions, such as-

- (i) "multiple sclerosis" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
- (ii) "parkinson's disease" means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.

### (b) Blood disorder-

- "haemophilia" means an inheritable disease, usually affecting only male but transmitted by women to their male children characterized by loss or impairment of the normal clotting ability of blood so that a minor would may result in fatal bleeding;
- (ii) "thalassemia" means a group of inherited disorders characterized by reduced or absent amounts of haemoglobin.
- (iii) "sickle cell disease' means a hemolytic disorder characterized by chronic anemia, painful events, and various complications due to associated tissue and organ damage; "hemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of haemoglobin.
- 5. Multiple Disabilities (more than one of the above specified disabilities) including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing sever communication, developmental, and educational problems.
- **6.** Any other category as may be notified by the Central Government.

Note: Any amendment to the Schedule to the RPWD Act, 2016, shall consequently stand amended in the above schedule.
