FEE RULES

1. For residential students, fees is payable in three equal installments i.e. in the months of June, August and October by the 15th of the relevant month.
2. For Day Scholars, the fees is to be paid by the 15th of every month.
3. If the 15th of the month in which the School dues are to be paid happens to be a holiday then the payment is to be made on the previous working day.
4. Parents are requested to make all payments by cash or a demand draft drawn in the name of NPS INTERNATIONAL SCHOOL payable at Guwahati.
5. Late fees charges @ 20/- per day for Day Scholars and Rs. 50/- per day for Boarders shall be levied from the 16th of the month in which the school dues have not been paid, till the end of the month. If the dues are not cleared even by that day, the name of the student will be struck off the rolls. Re-admission may be allowed at the discretion of the Director / Principal only after payment of all the dues including Late Fees along with 50% of the existing Admission Fees and subject to availability of a seat in the relevant class.
6. No student whose fees remains unpaid either in full or in part will be allowed to sit for the Board examination.
7. Internal examination results, reports or recommendations to other schools / colleges will not be issued to the student or parent unless outstanding dues are cleared.
- 8. Fees once paid will not be refundable under any circumstances.**

WITHDRAWAL PROCEDURE

1. Parents wanting to withdraw their ward(s) mid-way during the academic session have to pay the fees for the entire session.
2. Mid-session change from residential to day-school status is not allowed. In exceptional circumstances it may be allowed, but in such a case the residential fees for the entire session will be charged.
3. Parents willing to withdraw their ward at the end of the session need to give three months prior written notice to the school (on or before December 31) or else three months fees shall be charged.

DECLARATION / UNDERTAKING

- I/We hereby apply for the admission of my /our ward in Grade to NPS INTERNATIONAL SCHOOL and agree that our child will abide by all the rules and regulations of the School and the CBSE. I/We give permission to the applicant to go on school trips and to participate in regular physical education activities. We further permit our ward to participate in swimming / water sports / adventure sports and commute through school transport at our own risk. We will not hold the school responsible for any casualty / mishap as a result of medical illness / accident that occur in the school campus during school hours including time spent in commuting in the school transport. I/We certify that the above information is complete, true and correct to the best of my/our knowledge. We agree to pay the school fees as applicable from time to time and we understand that fees once paid is neither refundable nor transferable under any circumstances.
- I / We under take that in case my/our ward is given merit cum means based scholarship, i/we shall ensure that my / our ward shall have at least 85% attendance, attend all the tests / exams and shall score at least equivalent to the average score of top 5 students of the class.
- I/We undertake, that if at any stage, it is found to the sanctioning authority that the information given by me is false or if I/We violate the terms and conditions of the scholarship, the scholarship sanctioned to me, may be cancelled and the entire amount of scholarship will be refunded by me or recovered from me, apart from liability for such penal action as warranted by law.
- That I/We shall submit the Birth Certificate (in case of KG to class I) / Original Transfer Certificate (for classes II to XII) of my ward at the time of admission in the school, failing which the decision of the school authorities will be final and binding on me.
