- a) 4% or 16 posts are reserved for Persons with Locomotor Disability (PWD-Orthopaedically) Candidates includes anticipated vacancies..
- b) The number of vacant posts indicated above are provisional as per applicable roster, which may increase or decrease at the time of interview/selection. This is subject to change without any notice.
- c) The waitlist of above category will be operational as per rule.

2. **Eligibility**:

- a) MBBS with PG degree/diploma/DNB in concerned speciality from a recognized university (as well as the speciality recognized/permitted by MCI).
- b) Should be registered with Delhi Medical Council (DMC) or applied for registration (Proof to be enclosed).
- c) The candidate should complete the tenure of PG Degree/Diploma on or before <u>22.02.2019.</u>

3. Pay Scale:

Revised Pay Matrix Level 11 (Rs. 67700-208700/-) under CCS (Revised Pay) Rules, 2016 at entry level. Allowances as admissible will be paid.

4. Age Limit:

- a) Not exceeding 37 years (relaxable by 5 years for SC/ST, 3 years for OBC) as on **22.02.2019**.
- b) Age Relaxation of 10 years for Persons with Disability (PWD). 15 years for SC/ST and 13 years for OBC candidates of PWD.

5. Reservation:

All reservations will be considered in the above posts strictly in accordance with prescribed norms/rules.

- a) SC/ST candidates to submit copy of community/caste certificate.
- b) OBC candidates should submit OBC Certificate as per given format of Govt. of India (Annexure –II) having date of issue on or after 01.04.2016 vide OM No. 36036/2/2013-Estt.(Res-I) dated 31.03.2016 of DOPT, Ministry of Personal & Public Grievance & Pensions, New Delhi.
- c) Persons with disability (PWD) to produce/submit a certificate issued by a competent medical authority.
- d) For reservation of Persons with Disability (PWD) 4% of the total sanctioned seat i.e. 16 seats are reserved for the candidates. This is subject to condition that not more that 4% reservation to PWD candidates will be given in anyone department.

6. Terms & Conditions:

- a) Application should be <u>accompanied by a Demand Draft of Rs. 800/- for Unreserved & OBC Candidates [non refundable]</u>, issued after the date of advertisement, drawn on a scheduled bank in India, in favour of Pay & Accounts Officer, Dr. R.M.L. Hospital, New Delhi payable at New Delhi. SC/ST candidates and Persons with Disability (PWD) candidates are exempted.
- b) It must be ensured by the candidates that Application in prescribed form (Annexure-I) along with latest passport size photograph along Self attested copies of all documents should be delivered/received, either through post or by hand, at the Central Diary and Dispatch Section, Near Gate No. 1, Dr. Ram Manohar Lohia Hospital, New Delhi latest by 22.02.2019.
- c) The Hospital will not be responsible for any Postal delay.
- d) Incomplete application in any respect will not be considered. All previous applications received in this hospital will be treated as cancelled and only application in response to this Advertisement in the Prescribed form (Annexure-I) will be considered.
- e) The list of rejected candidates, after screening of applications, will be displayed on the Hospital website (www.rmlh.nic.in)/notice board of the HA.II Section latest by 18.03.2019. All representations regarding rejection should be received in the Section latest by 22.03.2019 till 4:00 P.M. No representation will be entertained after the date mentioned above.
- f) Crucial date of determination of eligibility with regard to age will be **22.02.2019**.
- g) The selection will be based on written examination and Interview.
- h) The schedule of written examination will be mentioned on the Admit Card.
- i) The Admit Card will be uploaded on hospital website only (www.rmlh.nic.in).
- j) OBC Candidates should submit the OBC certificate as per Annexure-II with required validity as mentioned at para 5 (b) above.
- k) The tenure of Senior Resident is for 03 (three) years including any service rendered earlier as Senior Resident on ad hoc/regular basis in any govt. institution. Under no circumstances, the total period of Senior Residency shall exceed three years, at the time of Joining PGIMER & Dr. Ram Manohar Lohia Hospital. The appointment will be initially for the

- period of one year, which could be extended for a period of three years on annual basis, subject to the satisfactory work and conduct report.
- I) Delhi Medical Council registration is mandatory at the time of interview.
- m) Other service conditions will be applicable as per service condition prescribed from time to time by the Government of India.
- n) The candidate who is already in Govt. Service should submit No Objection Certificate from the present employer.
- o) Inter hospital/Inter Institutional transfer shall not be permitted.
- p) The candidates must submit the copy of following documents (self-attested) along with application form. They should bring the original certificates at the time of interview:

 - 8) Delhi Medical Council (DMC) Registration Certificate for PG/ Acknowledgement.
 - 9) Proof of publication/presenting paper in conference/Case Report.
 - 10) Caste/Community/Disability Certificate where applicable.
 - 11) OBC Certificate only as per Annexure-II with with required validity as mentioned at para 5 (b) above.
 - 12) NOC from present employer (if employed).
- q) The candidates must submit the application in the prescribed form (Annexure-I) and paste recent passport size photograph on it. All the documents must be self-attested including his/her photograph on the application form.
- r) The candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement.
- s) The competent authority reserves the right to verify the authenticity of the Certificates submitted. If found incorrect, the candidature will be cancelled without any further notice
- t) In case the number of eligible candidates who qualifies in the written examination is high, the hospital may shortlist the number of candidates to be called for interview.
- u) Jurisdiction of Dispute: In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi only.
