## **FEE WAIVER SCHEME**

## FOR SESSION 2011 -12 FOR ADMISSION TO B. TECH. / B. ARCH. / B. PHARM / BHMCT COURSES

BEFORE APPLYING UNDER THIS CATEGORY PLEASE GO THROUGH THE GUIDELINES. IN CASE OF FALSE INFORMATION THE CANDIDATURE OF AN APPLICANT SHALL BE CANCELLED.

- 1. Candidates should logon to <a href="www.ptu.ac.in">www.ptu.ac.in</a> for registration and choice filling as per schedule.
- 2. Click on to new registration.
- 3. Before you proceed to register yourself for counseling you must ensure that you have read and understood the eligibility criteria for fee waiver scheme.
- 4. Student should fill his/her basic details like Name, Father's Name, DOB, AIEEE Roll Number, AIEEE Rank (where applicable), NATA Scores (where applicable), aggregate of qualifying examinations, Address, State, City, Contact No. very carefully.
- 5. Student should fill his/her Academic Qualification, marks very carefully.
- 6. Choose your password at least 6-10 characters. Please remember your password and don't share with others.
- 7. Before final submission of online Registration form, Read the declaration given in the website carefully and give your consent on it, failing which you will not be able to complete your registration. So you must check your information details carefully before final submission of your registration form.
- 8. Please Note that after successfully submitting the Registration form. Student will get a SMS that will ensure his/her registration successfully with a Registration No. and Password. For this student should provide valid mobile number.
- 9. **Counseling Fee** to participate in Fee waiver Counseling

Candidate are required to deposit a counseling fee of Rs. 3000/- by following ways:

- Log into www.ptuonline.in
- Fill the respective information.
- Select from any designated Banks as listed in the website where the candidate intends to deposit his/her counseling fees through cash.
- Take a printout of the E-Deposit Slip
- Deposit cash in the respective Bank.
- **Note :** 1. Candidates need not to deposit the fee again if deposited earlier for couselling other than fee waiver scheme.
  - 2. No manual cash deposit slip shall be entertained in any of the above mentioned banks.
  - 3. Only those candidates will be able to participate, who have deposited the counseling fees on time.

## 10. CHOICE FILLING

(a) After successful login, candidate's homepage is opened and following options are displayed:

**Registration Details:** Registration Detail is important for seat allotment and should be filled very carefully.

**Edit Registration**: Any mistake can be corrected in the above through "Edit Registration" option before final freezing of registration form.

**Available Choices:** System will provide the List of Colleges and branches thereof. **Fill Choices:** candidate can fill the college or branches of choice in order of preferences. It is in the interest of the candidate to fill maximum available choices of colleges and branches. Candidate can also alter the filled information.

(b) Allotment of seat: After the choice filling period is over, all filled choices of all Registered candidates will be considered for allotment of seats as per merit (Rank) Category of the candidate and Rules approved by PTU.

## 11. CHOICE FILLING

(a) After successful login, candidate's homepage is opened and following options are displayed:

**Registration Details:** Registration Detail is important for seat allotment and should be filled very carefully.

**Edit Registration**: Any mistake can be corrected in the above through "Edit Registration" option before final freezing of registration form.

Available Choices: System will provide the List of Colleges and branches thereof

**Fill Choices:** candidate can fill the college or branches of choice in order of preferences. It is in the interest of the candidate to fill maximum available choices of colleges and branches. Candidate can also alter the filled information.

- (b) Allotment of seat: After the choice filling period is over, all filled choices of all Registered candidates will be considered for allotment of seats as per merit (Rank) Category of the candidate and Rules approved by all Universities.
- **Result Declaration:** On the date of result declaration, candidate can take printout of Provisional allotment letter of college / Branch by logging into his / her account from the website <a href="www.ptuonline.in">www.ptuonline.in</a> The allotment of seat is purely provisional and subject to verification of original certificates and payment of college fee etc, at the time of reporting in the allotted institute.
- Candidates are required to report to their respective allotted institutions within the Specified period (as per the counseling schedule) along with the documents/testimonials/certificates and pay college fee as prescribed. If candidates do not report within the specified period, their allotted seats shall be cancelled and that seat will be offered to the candidate amongst the available merit listed students already registered.
- 14. The Detailed regarding the total number of seats in a particular college is available on the website
- 15. Total number of seats shall be 5% over and above the sanctioned intake of the course.
- 16. The eligibility criteria in respect of a particular course will be same as notified in the Information Brochure of PTU.
- 17. Candidates whose parent's annual income is less than Rs. 2.50 lakh from all sources shall only be eligible for seats under this scheme. The certificate in this regard should be issued by the competent authority. No other affidavit / certificate shall be accepted. Certificate to be produced at the time of reporting at the allotted college, failing of which seat will be cancelled.

For proof of income the following documents will be considered:

(a) Income certificate from the Head of the Department / Employer in case of serving parents / Income Tax Return in case of businessman / DC's certificate based on income from landed properly

- (b) Self-declaration of total family income attested by Executive Magistrate.
- 18. The waiver shall be limited to the tuition fee as prescribed by the state government all other fee except tuition fees will have to be paid by the beneficiary.
- 19. In the event of non availability of students in this category. The same shall not be given to any other category of applicants.
- 20. Student admitted under this scheme and such a beneficiary shall not be allowed to change institution or course under any circumstances. In case a selected beneficiary intends to forego the benefit of fee waiver to take admission in any other category he shall be allowed to do so provided
  - (a) he / she has to surrender his / her seats, in writing to the , in admission Cell of the University before 25<sup>th</sup> June, 2011 and inform to the concerned institute.
  - (b) that the seat vacated by him shall go to the next eligible candidate under this scheme only.
- 21. The fee waiver to a student shall be for the complete duration of the course.
- 22. The student availing fee waiver seat will not be entitled to avail financial assistance under any other Government Scheme what so ever. However, he / she shall be eligible for any scholarship available on competition / merit basis.
- 23. The implementation of this scheme shall be subject to any amendments / charges or orders of the State Government as may be issued from time to time
