
REGARDING REGISTRATION OF BACK SUBJECT (S) FOR SPECIAL EXAMINATION: 2017-18

In terms of the decision taken in the Academic Council in its meeting held on 20.01.2018, all Principal and Directors of Constituent and Affiliated Colleges offering B.Tech, B.Pharm, B.Arch, MBA and MCA Programmes are hereby informed that the Web Portal for registration of Subject (s) for Special Examination: 2017-18 will open from 26.06.2018 to 30.06.2018 (Without Fine) and 02.07.2018 to 05.07.2018 (With Fine). Beside, the University as per the directive issued by the Council of Architecture and subsequent discussion / decision taken in the Academic Council meeting held on 21.06.2018, no Special Examination will be conducted for 1st to 6th Semesters of B. Arch Course.

- Students, those who are not eligible for award of degree as per Academic Regulations due to securing "F" Grade (s) in Subjects after appearing in the End Semester (Regular and Back) Examination and or Special Examination, are eligible to register for the Special Examination: 2017-18.
- Students registered for regular 7th Semester and 8th Semester Examination but did not appear or appeared less than three theory subjects in these examinations, are not eligible to register in the Special Examination.
- Students, those who did not register for Regular 7th Semester and 8th Semester Examination, are not eligible to register in the special examination.

However, students awaiting for publication of Back or Re-checking / Evaluation Results (s) shall be required to register, and such subject (s) registered shall be electronically de-registered in the event, he / she secure pass mark on the last dates of registration. The Colleges will refund the Back subject (s) registration fees to the candidate (s) in the event he / she clear the registered paper after publication of Back / Re-Checking / Evaluation Results.


