



## 8.13 DOCTOR OF PHILOSOPHY (Ph.D.) IN PHYSICAL EDUCATION

This University offers Full-time Regular Ph.D. Programme in Physical Education. This programme is governed by the University Ordinance for the Doctor of Philosophy in Physical Education.

## 8.14 Ph.D. NUMBER OF SEATS : 20

The exact number of seats could fluctuate depending on the availability of Supervisor/s in specialty area/s such as: Physical Education Pedagogy, Health Education, Exercise Physiology, Sports Biomechanics, Sports Psychology; Sports Medicine; Statistical / Mathematical Modeling etc. Reservation in seats shall apply as per UGC/Government of India notification.

## 8.15 PROCEDURE TO APPLY AND IMPORTANT DATES

Application for admission in Ph.D. must be in the prescribed form which is available inside the Prospectus. Cost of prospectus cum application form is Rs. 800/- (Rs. Eight hundred only). Candidates willing to obtain Prospectus by post may write to Registrar, LNUPE, Shaktinagar, Racecourse Road, Gwalior – 474 002 (M.P.) with a DD of Rs. 900/- (payable in favour of Registrar, LNUPE at Gwalior). Application may also be downloaded from University website and the same may be sent to the Registrar, LNUPE, Gwalior alongwith a Demand Draft of Rs. 800/-. Application form duly filled in alongwith necessary documents should be sent to the Registrar, LNUPE under registered cover or handed over personally at the University Office before the last date mentioned for the course. Incomplete application form or without necessary documents shall be rejected and no further communication shall be entertained. **Further all candidates appearing in the admission test should bring a DD of Rs. 200/- as testing fee without which they shall not be permitted to appear in the test.**

## **8.16 ELIGIBILITY**

Applications are invited for admission in Ph.D. Program through Research Eligibility Test, to be herein after referred as RET, followed by Interview for the session 2012-13. To appear in RET, a candidate must have passed Master Degree in Physical Education (M.P.Ed.) or its equivalent degree from recognized University/ Institute in India or abroad with at least 55% marks(50% for SC/ST ) or equivalent grade. The RET examination will include the course content of M.P.Ed. level. The syllabus of RET is given in **ANNEXURE-XV**. The test shall have objective questions with the under mentioned breakup of marks:

### **8.16.1 Direct Admission**

A Candidate who fulfills following conditions may be considered for direct admission for the Ph.D. Programme however appearance in interview shall remain a mandatory requirement for admission to course work.

**8.16.1.1** A candidate who is a recipient of National Doctoral Fellowship or other fellowships from government/semi-government organizations (through All-India selection procedure conducted by the agency/organization for award of research fellowships) such as Council of Scientific and Industrial Research (CSIR), or University Grants Commission (UGC).

**8.16.1.2** A International national who is a recipient of fellowship by Indian Council for Cultural Relations (ICCR), Government of India and who is sponsored by his/her Government, subject to fulfilling condition as mentioned in clause II (a) of University Ordinance.

**8.16.1.3** A self-financing International national who is admitted through the Embassies /High commission of his/her country or admitted under a MoU with due clearance from the Indian Mission abroad. As per revised guidelines/ instructions of the Department of Higher education. MHRD, GOI on grant of research visa, the foreigners who desire to undertake research in India, Should therefore, apply to the concerned Indian Missions abroad with the brief synopsis of the research project to be undertaken in India, in India. The details of places to be visited, previous visits, whether the scholar has secured admission into a recognized or reputed institution and evidence of financial resources, subject to fulfilling condition as mentioned in clause II (a) of university ordinance.

**8.16.1.4** Recipients of JRF from UGC and / or M.Phil candidates shall be awarded 10% bonus marks in RET.

**Note:-** The Research Entrance Test (RET) shall be compulsory for all candidates, if numbers of applications are more than the number of notified vacancies.



### **8.17 RESEARCH ELIGIBILITY TEST (RET)**

- 8.17.1 Candidates must score minimum of 55% marks in RET, to be considered for admission to Course work. Admission to PhD programme will be made according to merit from the qualified candidates considering the available seats in various specialty areas for the academic year.
- 8.17.2 Number of seats for an academic year will be notified by the University in the prospectus or advertisement as well as on website well in advance.
- 8.17.3 A relaxation of 5% marks for SC/ST candidates will be given in the RET for minimum qualifying marks.
- 8.17.4 All qualified candidates in RET shall appear in an interview organized by the Department of Research Development and Advanced Studies of the University and only the qualified candidates shall finally be admitted to the course work.

### **8.18 PROCEDURE FOR ADMISSION IN COURSE WORK**

Selected candidates on the basis of merit in the RET and direct admission under clause II (b) will be considered for admission into Ph.D. programme on compliance of following:-

- a. Admission Fees for course work to be paid as given in **ANNEXURE VII**.
- b. A No objection, Certificate from the Head of Institution, where he/she is an employee, on a prescribed form (for in –service candidates only)
- c. Proof of Sponsorship/Fellowship /Clearance from embassy (High commission) in case of scholar from International country.
- d. Certificate of NET/JRF/SLET/Full time regular M.Phil. Programme.

### **8.19 COURSE WORK**

- 8.19.1 Candidates admitted to Ph.D. Programme shall be required to undertake regular course for a minimum period of one semester of about six months.
- 8.19.2 The course work will include Research methods, quantitative and qualitative analysis, Computer Application and Extensive reviews of latest research work in the field of Physical Education.
- 8.19.3 The course content which may also include laboratory work, conducting/Participation in workshop, seminar and conducting micro projects, etc.
- 8.19.4 The candidate should follow attendance rules of the University.
- 8.19.5 At the end of the semester, candidates shall appear in examination and must qualify with a minimum of 55% marks.

**8.20 ATTENDANCE**

All PhD scholars shall be expected to put in hundred percent attendances, however they shall be entitled to 30 days of personal leave in an academic year. The registration may be cancelled if the scholar is found short of attendance.

**8.21 AWARD OF Ph.D. DEGREE**

After the submission of thesis, the thesis shall be sent to two examiners for evaluation. Viva-voce Examination will be conducted and successful candidates will be awarded Ph.D. Degree in Physical Education.
