Two-Year Post Graduate Programme in Management (PGP) 2012-14 Batch at RAS AL
KHAIMAH (RAK), UAE Commencing in September 2012
Admission Procedure

1. Minimum Eligibility requirements for the programme

The candidate must hold a Bachelor's Degree, with at least 50% aggregate marks or equivalent CGPA awarded by any of the Universities that are recognised by Association of Indian Universities (AIU) or possess an equivalent qualification recognized by the Ministry of HRD, Government of India. The percentage of marks obtained by the candidate in the bachelor's degree would be calculated based on the practice followed by the University/Institution from where the candidate has obtained the degree. In case the candidates are awarded grades/CGPA instead of marks, the conversion of grades/CGPA to percentage of marks would be based on the procedure certified by the university/ institution from where they have obtained the bachelor's degree. In case the University/ Institution does not have any scheme for converting CGPA into equivalent marks, dividing the candidate's CGPA by the maximum possible CGPA and multiplying the result with 100 would establish the equivalence. Candidates appearing for the final year of bachelor's degree/equivalent qualification examination and those who have completed Bachelors Degree requirements and are awaiting results can also apply. However, the candidates who are appearing for final year examination should have 50% aggregate marks or equivalent grades up to pre-final year. In addition to 50% aggregate marks at Bachelor's Degree, candidates meeting the following criteria are eligible to apply. **Meeting the minimum eligibility does not guarantee final selection.**

- a. Minimum of 85.00 overall percentile score in CAT 2011 **(OR)**
- b. Minimum of 600 overall score in GMAT (GMAT score obtained during January 1, 2011 and June 15, 2012 is only valid)

2. How to Apply?

Candidates seeking admission to the two-year PGP of IIM Indore at RAK, UAE should apply online on or before, June 20, 2012

3. Admission Process and Selection Criteria

The admission process will be consisting of two-stages. Eligible candidates will be called for a short duration Written Ability Test (WAT) and Personal Interview (PI) based on their academic record, performance in CAT 2011 /GMAT. Final selection to the PGP would be based on criteria, such as the candidate's academic record, scholastic achievements, relevant work experience, and performance in CAT 2011/GMAT, WAT and PI.

However, IIM Indore reserves the right to change the criteria at its discretion. WAT and PI will be conducted at Bangalore, Chennai, Delhi, Hyderabad, Indore, Kolkata, Mumbai and Ras Al Khaimah (RAK), UAE. IIM Indore reserves the right to change the centers at any time if the situation so warrants. Candidates with valid CAT2011/GMAT scores short-listed for WAT and PI will be intimated around June 30, 2012 along with their centers. **Individual regret letters will not be sent to candidates those who are not shortlisted/selected.**

5. Programme fee

The programme tuition fee is Rs. 9.75 Lakhs per annum (payable in US\$) and is payable at the beginning of the academic year. Security deposit is US\$1000 refundable at the end of the programme. Tuition fee include limited study material. Examination fee is US\$ 500 per year. Hostel fee and VISA fee is additional.
