- 2. THE PROVISIONAL CERTIFICATES OF THE PASSED CANDIDATES WILL BE SENT ALONG WITH THEIR MARKS STATMENTS WHO OWES NO DUES TO SCHOOL OF DISTANCE EDUCATION. THEY NEED NOT APPLY SEPARATELY.
- 3. HOWEVER, CANDIDATES WHO OWES DUES BY WAY OF TUTION FEE ETC., HAVE TO CLEAR THE SAME TO GET THEIR PROVISIONAL CERTIFICATES.
- 4. THE MARKS STATEMENTS OF THE CANDIDATES OF SCHOOL OF DISTANCE EDUCATION WILL BE SENT DIRECTLY TO THE CANDIDATES TO THE ADDRESSES FURNISHED.
- 5. DUPLICATE MARKS LISTS AND PROVISIONAL CERTIFICAE WILL NOT BE ISSUED WITHIN 30 (THIRTY) DAYS FROM THE DATE OF THE PUBLICATION OF THE RESULTS.
- 6. THE REQUISTION FORM FROM THE CANDIDATES FOR RE-VALUATION OF THEIR SCRIPTS SHALL BE ADDRESSED TO DEPUTY REGISTRAR (EXAMS), SCHOOL OFDISTANCE EDUCATION, ANDHRA UNIVERSITY, VISAKHAPATNAM AND REACH HIM WITHIN A PERIOD OF 30 (THIRY) DAYS FROM THE DATE OF DESPATCH OF MARKS AFTER PUBLICATION OF THE RESULTS AT THE OFFICE OF THE SCHOOL OF DISTANCE EDUCATION.
