### ORDER

A committee has been constituted for the preparation of draft guidelines for the Assistanceship for M.Tech for Non Gate students and its application for the Non Gate Scholarship with the following members.

As per reference 3<sup>rd</sup> Prof. V. Santhakumari, Senior Joint Director (ECS) has submitted a detailed proposal for prescribing the guidelines Assistant ship of M. Tech for Non Gate Students. The proposal has been examined and approved as detailed below.

### Assistantship for M.Tech for Non-Gate Students

Teaching and Research Assistantship will be provided to the Non-Gate M.Tech students under the scheme of Research Scholarship in all Government Engineering Colleges. The Assistantship shall be starting from the month of joining the institution for 1<sup>st</sup> year students and from April, 2012 onwards for II year students. The amount of the assistantship will be Rs.8000/-per month. The guidelines are similar to the guidelines of GATE Scholarship. This scholarship is for the financial year 2012-2013 only.

### **ELIGIBILITY CRITERIA**

All the regular students, enrolled under various M.Tech programes in all Government Engineering Colleges as per the prevailing institute norms and regulations, are eligible for the assistantship subject to the fulfillment of following conditions.

- 1. The student must be Indian National only.
- 2. The student must be enrolled under Regular (Full-Time) M.Tech programme only. But she/he must be non-sponsored candidate. In the event of his/her conversion from full time to part-time, the assistantship shall be ceased to continue forthwith without any intimation.

- 3. Students who are receiving assistantship from the institute or from any other funding agencies, will not be considered for this assistantship.
- 4. The students who are receiving assistantship will be required to devote 8-10 hours per week as teaching/research assistant in their respective departments. This could include tutorials, laboratory classes, development and maintenance of laboratories, assistance in research and development activities undertaken by faculty members, maintenance and operation of computers, development of software and other central facilities. The HOD will certify the engagement of each of the student for the release of the assistantship every month.
- 5. Scholarship will be disbursed subject to the production of satisfactory attendance and progress report duly certified by HOD on every month.
- 6. The student must abide by CONDUCT RULES of the institute for the M.Tech programme. If any disciplinary action is taken by the institute authority against a student, his/her assistantship shall be discontinued from the date of effect of such order. The institute authority shall be requested to intimate such order (for M.Tech students) to the Directorate of Technical Education.
- 7. The selection of candidates for scholarship is purely on the basis of merit (The total marks obtained for the entire UG Programme).
- 8. 15 students of First Year class and 19 students of second year class will receive the assistantship for this financial year.
- 9. Reservation of scholarship to SEBC&SC/ST is as follows.

| <u>First Year</u> | Second Year |
|-------------------|-------------|
| SEBC -1           | SEBC -1     |
| SC/ST -2          | SC/ST -3    |

In the absence of candidates in the above categories, the scholarship will be distributed to general candidates of the same year.
