## **CHRISTIAN DENTAL COLLEGE, LUDHIANA**

The Christian Medical College, Ludhiana Society (Regd.) is a Christian Educational and Research Institution established, maintained and administered by Christian Churches and Christian agencies in India.

The Christian Dental College, Ludhiana is an educational institution of an all India character established and run by the minority Christian community. The primary aim of Christian Medical College Ludhiana Society is to educate and train men and women as health professionals for the healing ministry of the churches in all parts of India, especially in the rural areas. Like many other Christian educational institutions, Christian Dental College, Ludhiana also offers educational and training facilities to young men and women irrespective of their religion and community.

The Dental Department has been providing dental health care services in the Hospital and the community at large since 1966.

In 1968 a missionary - Dr J.J Fason, Dental Surgeon came from USA to join the faculty of Christian Medical College with a vision to start a modern dental clinic in this part of North India. Dr. Fason took the dental department to its new heights in four years. In January 1972 he left India after giving the responsibility of the Dental Department to Dr. J.L. Joshi who joined Christian Medical College in January 1971.

Besides providing high quality tertiary care in the hospital, the dental department launched its unique community dental health services in 1984 to rural areas reaching out primarily to the vulnerable population and children through a mobile health van, donated by the Government of India, which was converted

into a mobile dental van.

The Christian Dental College, Ludhiana was established in 1992. It admitted the pioneer batch to the BDS course in August 1992. The College is affiliated to Baba Farid University of Health Sciences, Faridkot. The Christian Dental College, Ludhiana started the MDS course in the subject of Pedodontia & Preventive Dentistry w.e.f. session 2002-2003.

Each year 4 students are admitted to the Postgraduate course of the college. All admissions are made on merit.

#### **Category A candidates:**

Those who are of the Christian Minority, who are sponsored by any of the sponsoring agencies which are a part of the Christian Medical College Ludhiana Society (list enclosed in annexure). Candidates selected in this category are required to enter into a service agreement with the respective sponsoring body/church, without which admission will not be granted. Service agreement is for a minimum period of two years after completion of the course in a hospital or institution managed by the member body/church. Such candidates must also fulfill the eligibility criteria given below.

## ADMISSION REQUIREMENT

### 1. Academic :

- a) Applicants must have passed the Final Professional BDS Examination of a recognized university and have completed 12 months paid compulsory rotating internship program (as prescribed and approved by Dental Council of India) by 31st March 2013. No condonation of Internship of 12 months period shall be accepted except for the students of the batch admitted during the academic session 2007-2008 and have completed 4½ year BDS Course along with 6 months compulsory rotating internship.
- b) An Indian national studying in Foreign University/ School must produce an eligibility certificate recognizing the qualifying examination as equivalent to BDS as recognized by the Baba Farid University of Health Sciences and Dental Council of India. This may be obtained from the Registrar, Baba Farid University of Health Sciences, Faridkot-151 203 Punjab, and the Secretary, Dental Council of India, Aiwan–E-Galib Marg, Kotla Road, New Delhi 110 002.

### 2. Registration

Applicants must be registered with the State Dental Council /Dental Council of India.

### 3. Nationality

Applicants must be Indian Nationals

### 4. Rotating Internship Program

An applicant must have completed 12 months paid compulsory rotating internship by 31st March 2013. A certificate to this effect must be submitted along with application form from the Principal of the concerned Dental College.

### 5. Service Obligation

The primary aim of the Christian Dental College, Ludhiana is to make a significant contribution to the health standards of all communities of our nation with a special emphasis on health care in the rural underserved and unreached areas/communities in India. This mandate is fulfilled by graduates who fulfil their sponsorship obligation by serving in such areas, understanding the needs of the society. A sponsored applicant, who has completed service agreement with regard to his/her BDS sponsorship obligation, should submit a certificate to this effect from the sponsoring body/church or the authority concerned. Certificate should state the period and place(s) of service. Applicant should have completed minimum of two years of service obligation by 31st March 2013. Non fulfilment of service obligation violates the spirit of sponsorship.

**\* Candidates who have not completed their service obligation for two years for any reason and those who have been released from the service obligation prematurely will not be eligible to apply for post graduation in CDC Ludhiana.**

\*Candidates who have not completed 2 years of satisfactory service obligation by 31st March 2013 will not be eligible for admission.

## 6. Category A & B

All Christian applicants applying under this category must provide Photostat copies of the following:

- a) Baptism certificate
- b) Letter from Pastor regarding church membership with dates
- c) An affidavit that the candidate will complete the service commitment as required by the CMC Ludhiana Society. (For category A only), Format given on page 26 for category A

***The original certificates must be available at the time of checking of original certificates.***

## HOW TO SUBMIT APPLICATION

Every candidate will be required to log on to ‘Admissions 2013’ on the institutional website [www.cmcludhiana.in](http://www.cmcludhiana.in). Click on link ‘MDS 2013’, register yourself as a new user and log in. Please note your application number and follow the instructions given there.

1. **The online application form must be filled and submitted online (mandatory).**

**A recent passport size photograph (preferably of a minimum size of 295 x 356 pixels) should be uploaded in the space provided. On submission of this form, an application number will be assigned which must be quoted in all future correspondence.**

2. **Form 100 (Application form) and Form 99 (Application for additional Marks, if applicable), must be downloaded, printed and filled. This along with relevant enclosures and requisite fee must be posted to ‘The Registrar’, Christian Medical College Ludhiana-141008, Punjab.**

**Acknowledgement of online submission alone does not indicate acceptance of application and has no bearing on the admission. Acceptance follows receipt of Application form, enclosures and demand draft (by post/courier/hand delivery) in the office of the Registrar before the last date of submission and subsequent verification. In the event the application form with enclosures and demand draft does not**

**reach the office of the Registrar before 3rd January 2013, the application stands cancelled.**

**Receipt of Admit Card does not mean that the applicant has met all the eligibility criteria for admission but indicates only eligibility to appear in the examination.**

A completed application for the postgraduate program consists of the following:

5. Application fee - A bank demand draft for Rs. 3300/- ( Rupees Three Thousand Three Hundred Only) drawn in favor of "Christian Medical College Ludhiana Society" on any scheduled bank payable at Ludhiana. Please quote name and application number behind the demand draft.

- Registration Certificate with State Dental Council / Dental Council of India

- Service obligation completion certificate from the sponsoring body/church of the authority concerned (if applicable)
- An affidavit that the candidate will complete the service commitment as required by the CMC Ludhiana Society. (For category A only), Format given on page 26.
- Admit card with Photograph will be generated through the online application after verification of enclosures. The admit card will be available for print from [www.cmcludhiana.in](http://www.cmcludhiana.in) on login using valid user ID and Password. Kindly ensure a valid email id is submitted. The institution will not be responsible for invalid email ID's.

*In the event the admit card is not received by 7<sup>th</sup> January, candidates are requested to contact the office of the Registrar.*

**ONLY PHOTOCOPIES ARE TO BE SENT WITH APPLICATION FORMS. ALL THE ABOVE DOCUMENTS, IN ORIGINAL, ARE NEEDED AT THE TIME OF COUNSELLING.**

In addition the following original documents, for Christian Candidates, must be submitted at the time of counselling- A Photostat copy of Baptism certificate, confirmation

certificate (if applicable) and letter from Pastor stating your Church membership. for Christian candidates applying in category A, Affidavit of Service (as mentioned above) and Sponsorship Letter from the Authorized Signatory of the Sponsoring Agency.

The last date for submission of application form is 03.01.2013 till 5.00 pm. Any incomplete application will be rejected.

The printed & completely filled application may be submitted at the Registrar's Office counter or be sent by registered post / speed post / courier, addressed to the **REGISTRAR, CHRISTIAN MEDICAL COLLEGE, LUDHIANA 141008, PUNJAB.**

Proof of posting will not be accepted as proof of delivery or receipt. If the application form is not completely filled and/or application is received without necessary enclosures, the application will not be considered. An incomplete application is liable to be rejected.

If the application form with enclosures is submitted to the Office of the Registrar by hand, a receipt may be obtained for the same from the Office of the Registrar.

The applicant will be given a roll number and also the receipt for the application fee, following which all correspondence regarding admission must bear this roll number otherwise correspondence, may be ignored.

Once application form along with enclosures has been submitted, the applicant will not be permitted to make any alteration. It is to be clearly understood that submission of complete application for admission does not itself confer a right to be called for admission written test or to be called to Ludhiana for checking of original certificates or admission to the College and that the choice of applicants for selection and admission rests with the Selection Committee of the Institution. The

decision of the Selection Committee shall be final and no correspondence will be entertained regarding rejection or disqualification of the applicant.

Any attempt by the applicants or their friends or relatives to canvas for admission or to bring influence to bear upon the administrative and / or other staff members shall render the applicant disqualified.

## **MDS ADMISSIONS**

Provisional admissions to the MDS course of this college are made according to the rules and regulations of Baba Farid University of Health Sciences, Faridkot and of the Government and Dental Council of India, as may be applicable, and of this college. These are subject to alterations, amendments and modifications.

Applicants should submit two passport size photographs stapled to the application form with name written on the back of the photograph. The candidate should be recognizable by the photograph and any change in face structure due to change in hair style and beard style etc may be a reason for the invigilator to refuse the applicant's entry into the examination hall. Such case will be the sole responsibility of the candidate.

### **Declaration Form**

Declaration form will be signed by all applicants who have been selected for the course. This declaration form will be signed at the time of scrutiny of documents.

***All P.G students will abide by the Institutional Service Rules and Regulations.***

## Admission Written Test Center:

The admission Written test is due to be held on **10th January 2013 from 1.00 pm to 4.00 pm at Kochi, New Delhi and Ludhiana.**

### ADMIT CARD

Generally admit card will be issued to all the applicants, whose application form along with full application fee have been received by the office of the Registrar, to sit for the admission written test at the center as given in the Admit Card. **Receipt of Admit Card does not mean that the applicant has met all the eligibility criteria.**

It is the responsibility of the candidate to check the schedule of the AWT 2013 and discrepancies if any must be brought to the notice of the Registrar's office immediately.

Admit card will bear the photograph of applicant and will mention:

- \* Name and roll number of the applicant
- \* Time of the test
- \* Centre and other relevant information.

All candidates are required to bring Identity Proof (Govt. Approved) to the venue of the examination.

### POST GRADUATE ADMISSION TEST MDS DEGREE

#### 1. Admission Written Test : **200 Marks**

- a) The admission written test shall be conducted in all the subjects of BDS course. All questions will be multiple choice type. There will be 200 questions; each question shall carry one mark, total marks being 200. There is no negative marking.
- b) **Criteria to Pass the Admission Written Test :**  
In order to pass the admission written test, an applicant must obtain a minimum of 50% marks. Failure to do so will make the applicant in-eligible for admission.

## 2. Additional Marks for Admission: Maximum 50 Marks

3. Satisfactory completion of work in; Any hospital managed by a member of the CMC Ludhiana Society (Annexure A) OR CDC Ludhiana, not part of service obligation 5 marks for every completed 6 months up to a maximum of 20 marks	20 Marks (for 2 years)



### 3. Preparation of Merit List

Three merit lists will be prepared as per the categories a candidate has opted for (A, B or C). The merit list will be prepared on the basis of the following marks obtained by the applicant:

- i) Admission Written Test
- ii) Additional marks, if any

Provided the applicant is otherwise eligible and photocopies of certificates and testimonials etc of the applicant are found to be in order.

### 4. Tie-Breaking

Tie-Breaking of the applicants on total marks will be done on the basis of the following.

- a) Marks in AWT
- b) Percentage of total marks obtained in all BDS professional examinations combined together.
- c) Age of the candidate-in favor of the older candidate.

### Declaration of Final Result

Provisional merit list as per category will be published. The number of "selected" candidates will be equal to the number of seats in that category and the rest will be deemed to be in waiting list.

The merit list will be displayed once final orders are received from the Hon'ble Supreme Court of India. It will be displayed on the notice board of the Office of the Registrar, Christian Medical College, Ludhiana and the website-[www.cmcludhiana.in](http://www.cmcludhiana.in).

**No separate information regarding the result will be sent to the candidates.**

### Scrutiny of Original certificates and testimonials

Procedure for counseling for MDS admissions to be held on 19-03-2013 from 10:00 A.M. onwards

**Candidates will be called as per merit and category. It is necessary for all the applicants in the list to be present at the required date and time for consideration for the counselling.**

**If any applicant fails to appear as per schedule mentioned above and/or, if the original certificates and testimonials etc are not found to be in order and/or, if he/she is found ineligible due to any reason he/she will not be considered for admission and his/her seat will be cancelled from the provisional selected/waiting list as the case may be, and the seat will be offered to the next applicant on the merit list.**

- ❑ Migration certificate for applicants from any other university other than Baba Farid University of Health Sciences, Punjab.
- ❑ For Christian Applicants- Church Membership certificate, Baptism certificate, Sponsorship Letter from Sponsoring body/church, duly signed by authorised signatory(for candidates applying to category A  
Applicants will have to bear traveling and other expenses e.g. boarding and lodging etc, on their own, for this purpose.

The College fees has to be submitted in the form of Bank Demand Draft only in favor of '**Christian Medical College Ludhiana Society**' drawn on any scheduled/nationalized bank payable at Ludhiana. It is necessary that in order to get admission

an applicant must submit College Fees in full for the Academic Year 2013-14 along with all relevant certificates and testimonials in original to the Registrar, Christian Medical College, Ludhiana otherwise fees will not be accepted and the offer will be withdrawn and the seat will be offered to the next applicant on the merit list.

### **Vacant Seats**

In the event of any vacant seats arising as a result of withdrawal of a candidate after first counselling, a second counselling will be held on 15th May 2013. The procedure for the second counselling will be the same as that followed for the first counselling. In the event any further counselling is required, such will be intimated on our website. Vacancies will be displayed periodically on the notice board of the office of the Registrar and on the website [www.cmcludhiana.org](http://www.cmcludhiana.org). For such seats, all candidates on the merit list including those absent for the previous counseling will be eligible to attend.

### **Refund Rules**

1. Any time upto 30.05.2013, full refund except administrative fee and any expenses incurred by the institution towards the candidate in question.
2. On the last date of admission (31.05.2013), full fees, except the administrative fees and any expenses incurred by the institution towards the candidate, will be refunded, provided the seat is filled. In the event the seat in question remains vacant, the candidate will be required to pay the fees for the entire duration of the course.

If any candidate fails to complete the training program and/or fails to appear in the PG examination at the end of the stipulated period of the training for the course, he/she will have to pay college fees as tuition fee for the additional period as may be applicable.

Candidates, who, for any reason are unable to complete their PG study and desire to discontinue their study, will be liable to pay the fees of the remaining period of the course.

The Security deposit is refundable only on completion of the course and if claimed within one year of completion of the course.

The management reserves the right to revise the college fees from time to time and these will be effective from the date as may be decided.

### **Registration is with Baba Farid University of Health Sciences, Faridkot**

All admissions are provisional and subject to the approval and confirmation of Baba Farid University of Health sciences, and the Dental Council of India.

### **Medical Examination:**

- a) Following admission, the Staff & Students Health Services of Christian Medical College, Ludhiana will examine all the candidates. A candidate will not be allowed to continue his/her studies in the College if found medically unfit.

- b) Immunization against Hepatitis B – All admitted candidates have to get the 1st dose of the Hepatitis B vaccine at their own expenses within the first week of admission
