NOTE : -

- (i) The detailed notification is placed in the website **www.apgenco.gov.in**.
- (ii) **SECURITY GUARDS** The nature of duties are to man the vital, sensitive and vulnerable power plants and to fix proper responsibility in all security aspects of the power plants, the exit and entry access system for men and material at all gates of the power plants round the clock on shift basis, proper checking and recording the entries of incoming and outgoing materials, industrial relations related issues, handling law and order related problems and to man the gates round the clock situated in different locations at far of places etc. The Power Generating Stations are declared as hazardous and nature of duties as enumerated above. Therefore, Male candidates only need to apply.
- (iii) **FIREMAN :-** The nature of duties are to take precautions against the fire accidents as Thermal power generating stations are fire prone areas due to the usage of coal and oils. Firefighting activities consists of controlling the spreading of fire and to save the lives of employees, officers of APGENCO and to protect the machinery and materials of the plants during fire accidents. Hence, Male candidates only need to apply.
- (iv) **PHYSICALLY CHALLENGED** candidates need not apply
- (v) The vacancies notified are subject to variation based on the necessity and shall be filled as per the rules in vogue.
- v). The written examination will be held at **HYDERABAD, WARANGAL VIJAYAWADA and KURNOOL** only.
- vi). Physical Efficiency Test will be conducted only at Hyderabad.

EX-SERVICEMEN :- 2% reservation for Ex-Servicemen is provided as per the orders issued in G.O.Ms.No.65, Dtd 15.02.1997 as adopted. If a qualified and suitable candidate is not available from Ex-servicemen, the turn allotted to Ex-servicemen shall be deemed to be allotted to open competition (OC).

SPORTS QUOTA :-

- a). The performance of individual is having obtained Medals/participation in disciplines for deciding a meritorious sports person against two percent (2%) sports quota as mentioned in Annexure II appended to the notification shall be the criterion, keeping in view the participation in the recognized sports disciplines as per Annexure I of the notification or as may be revised by the Government from time to time.
- b). Participation at higher level shall be considered only when it is supported by winning Medals at the lower levels.
- c). The candidate appointed under sports quota must represent the department for at least 5 years from the time of appointment.
- d). The eligibility certificate issued by the Committee constituted in G.O.Ms.No.74 (Youth Advancement, Tourism and Culture, Sports Department Dtd 09.08.,2012 shall only be considered for selection of candidate under sports quota.

NOTE :-

- i). As per G.O.Ms.No.98, dtd.15-04-1986, 50% of the vacancies notified are reserved for Land Losers/displaced person or his/her dependent son, daughter or spouse, whose land was acquired for construction of Power Generating Stations of APGENCO. These vacancies shall be filled duly following Rule of Reservation. The vacancies if any left-over or un-filled out of 50% of vacancies earmarked for Land Losers/displaced persons by virtue of non availability of candidates with prescribed qualifications for the post of Security Guard/Fireman and as per the selection procedure prescribed in the above G.O. shall be converted as "General Vacancies" and shall be filled up with non-displaced persons/general candidates.
- ii). The candidates claiming employment against the vacancies earmarked for Land Losers has to submit "Land Lost Certificate", "Award" in the prescribed format; and also the "certificate of no earning member in the family" duly certified by the concerned RDO. All such applications along with supporting documents shall be forwarded to the concerned District Collector, Chairman of the Selection Committee constituted under G.O.Ms.No.98, dtd.15-04-1986.
- iii). The candidates applying for the post under the category of "Land Losers"; are required to submit the following documents. along with the certificates without fail in support of their claim, on or before the last date prescribed for submission of application by post:

- Note:- (i) The records/certificates received after the due date will not be accepted under any circumstances and no correspondence in the matter will be entertained.
- (ii) In case of failure to submit, the records mentioned above, claiming as Land losers within the stipulated time, they shall be treated as “General Candidates” if possessed the Educational Qualifications mentioned in Para 10 (a) of the notification otherwise candidature will summarily be rejected.

04). AGE : A person must have attained the age of 18 years and must not have completed the age of 30 years as on the date of notification given for direct recruitment.

However, upper age limit shall be relaxed up to 5 years for SC/ST/BC candidates and also for the candidates claiming as Land losers supported by the documents referred in Note (iii) of para 2 above irrespective of their caste.

Upto 3 years in addition to the length of service rendered in Armed force for the candidates who served in Armed forces

Up to 3 years in addition to the length of service rendered as a whole time CADET CORPS INSTRUCTOR in NCC provided the candidate should work rendered a minimum service of as a whole time CADET CORPS INSTRUCTOR in NCC.

NOTE :- The Recruitment will be processed as per this Notification and also in terms of Regulations in vogue. However, the APGENCO is having all rights to modify or cancel any of the conditions of this notification or to insert new conditions at any point of time.

05). HOME GUARDS :-

5% posts are reserved for Home Guards The experience is to be certified by the concerned unit officer as on the date of the notification he is to be on duty as Home Guard for a minimum duration of 365 days within a period of two years.

06). CASTE & COMMUNITY: -

Caste and Community certificate issued by the Competent Authority should be submitted at appropriate time. Backward Classes, Schedule Castes and Schedule Tribes belonging to other States are not entitled for reservation.

07). UNIT OF APPOINTMENT/PREFERENCE :-

The "SECURITY GUARDS AND FIREMAN" are the District Cadre Posts. Each of the Power Generating Station in the District will be the unit of appointment. The candidates applying for the post has to choose his preference to any one of the Generating Stations in the order of his choice [not more than 3] where more than one Generating Station is situated in a particular District.

08). DISTRICT/LOCAL (POWER GENERATING STATION) :-

- a). The selection list will be drawn in two parts. The first part will comprise 20% of the posts consisting of combined merit list of "Local" as well as "Non-Local" and the same will be drawn from the state wide merit list. The remaining second part will comprise the balance 80% of the posts consisting of "Locals" only which will be drawn from the District Wide merit list in which the Generating Station is situated and the posts will be filled up duly following the Rule of Reservation.
- b). Rule of Reservation not applicable for 5% of vacancies reserved for Home Guards.

09). DISQUALIFICATION :-

The whole recruitment and selection process is carried out with utmost secrecy and confidentiality so as to ensure that the principle of merit is scrupulously followed. A candidate shall be disqualified for appointment, if he himself or through relations or friends or any others has canvassed (or) endeavored to enlist for his candidature, extraneous support, whether from official or non-official sources for appointment to this service.

10). EDUCATIONAL QUALIFICATIONS :-

a). General Recruitment Candidates -

Must have passed Intermediate or equivalent examination recognized by the Government of Andhra Pradesh including mere appearance for first and Second year examination of Intermediate in-respect of SC/ST candidates.

b). Land Losers :- Must have possessed Intermediate or SSC + ITI 2 years duration course.

11). PHYSICAL REQUIREMENTS :-

The candidates should have physical measurement as detailed below :-

a). Height : Must not be less than 167.6 cm.

b). Chest : Must not be less than 86.3 cm round the chest on full inspiration with a minimum expansion of 5 cm.

NOTE :-

Provided that in the case of candidates belonging to ST's and aboriginal Tribes in the agency areas of Srikakulam, Vizianagaram, Visakhapatnam East Godavari, West Godavari, Mahboobnagar, Adilabad, Warangal and Khammam Districts where the reserved quota could not be fully utilized for want of sufficient candidates possessing the requisite physical standard the board may relax the physical standards as indicated below :-

a). HEIGHT : Must not be less than 164 cm

b). CHEST : Must not be less than 83 cm round the chest on full inspiration with a minimum expansion of 5 cm.

The Physical Measurements entered in the online application should be tallied with the Physical Fitness Certificate issued by the Assistant Surgeon/Civil Assistant Surgeon. (Physical Fitness Certificate-Annexure-III of the notification)

12). MEDICAL STANDARDS :-

a). **EYE SIGHT :-** Visual standards required for the above selection shall be as follows :

ii). Each eye must have a full field of vision.

iii). Colour blindness, squint or any morbid condition of the eye or lids of either eye shall be deemed to be a disqualification.

b). The candidate should possess sound health and be free from any bodily defect or infirmity which will render him unfit for Security & Firemen service.

-: 08 :-

- c). Candidates who have the following ailments or defects will not be considered for recruitment to any post specified in this rule.
- a). Physically handicapped
 - b). Knocking knees, pigeon chest, flat foot, varicose veins, Hammer toes, fractured limbs, decayed teeth, stammering, hard of hearing and abnormal psychological behavior.

13). **APPLICATION REGISTRATION FEE :-**

The OC Candidates	Should pay an amount of Rs.500/- (Rupees five hundred only) (non-refundable) (Rs.350/- towards examination fee and Rs.150/- towards application registration fee).
Candidates belonging to BC, SC & ST communities. Ex-Servicemen/ Meritorious sports persons, Land Loosers	Should pay an amount of Rs.150/- (Rupees one hundred and fifty only (non-refundable) towards application registration fee
Candidates belonging to other states	Should pay an amount of Rs.500/- (Rupees five hundred only) (non-refundable) (Rs. 350/- towards examination fee and Rs.150/- towards application registration fee)

The applicant should pay the prescribed "Registration Fee" in any one of the A.P. Online Centers or A.P. Online Portal and obtain the "receipt" having paid the "Registration Fee" with "Journal Number" [12-Digit] in the first instance from 26.04.2013. The applicant can register their application only with Journal Number. The last date for payment of "Registration Fee" is 13 Hours of 25-05-2013 and submission of filled-in application is 23.59 Hours of 25-05-2013.

14). **OPTION FOR SECURITY GUARD/FIREMAN :-**

Selection for the post of Security Guard **OR** Firemen shall be made as per the preference given by the candidate in his online application. The order of preference for the post opted by the applicant in online application shall be final. No request for change of preference shall be entertained.

15). **SELECTION PROCEDURE :-**

(A) **FOR GENERAL RECRUITMENT**

SELECTION CRITERIA FOR WRITTEN TEST :- Based on the marks secured in SSC examination a merit list shall be drawn and the candidates, community wise, will be called for written test in the ratio of 1 : 100, duly following Rule of Reservation. Candidates who secured equal marks on par with that of candidates selected against the 1: 100 ratio shall also be called for written examination.

(The candidate who have been issued Hall Ticket, as per the above criteria, should bring the original SSC Marks Memo along with Xerox copy certified by the Gazetted Officer to the examination hall. If SSC marks mentioned in the online application do not tally with the marks memo he shall not be allowed to write the written test.)

NOTE :- The minimum marks to qualify in the written examination is 40% for OCs, 35% for BCs and 30% for SC/STs

Mere securing minimum qualifying marks does not vest any right to a candidate for selection to the post of Security Guard/Firemen.

ii). **SECOND LEVEL**

Only those candidates who qualify in the written examination by being ranked high, community wise, as per rules in vogue, will be called for 1 : 10 ratio, for second level selection procedure as detailed below .

a). **PHYSICAL MEASUREMENT TEST**

The Physical measurements of the candidates who selected for second level selection process shall be taken. The candidates who possess the minimum physical standards as specified at Para 11 above, shall only be allowed for Physical Efficiency Test (PET).

b) **PHYSICAL EFFICIENCY TEST (PET) :-**

The candidates shall be allowed to participate in all the 5 events as detailed below, in PET even after disqualification in any of the 5 events. However, the candidate must have to clear any 3 out of the 5 events of PET.

The marks secured in PET as per gradation table will be added to the marks secured in the written test for preparation of final merit list.

B). FOR LAND LOOSERS

No written test for the candidates applying for the post under the category of “LAND LOOSERS”.

Land Losers in addition to competing for posts earmarked for Land oustees are also eligible to compete against the vacancies notified for general recruitment and their cases shall be processed in all respects i.e., eligibility and written test etc., as applicable to general candidates as detailed in the notification at para 15 (A) above..

In terms of G.O.Ms.No.98, Irrigation (PW) Department Dtd 15.08.1986, the District Collector forwards the seniority list of land losers to the concerned Chief Engineers. Based on the said seniority list, the 1 : 10 ratio selection list in respect of Land Losers shall be drawn, by being ranked high, community wise, as per rules in vogue for Physical measurements and Physical Efficiency Test (PET) as detailed at Para 15 (A) (ii) (a) (b) above.

The candidates who possess the minimum physical standards, as specified in para – 11 above, shall only be allowed for PET events as detailed at para 15 (A) (ii) (b).

The merit list in respect of land losers will be prepared based on the marks secured in PET only, as per the gradation table subject to qualifying 3 out of 5 events of PET as there is no written test.

The final selection will be strictly on relative merit of the candidates in each category, as obtained by them based on their score in Physical Efficiency Test.

C). Selection shall be made based on State wide merit, against 20% of posts meant for non-local/local candidates and allotment to Project/Power Generating Stations shall be made as per the preference given by the candidate in his online application against the actual vacancies.

Selection shall be made from District wide merit list against 80% of posts meant for local candidates and allotted to the Project/Power Generating Stations based on the "Project" preference given by the candidate in his online application against the vacancies are available, in case of one or more Project/Power Generating Stations situated in a District.

The said preferences are only indicative, for being considered to the extent possible but not binding. Therefore, the APGENCO has the power to assign a successful candidate to any notified post in the District and also Project/Power Generating Station in respect of non-local candidates, for which, he is considered to be qualified and eligible, subject to fulfilling the selection criteria. Mere giving of preference for any District and also Project/Power Generating Station for allotment against vacancy does not confer a right to selection for that District and also Project/Power Generating Station in particular or any District Project/Power Generating Station in general.

- D).** Candidates have to produce Original documents viz., (i) Date of Birth Certificate; (ii) Educational Qualification Certificates i.e., SSC + Intermediate for general candidates **or** Intermediate **or** SSC + ITI for 2 years duration course in-respect of Land losers; (iii) Community Certificate; (v) Study/ Residence Certificate; Physical Fitness Certificate, Records mentioned at Note (iii) of Para (2) above, in respect of land losers and other particulars for verification as and when required and called for.
- E).** If the particulars furnished in the "Online Application Form" do not tally with the original documents produced by the candidates, the candidature will summarily be rejected, without further assigning any reasons.
- F).** The persons already in Government Service/Autonomous Bodies/other Corporations etc., whether in permanent or temporary capacity or as work charged employees must take print-out of the application after properly filled and get it endorsed by his employer and keep it with him ready, so as to submit the same as and when called for.
- G).** The appointment of selected candidates will be subject to their being found medically fit in the appropriate medical classification.

16). The Reservation to Local Candidates :

Reservation to the local candidates is applicable as provided in the Rules/Regulations and as amended from time to time in force as on the date of notification. The candidates claiming Reservation as “Local Candidates” should obtain the required study certificates (from Class IV to X) or Residence Certificate in the prescribed proforma only, for those candidates who have not studied in any Educational Institutions, as the case may be. The relevant certificates may be got ready with authorized signature and kept with candidates, for verification as and when required.

17). Definition of Local Candidate:-

- (i) “Local Candidate” means a candidate for direct recruitment to any post in relation to that Local area where he has studied in Educational Institution(s) for not less than four consecutive academic years prior to and including the year in which he appeared for S.S.C. or its equivalent examination. If however, he has not studied in any Educational Institution during the above four years period, it is enough if he has resided in that area, which is, claimed as his Local area during the above said period.
- (ii) In case the candidate does not fall within the scope of the (i) above, it will be considered if he has studied for a period of not less than seven years prior to and inclusive of the year in which he has studied for the maximum period out of the said period of seven years AND where the period of his study in two or more local areas are equal, such local area where he has studied last (in such Local area) will be taken for determining the Local candidature. Similarly, if he has not studied during the above said period in any Educational Institution(s), the place of residence during the above period will be taken into consideration and Local candidature determined with reference to the maximum period of residence or in the case of equal period where he has resided last.
- (iii) If the claim for Local candidature is based on study, the candidate is required to produce a certificate from the Educational Institution(s) where he has studied during the said 4/7 years period. If, however, it is based on residence, a certificate of residence should be obtained from an officer of the Revenue Department not below the rank of a Tahsildar in independent charge of a Mandal.

- (iv) If, however, a candidate has resided in more than one Mandal during the relevant 4/7 years period but within the same District, separate certificates from the Tahsildhars exercising jurisdiction have to be obtained in respect of different areas.

- Note:** A. Single certificate, whether of study or of residence would suffice for enabling the candidate to apply as a “Local Candidate”.
- B. Resident certificate will not be accepted, if a candidate has studied in any Educational Institution up to S.S.C. or equivalent examination, such candidates have to produce study certificates invariably.
