- (a) No. of posts may vary. The above percentage of reservation is as per the GAD Notification No. F-13-14/2009/R.C./1-3 dated 16/03/2012, 29.11.2012 and the said percentage of reservation shall be subject to the final order to be passed in W.P. (C) 591 of 2012 Guru Ghasidas Sahitya Avam Sanskriti Academy Vs. State of Chhattisgarh and others, by the Hon'ble High Court of Chhattisgarh.
- (b) The posts reserved for Scheduled Caste, Scheduled Tribe and Other Backward Classes are reserved only for Scheduled Caste, Scheduled Tribe and Other Backward Classes who are bonafide residents of Chhattisgarh State. The applicants, who are bonafide residents of other states and recognized as Scheduled Caste, Scheduled Tribe and Other Backward Classes in their own states will be considered only against unreserved category.
- (c) The candidates of OBC must not come under creamy layer.
- (d) In case of Orthopaedically Handicapped, Certificate regarding disability shall have to be produced

as and when called for.

(Two) Conditions of Service:-

- (a) The condition of service shall be governed by Chhattisgarh Lower Judicial Service (Recruitment and Conditions of Service) Rules, 2006.
- (b) Appointment to the post of Civil Judge (Entry Level) shall be subject to Rule 11 of Chhattisgarh Lower Judicial Service (Recruitment and Conditions of Service) Rules, 2006.
- (c) The period of probation shall be determined as per Rule 11 of Chhattisgarh Lower Judicial Service (Recruitment and Conditions of Service) Rules, 2006.

(Four) Age Limit:-

The candidate must have completed the age of 21 years but he/she must not complete 35 years of age as on the 1st day of January 2015.

Relaxation in upper age limit:-

- The upper age limit shall be relaxable upto a maxi-(a) mum limit of 5 years only for the candidates belonging to Scheduled Caste, Scheduled Tribe and Other Backward Classes as notified in relation to the State of Chhattisgarh.
- (b) The upper age limit shall be relaxable upto a maximum limit of 10 years in case of women candidates belonging to each category namely Scheduled Caste, Scheduled Tribe, Other Backward Classes and Unreserved.
- (c) The upper age limit for Government servant whether permanent or temporary, shall be relaxable upto further 3 years in addition to the relaxations available as above.

Note:-Candidates should make sure that relevant certificate is issued by the competent authority of the state for relaxation in upper age limit as mentioned in above paragraph & they have to produce the same as & when called for.

Note:-

- Candidates shall have to pay Rs. 35/- as Service (a) charge (Portal fees) and Bank charges (if any) in addition to the aforesaid Examination fees.
- (b) Candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes Category of the Note:other State are not entitled to get relaxation in fees.
- (c) Fees, once paid shall not be refunded in any circumstances.

(Six) Mode of Payment:-

Examination fees & Service charges (Portal fees) can be paid by way of Debit / Credit Card of any bank / Net Banking of State Bank of India. See Instruction- Appendix-'C'.

(Seven) Travelling Expenses:-

Expenses of travelling & stay shall have to be borne by the candidates appearing in Online Preliminary Examination, Main Examination or Viva Voce.

(Eight) Scheme of Examination and Syllabus:-

The Examination shall be conducted by the CGPSC in three parts for the aforesaid post. In the first part Preliminary Examination shall be conducted to restrict the number of candidates to the reasonable limit for the Main Examination.

Scheme and syllabus for the Online Preliminary Examination & Main Examination has been published in the advertisement under Appendix 'A' and Appendix 'B'. Information regarding Date & Time of Main Examination will be published later

Scheme of Online Preliminary Examination:-

- Question paper for Online Preliminary Examina-(1)tion shall be of 100 marks and will consist of 100 objective type questions. Each question will have four options for answer, out of which one option will be the correct answer.
- (2)Candidates shall have to tick the correct option.
- (3) Online Preliminary Examination Paper (Objective Type) shall be evaluated as per entries made on online exam to be assessed on Computer.
 - The language of question paper of Online Preliminary Examination and Main written Examination will be English and Hindi.
 - The relatively more meritorious candidates from among those who appeared in the Online Preliminary Examination in the ratio of 1:10 having regard to the number of vacancies shall be declared qualified for appearing in the Main Examination. The candidates obtaining equal marks as obtained by the last qualified candidates shall also be declared as qualified, though, in consequence the number of candidates declared as qualified may exceed the parameter of 10 times the number of Notified Vacancies. The same procedure will be adopted for Viva-voce in the Main Examination while declaring the candidates qualified on the basis of merit possibly three times against the number of vacancies.
- (6)The final selection will be on merit on the basis of total marks obtained in the written (Main) Examination and Viva-voce. The decision of the CGPSC with regard to calling the candidates for Viva-voce will be final. The maximum 15 marks are fixed for Viva-voce.

- There shall be a screening test in the Online Preliminary Examination to shortlist candidates for the Main Examination. The mark sheet for Online Preliminary Examination will not be issued, nor the marks obtained in that Examination will be added while preparing merit list of the Main Examination.
- (b) The candidates remaining absent in the Viva-voce

shall be disqualified for the selection.

Note:-It is not necessary that the Examination centre opted by the candidates will be allotted to them. Looking to the capacity and administrative convenience, the CGPSC will allot the Examination centre even other than mentioned or may delete any examination centre given in the list. The candidates shall have to appear in Examination at the allotted centre.

(Ten) Admit-card:-

The Admit cards will be generated and uploaded by CGPSC website i.e. www.psc.cg.gov.in and the candidates are required to obtain the same by downloading and taking print-out of the same. Admit Cards will be available 15 days prior to the concerning date of Examination.

(Eleven) Disqualification of Candidature:-

Such candidates shall be held liable to be prosecuted & disqualified from the examination process who are found guilty by the CGPSC for the following:-

- (a) Who have obtained support in any way or made any attempt therefor in order to get candidature for the Examination or the Viva-voce.
- (b) Guilty of Impersonating; or
- (c) Impersonation made by themselves or by some one else; or
- (d) Have submitted fabricated documents or has tampered with any documents; or
- (e) At any stage of selection, has supplied incorrect information, or has suppressed material information; or
- (f) Resorting to any other irregular or improper means for obtaining admission to the Examination; or
- (g) Using or attempting to use unfair means in the Examination hall; or
- (h) Harassing, threatening or inflicting injuries to the staff deputed for conducting the Examination; or
- (i) Violation of any directions or other instructions mentioned in their admit card and the oral instruction issued by any staff or invigilator involved in conducting the Examination; or
- (j) Misbehaviour in any manner in the Examination hall or during the Viva-voce; or
- (k) The applicants found guilty for the above may be subjected to the following actions in addition to the criminal prosecution:-
 - (i) Their candidature can be cancelled by the CGPSC for the said selection and/ or
 - (ii) They shall be debarred either permanently or for a specific period :-
 - From the Examination or selection held by the CGPSC.

- From the employment of the state Government or / and under it.
- (iii) If they are already employed under the State Government, they shall be subjected to disciplinary action as per the said rules, provided that no penalty shall be imposed in consequence of the above mentioned proceeding under:-

(l) <u>Incomplete or false information :-</u>

The candidates are required to fill in the online application form with correct and complete information carefully as per the directions given in the advertisement. The application form for the Online Preliminary Examination shall be treated as the base for the Main Exam. If any incomplete or false information is given, then the candidates will be responsible for the same and on the basis of false and incomplete information, the application form shall be rejected at any stage of the selection without giving any prior notice. On furnishing any false certificates or Indicating wrong category regarding caste in the application form or in case of any other default, the CGPSC shall reject the candidature at any stage of the selection and shall take all necessary action.

- Please read carefully all the instructions mentioned in the advertisement relating to this Examination.
 Do not provide wrong or incomplete information.
- (2) The Candidates who have successfully submitted online applications shall only be eligible for appearing in the Online Preliminary Examination. All candidates short listed for main examination have to again apply for main examination.
- The information provided in form applied to appear in online preliminary exam shall be taken as the base for the Main Examination.
- (4) All the candidates who are already in Government Service or in any Government undertaking or in any type of other organization or appointed in Non-Government institution shall have to produce <u>No Objection Certificate</u> as and when called for.
- The decision of the CGPSC as to the eligibility or any other matter related to the candidates for ad-

- mission to the Online Preliminary Examination, Main Written Examination and/or Viva-voce shall be final.
- (6) Candidates shall have to produce, at the time of appearing for the Online Preliminary / Main Written Examination/Viva-voce, photo identity proof in original i.e. Card issued by the Election Commission of India or Bar Council of the State or PAN Card or Driving License or any recognized photo identity proof along with the Admit Card.
- (7) Result of all Examinations will be made available on the CGPSC website i.e. www.psc.cg.gov.in.
- (8) Mere success in the Examination shall not confer any right to appointment and no candidates shall be appointed to the post unless the Government is satisfied, after such inquiries as may be considered necessary that the candidates are suitable in all respects for appointment to the post.
- (9) At present, candidates are not required to send copies of any testimonials/ documents to the CGPSC. At the time of Viva-Voce.

- (10) While applying online for the post, the applicant must ensure that they fulfill the eligibility and other norms mentioned above and that the particulars furnished by them are correct in all respects. In case it is detected at any stage of recruitment that a candidates do not fulfill the eligibility norms and/ or that they have suppressed/ twisted or truncated any material facts, their candidature shall stand cancelled. If any of these shortcomings is detected even after appointment, their services shall be liable to be terminated.

Candidates are required to Click '01 CLICK HERE TO VIEW/PRINT ADVERTISEMENT' in order to go through the advertisement carefully only after that they will Click "02 CLICK HERE TO APPLY ONLINE CIVIL JUDGE (ENTRY LEVEL)", thereafter they will see Application form on the screen. It is essential for the applicants to fill in the form the required information correctly. The applicants will see a button "Browse" below the Application form, here they will required to attach their Photo & Signature as per the instructions mentioned in the advertisement.
