Instructions regarding appointment/waiting list of successful candidates in TTA Direct Exam – 2012 held on 14.07.2013.

- 1 The result & waiting list is provisional and final selection shall be subject to fulfillment of all eligibility conditions and verification of original documents w.r.t. educational qualification, DOB and Caste for the post of TTAs in BSNL.
- 2 Intimation in this regard is to be sent to the selected candidates by registered post with A/D / Speed Post. The candidates are directed to report to AGM (Admn.)/Nodal officer within 30 days from the date of issue of Call letter with all certificates and other documents in original.
- 3 Candidates selected under OBC quota have to ensure that non creamy layer certificates should be in the proforma prescribed by Central Govt. & issued within last 6 months preceding the date of certificate verification.
- 4 Appearance of a candidate's name in the waiting list does not confer any right on the candidate for claiming appointment in BSNL.
- 5 Waiting list shall remain valid for a period of one year from the date of declaration of result or the date of notifying the DR Examination for the next recruitment year, whichever is earlier.
